The Rabbit Hole

They peddle science fiction fantasy as news, build a worldview around their own lies, and then they have the gall to mock Christians!

Rabbit holes are man-made constructs which have an alluring power. They are typically built around some religious belief, pseudo-science, event, or even some combination of these, and they have ability to propel truth-seekers down paths of inquiry where nothing of substance is ever accomplished, acquired or learned even though something is always just out of reach.

For example, there certainly is truth in many so-called conspiracy theories, such as the fact that Oswald alone did not kill Kennedy or the fact that Israelis and certain government insiders were responsible for the events of a particular September 11th morning.

However these things are readily observable from both the circumstances and the behavior of the parties involved and those who were within the periphery of the events themselves, if one can gain access to the hard data required to make such an observation.

But in order to distract people from finding the important rudimentary truths behind the causes of such events, a thousand books, articles or items in the electronic media quickly appear trumpeting a thousand different theories. In that manner, if anyone does navigate the labyrinth successfully, the one account which may reflect the truth of the matter is drowned out by a thousand lies.

Because of the speed of information and the developments in self-publishing and media observation provided by the internet, the spread of such theories took decades where the Kennedy assassination is

concerned, but only weeks in the case of the 911 incidents. At one time a few Jewish-owned-and-operated media outlets controlled the dissemination of virtually all published information, and it took years for self-publishers or small companies to write and print books or distribute recordings offering alternative views. Now the internet allows anyone who can post on a website or forum to express opinions, regardless of how they are formed. But if the powers-that-be can create a few popular “alternative media” websites, they can nevertheless continue to be the largest influence forming those opinions.



Once upon a time, the ancient priesthoods of Mesopotamia were used as an adjunct of kings and tyrants in order to maintain power over the people. While the government and military power were in the hands of the king, the priesthood kept its reins on the hearts and minds of the people, thereby keeping them in obedience to the king. The magic arts and specialized astronomical or medical knowledge gained through centuries of systematically recorded observation helped give the priesthood its power, in addition to their traditional role as keepers of the cultural and historical heritage of the people which were encapsulated in their myths and legends.

Today there are many websites and media outlets which are fulfilling both of these roles, serving as “alternative media” and also as the priesthood of a new government-preferred religion. Furthermore, as the ancient priesthoods of Mesopotamia undertook the task of giving the king the appearance of having much more power than he actually had, this modern priesthood is doing that same thing by promoting science fiction as actual science, and attributing to the imperial American government unusual powers far beyond those which it actually has. While doing this, the new priesthood also has the uncanny ability of trapping truth-seekers in an endless series of rabbit holes.

A perfect example is a recent article in *Wired* magazine, entitled [White House Denies CIA Teleported Obama to Mars](#). *Wired* promotes itself as a techno-news outlet for Science and Business, among other things. And while the magazine has an entertainment section, this article was instead published in the magazine's security section, an area usually concerned with military and politics, wars and rumors of wars.

Now if the White House denies something in reference to a sitting president, unless some observable circumstance indicates that the claim may actually be true, it should generally be considered non-news. The Nixon tapes and the stain on a certain blue dress come to mind. However while this article in *Wired*, written by one Spencer Ackerman, is accompanied with a snippet from an old cartoon entitled [Marvin the Martian](#) and is obviously included to poke fun at the idea, it nevertheless ends with claims that Obama did indeed “teleport” to Mars.

Ackerman develops his themes by saying that “... Obama’s past lies not in east Africa, but in outer space. As a young man in the early 1980s, Obama was part of a secret CIA project to explore Mars. The future president teleported there, along with the future head of Darpa. That’s the assertion, at least, of a pair of self-proclaimed time-traveling, universe-exploring government agents. Andrew D. Basiago and William Stillings insist that they once served as 'chrononauts' at Darpa’s behest, traversing the boundaries of time and space. They swear: A youthful Barack Obama was one of them.”

Ackerman talks about how “this all sounds fantastical, absurd, and more than a little nuts”, and then goes on to write “According to Basiago and Stillings, Obama isn’t just lying about his identity. He’s lying about his military service record, too. While his political opponents in 2008 attacked him for never serving, in truth, he was concealing his participation in a hidden CIA intergalactic program hosted at a [California community college](#) in 1980.” (In the article is an embedded link to an institution called College of the Siskiyous.)

Here Ackerman does something which seems innocent at first, but may indeed have a nefarious effect. Ackerman indirectly attributes to Basiago and Stillings the idea that Obama is lying about his identity, which is true. He also attributes to them the idea that Obama is lying about his military service, which would also be true. But Basiago and Stillings did not discover those lies. The mainstream media outlets ignore or even dismiss those lies to this day, but if they were properly investigated and broadcast by a responsible media [tongue-in-cheek] they may have prevented the re-election of a criminal. But perhaps that is all by design as well.



Doing this, Ackerman associates legitimate charges against Obama with the “absurd, more than a little nuts” claims about time travel and teleportation made by Basiago and Stillings. The logically-minded reader, one who won't fall into the sci-fi rabbit hole, may stop reading here, however near-equal doubt is implanted in relation to the legitimate charges.

Then Ackerman proceeds by portraying the claims of Basiago and Stillings as if they were of merit, seemingly as if he himself has accepted them. He begins by writing “Officially, the White House says Obama never went to Mars. 'Only if you count watching [Marvin the Martian](#),' Tommy Vietor, the spokesman for the National Security Council, tells Danger Room [the name of Ackerman's column]. But that's exactly what a secret chrononaut wants you to believe.”

Presenting the claims of these men, Ackerman provides details and even rough dates, and makes cynical parenthetical remarks about socialized medicine and birth certificates, a seeming attempt to discredit yet another legitimate charge that has been leveled against Obama. Turning back to the Mars story, Ackerman even goes so far as to include a comment alleged to have been made to the young Obama by one Major Ed Dames. This Dames character was once a regular on the old Art Bell late-night radio program, Coast-to-Coast. That program was, and still is, a sort of New-Age combination of science and science fiction mixed with government, religion and politics. Before the internet grew to become so popular, it was one of the primary vehicles for the dissemination of this new sci-fi techno-religion.

Ackerman reveals himself as a mouthpiece for this religion where he concludes, in part: “You can scoff at the idea of Obama on Mars. But it explains a lot.... Ignore Basiago and Stillings at your own peril. If Obama's reelected, the U.S. is finally colonizing Mars.” With this conclusion, Ackerman is willingly sending at least a portion of his readers into one of the rabbit holes being drilled out by Basiago and Stillings.

Major Ed Dames, a supposed “remote viewing” (or RV to the faithful) authority, is one early priest in a growing line of supposedly former government employees professing various dogmas for the new religion. These priests often come from the military, but sometimes come from the Civil Service, men who served as security contractors, scientists or in similar capacities. Another member of the new priesthood is Henry Deacon, who several years after coming forward with amazing “revelations”, now reveals what is evidently his real name, Arthur Neumann.

Neumann has made claims that he has “memories of coming from another planet”, and that he “never had any problems intuitively accessing complex scientific information...” He says “I've often found myself understanding complex systems with no detailed briefing or training”. (See the website [Project Camelot](#) for this and more.)



Neumann was interviewed by one Rafael Palacios ([available on Youtube](#)) and claimed that he was involved in projects for the U.S. government which included “pulse electronic weapons”, microwave and neutron bombs, particle beam weapons, sound weapons and more. Neumann claimed in reference to these weapons “that many different technologies that are being used constantly even in the cities and as well as just for specific targets”. Upon being asked about “black helicopters”, a long-time bogeyman of conspiracy circles, Neumann said “some of them look like helicopters but they're not helicopters” but admitted not knowing “the details”. He claimed that they were used for surveillance and abduction “but not by aliens”. He goes on to purport that in the electronic age everything is watched, recorded, and nothing is secret, that there is no privacy anywhere. Just like the ancient Mesopotamian priesthoods, Neumann's message

seems to be designed to instill fear and awe of the king (or the state) in the hearts of the people.

Yet at the same time Neumann, describing good and bad “forces” within government, is telling people that they should have no fear, that the “black operations ... they are very weak and powerless”. He asserts that people must “look forward and be happy”, and talking about change to “celebrate the change, and realize that there is pain involved in this change”. Then he claims “we're living in a galaxy full of worlds where people, people like you and me basically that have gone through the same experience as the people here on earth, the same experience long ago, and is continuing ... and they already know what's going to happen but they're watching this change happen now and they're supporting it and helping gently and quietly behind the scenes, and if you are aware of that, then you don't have anything to be afraid of”.

It is ambiguous as to what Neumann sees as good, and what he sees as bad. However smiling he talks confidently about changes being forced upon mankind, about aliens from other planets assisting this change, as if they are of a morality much higher than mankind. Neumann certainly seems to be an apostle for the new religion of sci-fi and all-powerful imperial government. For Neumann, it is not that people should not fear because they should resist those who want to control them, but that they should not fear because they should simply surrender to those who want to control them. The God of mankind is not part of the equation, because the aliens helping our governments are evidently the new gods.

However Neumann calls them people, and not aliens or gods, although it is obvious that he attributes to them the power over the course of life here on earth. He then claims to have “met so many of these people”, however the topic abruptly changed to the unrelated but infamous Report from Iron Mountain, and then to the swine flu, “secret government”, and describes how even heads of State do not have the proper security clearance to “know what is happening off-world”, as if the real decisions concerning the fate of mere earthlings were indeed being made by aliens. Neumann predicted that soon governments and agencies on earth would “lose all of their power”, inferring that they would lose it to aliens, which are evidently the higher moral authority.



When asked about the role of “humankind in all of this story”, Neumann exclaimed with a confident smile that “It's very simple. If you have different belief systems, different religions, you need to open up, open up your heart and realize that we're all here together and respect each others' beliefs as best as possible ... and understand that we share a common ancestry not just here but our whole galaxy ...” and with that we heard enough.

This is the sci-fi religion of UFO's, alien encounters, other worlds, and its apostles can never prove their assertions but many of their

listeners even unconsciously take it for granted that it is true. The whole world should therefore resemble the Star Wars' bar scene, itself an image created by a Jew, where all the (imagined) races in the universe fraternize and mingle in relative harmony. Is it not odd, that this new sci-fi religion is patterned after the same political, economic and social goals espoused by World Jewry, that one-world system known in the Christian Bible as Mystery Babylon?

We have heard dozens of men and women like Neumann, and although this interview we critique here is five years old, we heard them long beforetime. In the 1990's such professions were frequently heard from so-called insiders describing government collusion with aliens, or from people who claimed to have “close encounters” with aliens, or from purported alien abductees who were released in order to spread this same gospel. It is the same as the Jewish Gospel of the Melting Pot, which was unleashed on America by

Broadway and Hollywood Jews in the early 20th century. Is it any wonder that the first people the 20th century media proclaimed to be alien abductees were the mixed-race couple, Betty and Barney Hill?

Revisiting the character who claimed that Obama teleported to Mars, Andrew Basiago, we found a webpage for podcasts he does on the [Biblioteca Pleyades](#) website. This website is among the most-visited in the world, getting tens of thousands of visits per day. The laundry-list of topics covered by the podcast reflects the doctrines of this neo-Mesopotamian priesthood. Life on Mars, Chrononauts, Chronovision, Astral Projection, Mind Control, Parapsychology and Out-of-Body experiences, Quantum Leap technology, Remote Viewing, UFOs, Time Travel, Teleportation, all of these things are strewn about a longer list of more mundane topics, including many of the usual conspiracy theories surrounding recent U.S. presidents and other political and business figures.

The website claims of its purpose that “These explorations bring more light to mystical and 'religious' information than we have received through a dogmatic system of education, often unclear, distorted and manipulated. Here, we have the opportunity to report on new chapters beyond current knowledge, such as Exopolitics, Neo-Archeology, Parascience, "Alternative" Medicine, Life in Our Universe and much more...” In other words, the website is loaded with rabbit holes. But these are the scriptures of the new one-world religion, and represent the new mysticism designed to help keep the Jewish tyranny in power.




Basiago and Neumann, Wired and [Biblioteca Pleyades](#) are certainly not alone. Neumann mentioned the [Project Camelot](#) website in the interview we critiqued here. That website is another outlet for the same priesthood. One recent article, entitled [A'shayana Deane - Ascension Mechanics](#) claims in part: “Her previous work details the history behind the genetic engineering of the human race and the numerous ET races that have been interacting with and shaping our destiny here on Earth as well as throughout the many multi-verses.” Of course, empirical evidence in support of such claims could never be produced, and the woman should be treated as a novelist. It is much more profitable for her, and much more useful to the powers-that-be, to peddle such fantasies as great hidden truths.

There are hundreds of such websites out there, mixing such science fiction as truth along with the more mundane conspiracy theories, things which actually do merit investigation. Some people are alienated by the combination, and others looking for something in particular are pulled down one of the rabbit holes. The powers-that-be win either way, because people either do not believe anything, or they end up believing everything! Hollywood colludes with this scheme, promoting the same sci-fi doctrines not only as the new religion, but even as history! Such examples are the television series [Ancient Aliens](#) and [UFO Hunters](#) which are running on the so-called History Channel, none of which could even remotely qualify as history.

The Jews and their Shiksas have indeed leveraged the media and the internet in an attempt to create a new world religion and an alternate perception of reality, which is not reality at all. The only true answer is Christ. Christ is the Way, and all other paths are rabbit holes.



A ten part series

The Prophecy of Amos

Part 8

William R Finck

Most of the historical portion of our presentation of Amos is past. Now we shall focus on the pattern of sin and punishment suffered by the children of Israel.

Amos 4:1 Hear this word, ye kine of Bashan, that are in the mountain of Samaria, which oppress the poor, which crush the needy, which say to their masters, Bring, and let us drink.

Bashan means *fruitful*. The land of king Og of Bashan fell to the lot of Manasseh when the land was taken from the Canaanites and divided by Israel (Joshua 17). The children of Israel are likened to *kine*. If we had to venture as to why, it is evident that they had worshipped the golden calves of Jeroboam I all throughout the period of the divided kingdom. Adam was formed in the image of Yahweh his God, and these Israelite children of Adam would rather worship calves. They were therefore likened to calves. Later, Ahab, Ahaziah, Jehoram, Jehu, Jehoahaz, Jehoash, Jeroboam II, Azariah, Menahem, Pekah, all kings of Israel, and probably some others besides these, were all criticized for doing “evil in the site of Yahweh” and for not departing from the ways of “Jeroboam the son of Nebat, who made Israel to sin”.

Yahweh had made much the same illustration through the prophet Hosea, on several occasions:

Hosea 4:16-17 “16 For Israel slideth back as a backsliding heifer: now the LORD will feed them as a lamb in a large place. 17 Ephraim is joined to idols: let him alone.”

Hosea 10:11: “And Ephraim is as an heifer that is taught, and loveth to tread out the corn; but I passed over upon her fair neck: I will make Ephraim to ride; Judah shall plow, and Jacob shall break his clods.”

Presenting the Book of Hosea here some time ago, this passage was interpreted as to mean that “although Ephraim deserves death for his sin, Jacob shall prevail against him, meaning that the promises which Yahweh made to Jacob shall prevail over anything which Ephraim does. The seed of Israel is preserved not for themselves, but for Yahweh, on account of His promises to the fathers.”

2 The Lord GOD hath sworn by his holiness, that, lo, the days shall come upon you, that he will take you away with hooks, and your posterity with fishhooks.

The Septuagint has “2 The Lord swears by his holiness, that, behold, the days come upon you, when they shall take you with weapons, and fiery destroyers shall cast those with you into boiling caldrons.”

As we witnessed when discussing the “captivity of Solomon” or the “prisoners of Solomon” which are

found in the Septuagint version of Amos 1:6 and 1:9, in the prayer that Solomon offers to Yahweh upon the dedication of the temple which is recorded in both 1 Kings chapter 8 and 2 Chronicles chapter 6, Solomon foresaw the day when the children of Israel would sin before Yahweh, and for that reason they would be carried off by those whom they opposed in battle. However the warnings concerning these things are even much earlier than this. The first allusion to the captivity of Israel seems to be made even before the Israelites complete the conquest of Canaan. This is found in the attempted curses of Balaam upon Joshua's Israelites, in that part which is recorded in Numbers 24:17-22: "17 I shall see him, but not now: I shall behold him, but not nigh: there shall come a Star out of Jacob, and a Sceptre shall rise out of Israel, and shall smite the corners of Moab, and destroy all the children of Sheth. 18 And Edom shall be a possession, Seir also shall be a possession for his enemies; and Israel shall do valiantly. 19 Out of Jacob shall come he that shall have dominion, and shall destroy him that remaineth of the city. 20 And when he looked on Amalek, he took up his parable, and said, Amalek was the first of the nations; but his latter end shall be that he perish for ever. 21 And he looked on the Kenites, and took up his parable, and said, Strong is thy dwellingplace, and thou puttest thy nest in a rock. 22 Nevertheless the Kenite shall be wasted, until Asshur shall carry thee away captive."

In Deuteronomy chapter 28 there are the blessings of obedience and the consequences of disobedience which are laid before the children of Israel by Yahweh. We read in Deuteronomy 28:25 that one of the consequences of disobedience is that "The LORD shall cause thee to be smitten before thine enemies: thou shalt go out one way against them, and flee seven ways before them: and shalt be removed into all the kingdoms of the earth." This is what Amos warns of here in his oracle against the children of Israel. It is the same thing which his contemporaries, Hosea and Isaiah, were also warning the nation of: that they were about to be carried into captivity for their sins.

In Deuteronomy chapter 30 we see a promise of recovery from that captivity, and we can see that the time for that recovery is near when the descendants of the children of Israel perceive what has become of them, and consider it, and repent of their sin: "1 And it shall come to pass, when all these things are come upon thee, the blessing and the curse, which I have set

before thee, and thou shalt call them to mind among all the nations, whither the LORD thy God hath driven thee, 2 And shalt return unto the LORD thy God, and shalt obey his voice according to all that I command thee this day, thou and thy children, with all thine heart, and with all thy soul; 3 That then the LORD thy God will turn thy captivity, and have compassion upon thee, and will return and gather thee from all the nations, whither the LORD thy God hath scattered thee. 4 If any of thine be driven out unto the outmost parts of heaven, from thence will the LORD thy God gather thee, and from thence will he fetch thee".

This scattering and gathering of the children of Israel described in Deuteronomy is the same one recorded by the apostle John, in his gospel at John 11:52, where it says of Christ that He would die "not for that nation only, but that also he should gather together in one the children of God that were scattered abroad." Of course, John's record was only referring to true Israel, and not to any Jews.

3 And ye shall go out at the breaches, every *cow at that which is before her*; and ye shall cast them into the palace, saith the LORD.

Notice the reference to cows is in italics, which means it was added by the translators of the King James Version. From the NAS, Amos 4:3 reads thus: "You will go out through breaches in the walls, Each one straight before her, And you will be cast to Harmon," declares the LORD."

From Brenton's Septuagint, Amos 4:3: "And ye shall be brought forth naked in the presence of each other; and ye shall be cast forth on the mountain Romman, saith the Lord." The Greek says Ρεμμων, a spelling which also stands for Rimmon in 2 Kings 5:18 where the "house of Rimmon" (in the King James Version) is a place of idolatry. Elsewhere in the Greek where Rimmon is mentioned the spelling is Ρεμμων. *Harmon*, Strong's Hebrew Dictionary # 2038, is from a Hebrew word which means a *castle* or a *high fortress*, and that is the word which the King James Version translated *palace*. The Septuagint version seems to be derived from an errant transliteration of the word.

I have not yet seen a translation of this passage which may be easily understood. It seems to reinforce, in one way or another, the idea that captivity is imminent for the children of Israel. This punishment of captivity is against those who oppressed the poor of their own

people. The next part of Amos' prophecy chastises the idolaters:

4 Come to Bethel, and transgress; at Gilgal multiply transgression; and bring your sacrifices every morning, and your tithes after three years:

The Septuagint has "and your tithes every third day." Bethel was the seat of idolatry of one of the two golden calves set up by Jeroboam I, the other being Dan. Gilgal was a center for the prophets, and often criticized by Hosea. From Hosea 9:15: "All their wickedness is in Gilgal: for there I hated them: for the wickedness of their doings I will drive them out of mine house, I will love them no more: all their princes are revolvers."

5 And offer a sacrifice of thanksgiving with leaven, and proclaim and publish the free offerings: for this liketh you, O ye children of Israel, saith the Lord GOD.

Leviticus 2: "11 No meat offering, which ye shall bring unto the LORD, shall be made with leaven: for ye shall burn no leaven, nor any honey, in any offering of the LORD made by fire." The word meat in the original English generally referred to food rather than merely flesh. The first ten verses of Leviticus 2 describe meat offerings in the form of cakes of flour. Leaven was forbidden in such offerings.

Again the Septuagint reading is quite different: "And they read the law without [meaning *publicly*], and called for public professions: proclaim aloud that the children of Israel have loved these things, saith the Lord."

The Dead Sea Scrolls version of Amos is heavily fragmented here. In the Masoretic Text, it seems the children of Israel publicly proclaimed the acts of their own idolatry, without shame. The Septuagint version seems to be saying that the law would be read publicly that the sin of the children of Israel would be openly confessed.

6 And I also have given you cleanness of teeth in all your cities, and want of bread in all your places: yet have ye not returned unto me, saith the LORD.

Cleanness of teeth is famine. Even in famine Israel does not call on Yahweh their God. Cleanness of teeth and want of bread refer to the same thing. The language of the Bible often repeats itself in a different fashion in order to stress a point, even in the New

Testament. That repetition is called *parallelism*.

7 And also I have withholden the rain from you, when there were yet three months to the harvest: and I caused it to rain upon one city, and caused it not to rain upon another city: one piece was rained upon, and the piece whereupon it rained not withered. 8 So two or three cities wandered unto one city, to drink water; but they were not satisfied: yet have ye not returned unto me, saith the LORD. 9 I have smitten you with blasting and mildew: when your gardens and your vineyards and your fig trees and your olive trees increased, the palmerworm devoured them: yet have ye not returned unto me, saith the LORD. 10 I have sent among you the pestilence after the manner of Egypt: your young men have I slain with the sword, and have taken away your horses; and I have made the stink of your camps to come up unto your nostrils: yet have ye not returned unto me, saith the LORD. 11 I have overthrown some of you, as God overthrew Sodom and Gomorrah, and ye were as a firebrand plucked out of the burning: yet have ye not returned unto me, saith the LORD.

If we believe, as we should, that Yahweh created the heavens and the earth and all that is in them (except for that which man has corrupted), then we must believe that Yahweh has efficacy within His creation, and that famine and plenty, drought and rain, are indeed within His provenance.



Britain's United Kingdom Independence Party [UKIP] suspends councillor, D Sylvester, who blamed floods on recent gay marriage legislation. PM David Cameron derided UKIP as a group of "fruitcakes, loonies and closet racists".

Leviticus 26: “3 If ye walk in my statutes, and keep my commandments, and do them; 4 Then I will give you rain in due season, and the land shall yield her increase, and the trees of the field shall yield their fruit. 5 And your threshing shall reach unto the vintage, and the vintage shall reach unto the sowing time: and ye shall eat your bread to the full, and dwell in your land safely.”

The historical books of the Bible are indeed historical, as we have seen many corroborating witnesses from archaeology here in the first several segments of this presentation. However they are by no means complete. In many cases there are only brief descriptions of the reigns of kings who sat on the throne over Israel or Judah for years, and little about what transpired during those years is mentioned. There was a famine in the days of King David, mentioned in 2 Samuel 21, and a pestilence in 2 Samuel 24. There was a severe famine in the days of Elijah, mentioned in 1 Kings 18. Not long after, in the time of Elisha, there was a famine in Samaria as it was besieged by the Syrians which was so bad that women were eating their own children, described in 2 Kings 6. Yahweh delivered the city, and used four lepers – the most despised of men – to make that delivery evident. Another drought and a resulting famine occurred a short time later, and is only given a brief mention in 2 Kings chapter 8.

The children of Israel were not spared from destruction in these instances for their own sakes. The famine of Samaria described in 1 Kings 6 did not end because the people repented. It ended because Yahweh wanted His people to have this example: the people were spared for the sake of God's word. Further on in 2 Kings chapter 8 we are told explicitly as to why our sinful ancestors were spared, in verses 16 through 19: “16 And in the fifth year of Joram the son of Ahab king of Israel, Jehoshaphat being then king of Judah, Jehoram the son of Jehoshaphat king of Judah began to reign. 17 Thirty and two years old was he when he began to reign; and he reigned eight years in Jerusalem. 18 And he walked in the way of the kings of Israel, as did the house of Ahab: for the daughter of Ahab was his wife: and he did evil in the sight of the LORD. 19 Yet the LORD would not destroy Judah for David his servant's sake, as he promised him to give him alway a light, and to his children.”

For the sake of the promises made to the fathers do the children of Israel have deliverance, and never for their

own merit. So it is today also, and we see as much in the announcement of Zacharias the father of John the Baptist, which tells us the purpose of the ministry of his son and of the coming Christ, which is recorded in Luke 1:68-75: “68 Blessed is Yahweh the God of Israel, that He has visited and brought about redemption for His people, 69 and has raised a horn of salvation for us in the house of David His servant, 70 just as He spoke through the mouths of His holy prophets from of old: 71 preservation from our enemies and from the hand of all those who hate us! 72 To bring about mercy with our fathers and to call into remembrance His holy covenant, 73 the oath which He swore to Abraham our father, which is given to us: 74 being delivered fearlessly from the hands of our enemies to serve Him 75 in piety and in righteousness before Him for all of our days.”

In modern times we have floods and we have drought, we have pestilence and we have disease, and no one thus affected ever even considers what manner of sin they have committed, or what manner of sin they have allowed to exist in their communities, that they should suffer such things. These calamities are clearly punishments from Yahweh our God. We have only been deceived into thinking that natural disasters originate from other sources. Today we are even further deceived, by those who claim that such things are caused by man and that they can be controlled by man. In truth, man has no efficacy on nature outside of the provenance of God. When man tries to create his own world, he fails and his actions will only help to contribute to the punishment he shall receive for mocking God. Good stewardship is man who functions within God's law, and not in spite of it.

This understanding begs another question: should we help disaster victims, since disasters befall men when they dwell unrepentant in sin? As Christians we should indeed help our brethren who are fallen, no matter the reason for their fall. However we are also obligated to explain to them why it is that bad things happen to people, and even to apparently decent people. Christ informs us in Luke chapter 13 that tyrannical government as well as unexpected calamity are judgments from God: “1 There were present at that season some that told him of the Galilaeans, whose blood Pilate had mingled with their sacrifices. 2 And Jesus answering said unto them, Suppose ye that these Galilaeans were sinners above all the Galilaeans, because they suffered such things? 3 I tell you, Nay:

but, except ye repent, ye shall all likewise perish. 4 Or those eighteen, upon whom the tower in Siloam fell, and slew them, think ye that they were sinners above all men that dwelt in Jerusalem? 5 I tell you, Nay: but, except ye repent, ye shall all likewise perish.”

We often hear it argued, that if there was a beneficent and just God, that bad things would not happen to “good” people. But in whose eyes are people “good”? Leviticus chapter 5 tells us “And if a soul sin, and hear the voice of swearing, and is a witness, whether he hath seen or known of it; if he do not utter it, then he shall bear his iniquity.” It is not enough for us as individuals to simply be “good”. Rather, it is a matter of God's law, that if we do not stand against the evil which we witness, then we become responsible for it. Likewise, Paul tells us in Romans chapter 1 “28 And just as they do not think it fit to have Yahweh in their knowledge, Yahweh handed them over to a reprobate mind, to do things not fitting; 29 being filled with all injustice, fornication, greediness, wickedness; full of envy, murder, strife, treachery, malignity, slanderers, 30 loud talkers, haters of Yahweh, insolent, arrogant, pretentious, contrivers of evil, disobedient to parents, 31 void of understanding, covenant breakers, heartless, merciless; 32 such as these who knowing the judgments of Yahweh, that they practicing such things are worthy of death, not only they who cause them, but also they approving of those committing them.”

These traits that Paul lists here are a perfect description of our society today. The rampant sexual deviancy among our young people, the race-mixing, the rebellion against traditional morals, the rebellion against parents, are all a punishment from God because our people did not seek knowledge of Him and His will. We can blame the enemies of God for all of our woes, but they are not the cause of the problem. Rather, they are the result of the problem! Evil

prevails, because we refuse to open the Word of our God and read to understand what is Good. The seeds of today's problems were sown a hundred years ago, when we as a people accepted the economic rule of the Jew and slaughtered our own brethren at his beck and call in the wars which he created. We cannot justly expect our conditions to improve, so long as our people worship the enemies of our God. With the current state of what was once Christendom, it is a wonder that we do not yet suffer drought and famine.

Now today we hear a lot of talk of resistance against the present tyranny. We hear a lot of talk about guns and rights. But tyrants really don't care about rights, and all of the guns we can hold will do us no good unless we first turn to our God, and seek His will, cleansing ourselves of all that He rejects. From the thirty-third Psalm: “12 Blessed is the nation whose God is the LORD; and the people whom he hath chosen for his own inheritance. 13 The LORD looketh from heaven; he beholdeth all the sons of men. 14 From the place of his habitation he looketh upon all the inhabitants of the earth. 15 He fashioneth their hearts alike; he considereth all their works. 16 There is no king saved by the multitude of an host: a mighty man is not delivered by much strength. 17 An horse is a vain thing for safety: neither shall he deliver any by his great strength. 18 Behold, the eye of the LORD is upon them that fear him, upon them that hope in his mercy; 19 To deliver their soul from death, and to keep them alive in famine. 20 Our soul waiteth for the LORD: he is our help and our shield. 21 For our heart shall rejoice in him, because we have trusted in his holy name. 22 Let thy mercy, O LORD, be upon us, according as we hope in thee.” For us, there is no salvation without our God.

12 Therefore thus will I do unto thee, O Israel: and because I will do this unto thee, prepare to meet thy God, O Israel. 13 For, lo, he that formeth the mountains, and createth the wind, and declareth unto man what is his thought, that maketh the morning darkness, and treadeth upon the high places of the earth, The LORD, The God of hosts, is his name.

Israel would meet their God by experiencing His judgment, which he pronounces here through the prophet. These judgments were also being pronounced by Isaiah and Hosea at this same time. That God was true, the Israelites indeed learned when their cities were destroyed and when they were taken into

Assyrian captivity as the prophets announced, and as we see here in Amos. Today we are in a similar situation. It can be established that the word of God forewarned us about the very tyranny we now suffer, that our “kingdom would be handed over to the beast” in Revelation 17:17. Only now we do not await entry into captivity, as the Israelites of Amos' time were warned. Rather, we await deliverance from captivity, the same captivity which the people of Amos' time were taken into.

The Septuagint version of Amos 4:12-13 is again quite different: “12 Therefore thus will I do to thee, O Israel: nay because I will do thus to thee, prepare to call on thy God [rather than “meet thy God”], O Israel. 13 For, behold, I am he that strengthens the thunder, and creates the wind, and proclaims to men his Christ [the anointed], forming the morning and the darkness, and mounting on the high places of the earth, The Lord God Almighty is his name.”

Amos 5:1 Hear ye this word which I take up against you, even a lamentation, O house of Israel. 2 The virgin of Israel is fallen; she shall no more rise: she is forsaken upon her land; there is none to raise her up.

The virgin of Israel is a virgin no more, but she is now the great whore of the Revelation, which has joined herself to the beast.

3 For thus saith the Lord GOD; The city that went out by a thousand shall leave an hundred, and that which went forth by an hundred shall leave ten, to the house of Israel.

Ninety percent of the people would die or go into the Assyrian captivity. That some were indeed left behind is revealed in the later Biblical records, such as those of the reign of Josiah. From 2 Chronicles 34: “1 Josiah was eight years old when he began to reign, and he reigned in Jerusalem one and thirty years. 2 And he did that which was right in the sight of the LORD, and walked in the ways of David his father, and declined neither to the right hand, nor to the left. 3 For in the eighth year of his reign, while he was yet young, he began to seek after the God of David his father: and in the twelfth year he began to purge Judah and Jerusalem from the high places, and the groves, and

the carved images, and the molten images. 4 And they brake down the altars of Baalim in his presence; and the images, that were on high above them, he cut down; and the groves, and the carved images, and the molten images, he brake in pieces, and made dust of them, and strowed it upon the graves of them that had sacrificed unto them. 5 And he burnt the bones of the priests upon their altars, and cleansed Judah and Jerusalem. 6 And so did he in the cities of Manasseh, and Ephraim, and Simeon, even unto Naphtali, with their mattocks round about.”

While not all of the Samaritans were Israelites, many of these Israelites left behind were among those peoples who were later known generally as Samaritans. Therefore we see the Samaritan woman at the well proclaim to Yahshua that “our fathers worshipped in this mountain; and ye say, that in Jerusalem is the place where men ought to worship” and “I know that Messias cometh, which is called Christ: when he is come, he will tell us all things” (John 4:20, 25).

4 For thus saith the LORD unto the house of Israel, Seek ye me, and ye shall live: 5 But seek not Bethel, nor enter into Gilgal, and pass not to Beersheba: for Gilgal shall surely go into captivity, and Bethel shall come to nought. 6 Seek the LORD, and ye shall live; lest he break out like fire in the house of Joseph, and devour it, and there be none to quench it in Bethel.

From Isaiah 51, where the prophet is addressing the dispersed of Israel in the isles: “1 Harken to me, ye that follow after righteousness, ye that seek the LORD: look unto the rock whence ye are hewn, and to the hole of the pit whence ye are digged. 2 Look unto Abraham your father, and unto Sarah that bare you: for I called him alone, and blessed him, and increased him.”

From Jeremiah 50, where the prophet illustrates the fall of Babylon: “4 In those days, and in that time, saith the LORD, the children of Israel shall come, they and the children of Judah together, going and weeping: they shall go, and seek the LORD their God. 5 They shall ask the way to Zion with their faces thitherward, saying, Come, and let us join ourselves to the LORD in a perpetual covenant that shall not be

forgotten.”

It was discussed earlier, that Gilgal was renowned as the home of the prophets. Bethel was one of the major seats of idolatry, and home of one of the two golden calves set up as the new state religion by Jeroboam I after the kingdom was split from Judah.

From Hosea 8, who was a contemporary with Amos: “4 They have set up kings, but not by me: they have made princes, and I knew it not: of their silver and their gold have they made them idols, that they may be cut off. 5 Thy calf, O Samaria, hath cast thee off; mine anger is kindled against them: how long will it be ere they attain to innocency? 6 For from Israel was it also: the workman made it; therefore it is not God: but the calf of Samaria shall be broken in pieces.”

The forsaking of idolatry by Israel is a major theme in the prophecy of Isaiah. Here from Isaiah 2: “12 For the day of the LORD of hosts shall be upon every one that is proud and lofty, and upon every one that is lifted up; and he shall be brought low: 13 And upon all the cedars of Lebanon, that are high and lifted up, and upon all the oaks of Bashan, 14 And upon all the high mountains, and upon all the hills that are lifted up, 15 And upon every high tower, and upon every fenced wall, 16 And upon all the ships of Tarshish, and upon all pleasant pictures. 17 And the loftiness of man shall be bowed down, and the haughtiness of men shall be made low: and the LORD alone shall be exalted in that day. 18 And the idols he shall utterly abolish. 19 And they shall go into the holes of the rocks, and into the caves of the earth, for fear of the LORD, and for the glory of his majesty, when he ariseth to shake terribly the earth. 20 In that day a man shall cast his idols of silver, and his idols of gold, which they made each one for himself to worship, to the moles and to the bats”.

Our ancestors had put away such idolatry on more than one occasion. Today we must ask, whether we have taken to such idolatry again. It can be effectively argued that we certainly have, even if our idols are now more sophisticated. If we are to truly seek after our God, we must first lay these idols aside.


7 Ye who turn judgment to wormwood, and leave off righteousness in the earth,

Judgment should be according to the laws of God, lest it be bitter like wormwood. From Isaiah 10:1-3, where the prophet addresses the same people at around the


very same time: “1 Woe unto them that decree unrighteous decrees, and that write grievousness which they have prescribed; 2 To turn aside the needy from judgment, and to take away the right from the poor of my people, that widows may be their prey, and that they may rob the fatherless! 3 And what will ye do in the day of visitation, and in the desolation which shall come from far? to whom will ye flee for help? and where will ye leave your glory?”

The Septuagint interpreted verse 7 quite differently, where it is esteemed that Yahweh refers to Himself and says: “It is he that executes judgment in the height above, and he has established justice on the earth:”

8 Seek him that maketh the seven stars and Orion, and turneth the shadow of death into the morning, and maketh the day dark with night: that calleth for the waters of the sea, and poureth them out upon the face of the earth: The LORD is his name:



Many people confuse God with Nature. Here we see that God is not merely Nature, but that He is indeed a being, a personality, which transcends Nature. The stars in the night sky mean nothing to the ignorant and casual observer. However references such as this one bring to light the antiquity of the traditions which have been written into the skies of Western Culture for thousands of years. Orion is also mentioned in the Book of Job, along with others of the constellations, at Job 9:9 and 38:31. [Orion](#) indeed has seven stars, which are interpreted as representing a man. Some commentators have likened this to Christ, He who has the seven stars, which represent the messengers to the seven assemblies, and which are in His right hand.



Revelation 1:20: “20 The mystery of the seven stars which thou sawest in my right hand, and the seven golden candlesticks. The seven stars are the angels of the seven churches: and the seven candlesticks which thou sawest are the seven churches.” It is also said that Orion forms a cross.

9 That strengtheneth the spoiled against the strong, so that the spoiled shall come against the fortress.

Matthew 23:12: “And whosoever shall exalt himself shall be abased; and he that shall humble himself shall be exalted.”

From 1 Peter 5:5-7: “5 ... God resisteth the proud, and giveth grace to the humble. 6 Humble yourselves therefore under the mighty hand of God, that he may exalt you in due time: 7 Casting all your care upon him; for he careth for you.”

James 4:10: “Humble yourselves in the sight of the Lord, and he shall lift you up.”

The Septuagint reads verses 8 and 9 quite differently, even wanting the reference to Orion and the seven stars: “8 who makes all things, and changes them, and turns darkness into the morning, and darkens the day into night: who calls for the water of the sea, and pours it out on the face of the earth: the Lord is his name: 9 who dispenses ruin to strength, and brings distress upon the fortress.”

10 They hate him that rebuketh in the gate, and they abhor him that speaketh uprightly. 11

Forasmuch therefore as your treading is upon the poor, and ye take from him burdens of wheat: ye have built houses of hewn stone, but ye shall not dwell in them; ye have planted pleasant vineyards, but ye shall not drink wine of them. 12 For I know your manifold transgressions and your mighty sins: they afflict the just, they take a bribe, and they turn aside the poor in the gate from their right.

Isaiah 29:20-21 “20 For the terrible one is brought to nought, and the scorner is consumed, and all that watch for iniquity are cut off: 21 That make a man an offender for a word, and lay a snare for him that reproveth in the gate, and turn aside the just for a thing of nought.”

13 Therefore the prudent shall keep silence in that time; for it is an evil time.

Proverbs 22:3: “A prudent man foreseeth the evil, and hideth himself: but the simple pass on, and are punished.”

14 Seek good, and not evil, that ye may live: and so the LORD, the God of hosts, shall be with you, as ye have spoken.

The prudent may be silent on account of what evil may befall them, however Christ tells us that “22 ... The Son of man must suffer many things, and be rejected of the elders and chief priests and scribes, and be slain, and be raised the third day. 23 And he said to them all, If any man will come after me, let him deny himself, and take up his cross daily, and follow me. 24 For whosoever will save his life shall lose it: but whosoever will lose his life for my sake, the same shall save it.” (Luke 9:22-24)

15 Hate the evil, and love the good, and establish judgment in the gate: it may be that the LORD God of hosts will be gracious unto the remnant of Joseph.

So we see that while the prudent are silent, because it is an evil time, they are not doing that which is godly. Here Yahweh is chastising those in Israel who have committed evils, and those who seek good are to oppose them as well.

16 Therefore the LORD, the God of hosts, the Lord, saith thus; Wailing shall be in all streets; and they shall say in all the highways, Alas! alas! and they shall call the husbandman to mourning, and such as are skilful of lamentation to wailing. 17

And in all vineyards shall be wailing: for I will pass through thee, saith the LORD. 18 Woe unto you that desire the day of the LORD! to what end is it for you? the day of the LORD is darkness, and not light.

While there are many parallels between the “Day of the Lord” which brought judgment upon the old kingdoms of Israel and Judah and the situation which the people of God are in today, and while the similarities help us to see the necessity of that judgment upon the present world which we now anticipate, the parallels are not complete. Rather, the judgment upon this old world was one fit for lamentation because the Kingdom of God was being brought to nought and His people, those who were destined to survive the carnage, were entering into a period of prolonged captivity.

In contrast, in reference to the return of the Son of Man Christians are told to rejoice. From Luke 21, where Christ is asked about His return and the end of the age: “27 And then shall they see the Son of man coming in a cloud with power and great glory. 28 And when these things begin to come to pass, then look up, and lift up your heads; for your redemption draweth nigh.” Likewise from Revelation 18:20, when Babylon falls, we see the command to “Rejoice over her, thou heaven, and ye holy apostles and prophets; for God hath avenged you on her.”

19 As if a man did flee from a lion, and a bear met him; or went into the house, and leaned his hand on the wall, and a serpent bit him. 20 Shall not the day of the LORD be darkness, and not light? even very dark, and no brightness in it?

For most of Israel, there was no escaping the expected calamity. One would be slain, or taken captive. Even if one survived, there would be little left of his old life once the Assyrians were done destroying the kingdom.

21 I hate, I despise your feast days, and I will not smell in your solemn assemblies. 22 Though ye offer me burnt offerings and your meat offerings, I will not accept them: neither will I regard the

peace offerings of your fat beasts. 23 Take thou away from me the noise of thy songs; for I will not hear the melody of thy viols. 24 But let judgment run down as waters, and righteousness as a mighty stream.

It is evident that the sacrificial rituals were abused and that the people were unrepentant of their sin, not offering their sacrifices sincerely. Neither did the people judge one another justly, but commonly took advantage of the disadvantaged. Christ quoted from Hosea 6:6, which is recorded in both Matthew 9 and Mark 12: “6 For I desired mercy, and not sacrifice; and the knowledge of God more than burnt offerings.” Likewise in Isaiah, it is seen that the sacrifices of the

people became an abomination to Yahweh for much the same reasons that Amos gives here. From Isaiah 1: “10 Hear the word of the LORD, ye rulers of Sodom; give ear unto the law of our God, ye people of Gomorrah. 11 To what purpose is the multitude of your sacrifices unto me? saith the LORD: I am full of the burnt offerings of rams, and the fat of fed beasts; and I delight not in the blood of bullocks, or of lambs, or of he goats. 12 When ye come to appear before me, who hath required this at your hand, to tread my courts? 13 Bring no

more vain oblations; incense is an abomination unto me; the new moons and sabbaths, the calling of assemblies, I cannot away with; it is iniquity, even the solemn meeting. 14 Your new moons and your appointed feasts my soul hateth: they are a trouble unto me; I am weary to bear them. 15 And when ye spread forth your hands, I will hide mine eyes from you: yea, when ye make many prayers, I will not hear: your hands are full of blood. 16 Wash you, make you clean; put away the evil of your doings from before mine eyes; cease to do evil; 17 Learn to do well; seek judgment, relieve the oppressed, judge the fatherless, plead for the widow.”

25 Have ye offered unto me sacrifices and offerings in the wilderness forty years, O house of Israel? 26 But ye have borne the tabernacle of your Moloch and Chiun your images, the star of your god, which ye made to yourselves. 27 Therefore will I cause you to go into captivity beyond Damascus, saith the LORD, whose name is The God of hosts.

The offerings of the children of Israel were apparently insincere from the beginning. At verse 26 the

Septuagint has: “Yea, ye took up the tabernacle of Moloch, and the star of your god Raephan, the images of them which ye made for yourselves”



This passage of Amos is quoted in Acts chapter 7, where we are also given more insight into some of the events of the Exodus, which we do not find in the Old Testament: “37 This is Moses who said to the sons of Israel: ‘Yahweh shall raise up a prophet for you from among your brethren, even as me.’ 38 This is he who had been among the assembly in the desert with the messenger speaking to him and to our fathers at Mount Sinai, who received the living oracles to give to you. 39 To whom our fathers did not wish to be obedient, but rejected and turned in their hearts to Egypt, 40 saying to Aaron ‘Make for us gods which shall go before us, for this Moses who led us out of the land of Egypt, we know not what happened to him.’ 41 And they made a calf in those days and conducted a sacrifice to the idol and rejoiced in the works of their hands. 42 Then Yahweh turned, and

gave them over to serve the hosts of the heaven just as it is written in a book of the prophets: ‘Have you offered to Me victims and sacrifices, forty years in the desert, house of Israel? 43 And you have taken up the habitation of Moloch and the star of the god Rompha, the images which you have made to worship them, and I shall move you beyond Babylon.’” Yet in the books of Moses as they are presently we see only prohibitions and warnings concerning the worship of the “host of heaven”, such as at Deuteronomy 4:19 and 17:3.

The Hebrew Chiun, Strong's Hebrew Dictionary # 3594, is simply a *statue* or *pillar*. The word comes from a verb which means *to stand erect*. As for the name Rompha, which is from the Codex Vaticanus reading of Acts, there are at least seven different spellings among the major extant manuscripts. The Greek words *Raiphon* and *Rompha* are unknown outside of the Biblical literature, and therefore they are not Greek substitutes for the Hebrew name Chiun which appears in the Masoretic Text.

There are many who would want to connect the modern Jewish so-called “Star of David”, which has no relation to David or his successors, to this star mentioned here in Amos. However all such explanations seem to be merely conjectural, and stars with various numbers of points were used in many pagan contexts in ancient times.

Note also that all of the ancient manuscripts of Acts have Babylon at 7:43, and not Damascus as we find in the King James Version and, so far as can be told from the *Hatch and Redpath Concordance*, all extant versions of the Septuagint. This is an anomaly which cannot be explained. The relevant section of Amos chapter 5 is wanting in the Dead Sea Scrolls.

In this context, Putin consulted with the rabbis on means of dealing with anti-Semitism, Holocaust deniers and preventing historical revisionism."

So much for truth in Russia. And so much for anything in Russia which is actually in the interests of White Christians anywhere. Whatever is good for the Jews, Putin will support. It is time that White Nationalists, and especially Christian Identity adherents, took an honest look at Vladimir Putin.

Just this May, Vladimir Putin made it illegal to question any aspect of the Holocaust in Russia, with a penalty of 5 years imprisonment for those who do so. Under this new law, not only is it illegal to question any official report concerning Soviet history during the Second World War. It is also illegal to question the

official reports concerning the verdicts of the Nuremberg trials. Therefore the innumerable Jewish lies concerning the so-called Holocaust are now upheld by law in Putin's Russia.

The day this law was signed, we posted the following report by the Ukrainian news agency Unian (we apologize for the imperfect Google translation, which has been very minimally edited):

"In Russia Criminal Liability introduced for Rehabilitation of Nazism"

"Putin's regime continues to heroize history of the USSR.

"According to the press service of the Kremlin, President Vladimir Putin signed a federal law 'On amendments to some legislative acts of the Russian Federation.

"According to the document, criminal liability for the rehabilitation of Nazism spread false information about the activities of the Soviet Union in World War II, and the denial of the facts established by the verdict of the Nuremberg Tribunal.

"It is emphasized that the law is aimed at countering attempted assaults on historical memory of events that took place during the Second World War.

"Federal law has introduced criminal responsibility for denying the facts established by the verdict of the International Military Tribunal for the trial and punishment of the major war criminals of the European Axis countries, the approval of the offenses established in the said judgment, as well as the dissemination of false information about the activities of the Soviet Union in World War II' - the document says.

"Thus, increased criminal liability is assumed by the mentioned act, if committed by a person using his official position, using the media or from the

fabrication of prosecution evidence.

"In general, the following are punishable by up to 5 years imprisonment.

"Recall as UNIAN reported earlier, in the Luhansk Oblast [of the Russian neo-Nazi arrested](#) on anti-Ukrainian propaganda materials. It was determined that the detainee is a member of the group of neo-Nazi-skinhead 'Slavs'. When he was discovered with a swastika SS, metal chain and propaganda leaflets 'Donbass arise.'"

This article was first located at the Ukrainian website [Ukrainian Truth, Historical Truth](#) and confirmation was found at the English-language website [Russia Beyond the Headlines](#).

The internet news outlet [Russia Today](#), which is actually a Russian propaganda agency, had made an announcement when the bill was passed, exactly one month before Putin signed it into law. When the bill was introduced, a story from the English-language website sbs.com entitled [Russia backs Nazi rehabilitation ban bill](#) said the following:

"Russian politicians have given initial approval to a bill forbidding 'rehabilitation of Nazism' that will punish historians denying Nazi crimes during World War II but could also be used against the opposition.

"The bill introduces a new criminal charge for "denying facts" established by the Nuremberg tribunal regarding the crimes of the Axis powers, as well as "disseminating false information about Soviet actions" during the war.

"Punishment for such violations would range from a fine of 300,000 rubles (\$A9,230), up to prison terms of five years.

"The harshest punishments would be reserved for those who disseminate such views in the media or using public office, according to the text of the bill which went through a first reading on Friday.

"Conservative pro-Kremlin MP Irina Yarovaya called rehabilitation of Nazism "not only a gunshot into the past and a crime against millions of victims of fascism, it is the execution of the future", because it could lead to the repetition of similar crimes.

"Critics saw political motives behind the bill and said it could be used to enforce a single, Kremlin-approved interpretation of history.

"It's directed against liberals and democrats that compare our regime with the regime of Hitler," political analyst Alexei Makarkin said.

"A few Russian publications have recently run articles drawing parallels between Moscow's annexation of the Crimean peninsula with Adolf Hitler's moves to annex German-speaking regions.

"Respected professor Andrei Zubov was fired from his university, the Moscow State Institute of International Relations, in late March for comparing Russia's actions in Crimea to the Nazi's Anschluss with Austria in 1938 in a newspaper opinion piece."



So it seems that not only has Putin made Russia safe for the lies of world Jewry, he also helped to protect the tyranny of his own regime from criticism with this new law. Jewish Supremacy and Jewish lies need such laws so that Jews may continue to exert many times greater influence upon the non-Jewish world than they are due. Vladimir Putin has made Russia safe for Judaism, as his war-mongering has also assured continued Jewish rule in Ukraine.

There are other areas as well, where Putin has shown himself to be no friend of White Nationalists, and certainly no friend of the White Slavs of Russia. For instance, Russia too is being overrun with immigrants from the Asiatic and Arab worlds, just as the United States is being overrun with Mexicans, and both the U.S. and Europe with Africans and Arabs.

In the face of all this immigration, Russia has been making laws which on one hand force native Russians to allow the alien immigrants, and on the other hand promote ethnic peace and diversity, an objective which Jews frequently profess is their plan for every nation, so long as they are White nations.

To this end, Russia Today recently reported that [Russian Governors who fail to stem race attacks could be sacked](#), where it said:

"A new draft law makes it the responsibility for regional authorities to prevent ethnic clashes and

disputes and allows the dismissal of top officials who fail to do so.

"The bill adds to the duties of the heads of both legislative and executive branches of power and makes them responsible for the prevention of discrimination on the basis of race, religion or language, and also for social and cultural adaptation of immigrants.

"If regional governors can't keep a lid on ethnic tension they could be dismissed. The current version of the bill differs from the [initial suggestion from a group of regional legislators](#) who last year said regional leaders should be fined or even jailed if they allow ethnic conflicts to take place.

"The initial document met strong opposition from a number of regional officials who said that the present legislation was already strict enough and from Human Rights officials who said the Federal Security Service should take all responsibility for the failure to oppose radical nationalism."

Therefore we see the beginnings of the same racial tension and upheaval which began in the United States in the 1950's, and ever since then in America the original White citizenry has been slowly replaced with aliens from all other races.

Just like in America, this undermining of the White population in Russia has a social front as well, and RT ran an article in February under the headline [Russia considers state PR agency to promote ethnic peace](#) which said:

"The Presidential Council on Inter-ethnic Relations suggests that the new agency should operate under values that unify the nation, but also monitor the tolerance levels in mass media.

"The authors of the initiative, Vladimir Zorin and Maksim Shevchenko, said that the agency must be privately owned but work on state orders and become a think tank, working with mass media and creating trends in the public sphere. In particular, the new body could commission books and movies that form the positive image of inter-ethnic accord, said the members of the council."

Another Russia Today article, from August of 2012, announced: [Kremlin to set up mobile teams to tackle ethnic conflicts](#), reminiscent of the use of National

Guard units in the American South in the 1950's and 60's, and in the American Northeast in the 1970's, all in order to enforce racial diversity. The laws and decrees signed or made by the Russian President are published in English at the Kremlin website. Here is a link which produces pronouncements concerning "inter-ethnic relations":

Like in America, the word "nation" has been abused and perverted to refer to a geographical area under a common government. However the word originally signified a group of people with common origins and history. A government ruling over more than one such group is not a nation, but an empire.

Like New York City, it is already becoming too late for Moscow. The city is said to be the home of millions of illegal aliens. Likewise, in August of 2012 Russia Today announced that [Russia's biggest mosque was to be built in Moscow](#), which said in part:

"A huge mosque able to accommodate up to 60,000 worshippers is to be built on the outskirts of Moscow. It's estimated the city is home to up to two million Muslims.

"The project to construct the mosque and a cultural center has already been discussed with the capital's mayor Sergey Sobyenin and is currently being looked at by Moscow's Committee on Architecture and Urban Planning, writes Izvestia daily."

While it was announced in November of 2013, by the same mayor, that [no new mosques would be built in Moscow](#), it is unclear whether this particular mosque was approved. But that is immaterial, since a prohibition would not remove the millions of muslims from the once-Christian city.

How long will western White Nationalists trumpet Vladimir Putin as some Great White Hope? When will they finally admit they were wrong, and recognize the fact that Putin is just another run-of-the-mill politician in the pocket of World Jewry?

The only Great White Hope that Whites anywhere can expect is indeed coming. His name is Jesus Christ.



De Klerk's Liberal Conversion and the Mindset of Treason Opening Pandora's Apartheid Box – Part 31 *extract May 2011*

We have seen that many authors describe F.W. de Klerk as once being one of the most conservative in the NP government. What is it that changed him? How does one man, bordering on the extreme right wing in his party change to become one of the most liberal and hand the country over to Black Marxist terrorists? Did the change come out of his own accord or was he forced to change?

We have seen that there are several reasons why people become traitors or cross over to the other side. The main reasons are represented by the acronym M.I.C.E... Money, Ideology, Coercion and Ego or any combination of the above.

Of these the most often one is the Ego. Traitors are criminals of the worst kind and something that criminals all share is their own greed and the belief that they will never be caught out. They are narcissists who believe they are somehow special.

What was it that moved F.W. de Klerk to become one of the worst traitors of his people to date? Was it one of the above or all of the above or was it a specific combination?

I will explore whether F.W. de Klerk fulfilled the criteria to be called a traitor. I will not follow the letters of M.I.C.E. in the proper order but in the order of what I believe was the importance. I will start with:

The "I" for Ideology

Several authors as well as F.W. de Klerk's own brother Wimpie de Klerk and F.W. de Klerk himself, state that F.W. never really experienced a Damascus conversion moment. With him it was a slow, gradual change. This is not entirely true. F.W. de Klerk did have a Damascus moment, well sort of. De Klerk used to go on holiday during the time of the run-up to his speech on the 2nd of February 1990 and sit at the beach teeming out over the water doing a huge amount of introspection and reflection.

At this stage it is necessary to explore the ideology of F.W. de Klerk at the time. When we say he was conservative or religious, then we need to define HOW conservative and HOW religious he actually was. For that, we need to digress slightly and explore the general beliefs and religious convictions of the Afrikaners in South Africa.

For the most part Afrikaners are staunch protestant people. Since the arrival of the first Dutch farmers at the Cape of Good Hope in 1652, they brought their Dutch Reformed Church (Nederduits Gereformeerde Kerk) NGK and Calvinistic religion with them. Highly educated ministers or "Dominees" were imported from the Netherlands. NG Kerk dominees study theology for seven years at university.

By 1834 when the Great Trek started on the Eastern

Frontier in what is today the Eastern Cape, the Dutch Reformed Church (NGK) was one of the mightiest organizations at the Cape and opposed to the Great Trek.

The Farmers who trekked and who later started their own Republics namely the ZAR (Transvaal) and the Orange Free State therefore started a new Church independent from the Dutch Reform Church or NGK. This church is known today as the “Hervormde Kerk” or “Reconstituted Church”. The Hervormde Kerk (HK) also imported their own Dominees from the Netherlands.

At the time there was a debate going on in the Netherlands on whether hymns should be sung in church together with Psalms or only Psalms. The argument was, “In God’s Church, only God’s word”. The argument was that, hymns were sometimes of unknown and therefore dubious origins and could have been inspired by Satan who urged a drunk to write a hymn in his drunken state. Actually they found that some of the hymns were in contradiction to the Calvinistic teachings, the Canons of Dort and the Belgic Confession.

A dominee called Dirk Postma arrived in the Boer Republic of the ZAR to take up service in the Hervormde Kerk, but upon hearing that he might have to sing Hymns in church, he broke away with 15 members and a short while later started a new Ultra Conservative church called the Gereformeerde Kerk or (GK) and enrolled 300 members.

So at this stage there were three of these Dutch Reformed Churches. The Nederduits Gereformeerde Kerk (NGK) of the Cape, The Hervormde Church (HK) of the Transvaal and the Gereformeerde Kerk (GK), the Boer Church.

One of the founding fathers of the GK church was Boer President Paul Kruger himself. Together with his 15 founder brothers and 300 new members they founded the GK under a seringboom in Rustenburg in 1859.

The GK or “Dopper” Church is still known today as the “Boer Church”.

Nevertheless, all three churches NGK, HK and GK are

sister churches and the dogma basically the same, i.e. Calvinistic. The only difference is basically the singing of hymns in church. The GK only sings Psalms and what is called “Skrifberymings”, text out of the Bible rewritten to rhyme and given melodies.

Another difference is the belief of the Ultra Conservative “Dopper” Church that God personally intervenes in the lives of people and that when one prays long and hard enough, God will show one the way...show one which course to take. They believe that one can get a calling from God. In Afrikaans it is called a “Roeping”.

F.W. De Klerk was, and still is, such an Ultra Conservative Christian... a “Dopper”, a member of the Boer Church. F.W. de Klerk comes from a thorough-bred Boer family.

During his time of intense introspection, F.W. de Klerk also searched for such a sign from God, to show him the way, a calling to do something great. The sign eventually came in the form of his personal friend and Dopper Dominee, Pieter Bingle of Cape Town.

De Klerk, his wife Marike and Pieter Bingle knew each other since their student days at the Potchefstroom University. Pieter Bingle was at the wedding of his son and would testify in the murder trial following the murder of former First Lady Marike de Klerk. Pieter Bingle and F.W. De Klerk are also members of the same Afrikanerbond lodge (afdeling), Leeuwenhof in Cape Town.

At the inauguration of F.W. de Klerk as State President, Dominee Pieter Bingle gave a sermon. His text was from Jeremiah 23 verse 16 and 22.

Jeremiah 23: 16...

Thus says the LORD of hosts:

“ Do not listen to the words of the prophets who prophesy to you. They make you worthless; They speak a vision of their own heart,

Not from the mouth of the LORD.

Verse 22:.. **“But if they had stood in My counsel, And had caused My people to hear My words, Then they would have turned them from their evil way And from the evil of their doings.”**

Basically, Dominee Pieter Bingle told F.W. De Klerk to stop listening to the people and his advisers who were all “false prophets”. He told De Klerk that he was standing in the Council Chamber of the Lord; that he was an instrument of God.

He told De Klerk that he who stands in the Council Chamber of the Lord will be aggressive enough to tackle problems and challenges fearlessly.

Pieter Bingle said...

“New ways will have to be found where roads enter culs de sac, or are worn out or cannot carry the heavy traffic. Excess baggage will be cast aside. Certain will stay and others will have to be discarded. Those stuck in the grooves of the past will find that besides the spelling, depth is the only difference between a groove and a grave.”

During the sermon, Pastor Bingle said, **"Mr. de Klerk, as our new President, God is calling you to do his will. Today God calls you to serve as the President of South Africa. God's commission is not to serve as the President of some of the people, but as the President of all the people of South Africa."**

F.W. De Klerk was deeply moved by Pieter Bingle's sermon. He was literally in tears. At a post inaugural meeting he told his friends and families that they should pray for him while the tears were flowing down his cheeks. He said that God called him to do a specific task...to save South Africa...To save all the people of South Africa.

He said that he knew he would be rejected by his own people, but that he had to walk this road and that his friends and family should help him. He confessed that God had called him and that he could not ignore the call.

De Klerk the narcissist felt himself special...singled out by God Almighty to do this job...to commit the ultimate treason against his people.

About his convictions, Allister Sparks quotes De Klerk in “Tomorrow is another Country”, page 100. “I also believe that God directs things here on earth, and as a result I had to accept that my election as president was something HE wanted to happen, and therefore in my relationship - my vertical relationship - I have a direct responsibility and I must try to live according to that.”

From that day on, De Klerk knew what to do. God told him to hand over the country to a gang of Marxist terrorists. We will see later how “God” directed De Klerk but let's continue on our journey through betrayal.

Whilst De Klerk enjoyed his Damascus moment, on the other side of the parliamentary benches, the Conservative party felt different. These people were also Christians who believed God told them to oppose De Klerk's decisions such as Dr. Andries Treurnicht who was a Dutch Reform minister for 14 years himself and later became leader of the Conservative Party, the opposition of the National Party.

But why was F.W. de Klerk in doubt to start off with? What cognitive dissonances were playing off in his mind at the time of his Bingle induced Damascus moment?

Well, several things played a role. For that we need to go back to the mid 1980's and the discussions between people at grill parties (Braais) a favorite past time of South Africans. We have to backtrack into the fears and doubts of the people of the time.

In 1985 president P.W. Botha scrapped the Mixed Marriages Act and the Immorality Act which outlawed interracial marriage and interracial sex.

Since 1983 P.W. Botha split the Afrikaners down the middle with the HNP and CP on the right and the NP and the PFP on the left. The PFP was run by a liberal Afrikaner called Dr. Van Zyl Slabbert. Inside the NP itself one had three factions, namely liberal (Verligtes), Moderates (Draadsitters), and Conservatives (Verkrampstes).

Around the Braais one would find friends and family with the entire spectrum of political views debating religion and politics, of which few actually had any

idea. The Afrikaners of the time were for the most part political ignoramuses. Their political beliefs were based on Black and White racial politics and the threat of Communism which was from the Devil. Asked them what “Liberal” and “Conservative” meant, they probably would not know.

Typical braai conversation would be, between a liberal and a conservative Afrikaner and the liberal would ask the conservative,

“OK, so you believe in Apartheid, but when you go to heaven, would there also be Apartheid in heaven? Does God have a heaven for blacks and another for whites, or how does it work? Or do you believe that only whites go to heaven? Do blacks also have souls or only whites? What about all those converted blacks out there who converted to Christianity?”

Another question would be, “OK, so you say you are so conservative...The laws have now changed. It is now possible for whites to marry or have sex with blacks...What are you going to do when your son or daughter comes home with a black man or a coloured woman?”

So with these questions in the minds of white South Africans of the time let us consider the de Klerk family.

The De Klerk Family

When one thinks that F.W. de Klerk was Ultra Conservative then it is still nothing compared to Marike (Willemse) de Klerk his first wife. She was an extremely benevolent person who helped the poor Afrikaners a lot, but she was even more conservative than F.W. De Klerk.

Her father, Wilhelm Willemse, was an academic and writer. He was Professor of Social Pathology and Psychology at Pretoria University.

Nevertheless, the couple never had any children of their own. They adopted three children together; Jan, Willem, and Susan, whom they obviously brought up with their religious convictions and conservative values.

Little Willem de Klerk, turned out to be the black sheep of the family. He was about 18/19 at the time

that P.W. Botha abolished the Immorality Act in 1985 that prohibited sex between whites and coloureds. He was also one of the first to take advantage of this new found freedom.

F.W. de Klerk’s youngest son had a weakness for all those attractive coloured girls down in the Cape. While he was a student at the Cape Technikon he met a young coloured lady that took his fancy called Erica Adams. Erica was the daughter of a Coloured politician namely Deon Adams of the Labour Party. They were madly and passionately in love and wanted to get married. They got engaged, but his mother Marike flipped out. No ways that she wanted coloured grandchildren, especially not from her darling youngest boy Willempie. She told him that he was putting his entire father’s work in jeopardy. That he was going to destroy South Africa if he continued the relationship with this coloured girl. After two years of severe pressure from his mother Willem ended the relationship with Erica.

Willem then went on to marry a White Afrikaner girl called Hermien Mostert. She was an ex teacher and at the time she held a senior post at Woolworths. At their wedding Dominee Pieter Bingle did the table prayer. ds. Kobus van der Westhuyzen moderator of the NGK in the Western Cape married them.

Nevertheless the marriage lasted four and a half years. The couple got divorced around the same time that F.W. de Klerk got divorced from Marike...more on that later.

While young Willem was married to Hermien, the owner of a very popular restaurant in Kloof Street, Cape Town, said Willem de Klerk and a woman with dark hair had visited the restaurant a month before and were openly affectionate with one another. Who was this mysterious dark haired woman? Her name was, Nicole Norodien. Another Cape Coloured exotic beauty for young Willem De Klerk. Willem then married her in Paarl in February 2003.

He started to divorce her in 2009 (the case is still ongoing) after she had an affair with a Johannesburg Businessman, Ernest Lefebvre. Willem de Klerk sued Lefebvre for R200,000 but lost.

During the divorce case she claimed that De Klerk

was "unpredictable and aggressive" towards her, and that he is "emotionally and verbally abusive". Norodien described him as "regularly intoxicated", adding that he drank "excessive" amounts of alcohol. She claimed he had been having an affair and said he had had several previous adulterous relationships. Nevertheless he had two children with Norodien.

Norodien also wanted the court to order De Klerk to pay her maintenance of R15 000 a month, as well as comprehensive medical aid cover, a car worth R300 000, a house of up to R2-million or R20 000 a month for accommodation and "household necessities" worth R200 000.

Was Norodien right? Was Willem de Klerk now having another affair with another coloured woman? Yes.

Willem De Klerk now 44 years old has just (May 2011) settled out of court with another coloured woman named Desiré Joseph , a 27 year old midwife at the Tygerberg Hospital. She comes from the Boland town of Wellington where her parents own a furniture shop.

They met in a pub in the town of Paarl. She claimed that he was the father of her child Ana-Wilmien, but he denied it and wanted paternity tests done. Paternity test proved that he was indeed the father of the child.

Why did she leave him? She said she caught him with another coloured woman in the same pub when she was seven months pregnant.

The end result today is that former President F.W. de Klerk now has three coloured grand children. His worst fears came to life.

What we spoke about around braais happened to him. His son came home with a coloured woman...several in fact...and several grandchildren.

How could he still morally justify Apartheid when his son was producing coloured grand children on a regular basis?

All F.W. de Klerk's superior education as a lawyer, his conservative convictions, his Ultra Conservative religious beliefs that he raised his children on, all came to naught when his youngest boy came home with a coloured girl and evinced a weakness for Cape Coloured beauties.

As a once Ultra Conservative politician it must have chewed F.W. de Klerk up inside. Although Willem was an adopted child, he was still raised in the De Klerk household. He attended church and Sunday school, graduated with a "Boere Matriek" called "Katkisasie", accepted into the Gereformeerde Kerk, the Boer church, yet still he discarded all of those conservative upbringings and still went for race mixing.

Under Apartheid laws F.W. de Klerk's son would have been in prison. F.W. de Klerk had to make peace with this and that his grand children would be coloureds. One can almost have sympathy with him today. His Ideology changed from Ultra Conservative to Liberal. A rare occurrence, for normally it is the other way around.

The "E" for Ego

We have already seen that F.W. de Klerk thought of himself in a narcissist way as singled out by God to save South Africa.

Nevertheless. During the early years of F.W. de Klerk's presidency he travelled to London where in 1989 his friend Dawie De Villiers, former Springbok Rugby player, turned liberal politician and at the time ambassador to London, introduced him to a Greek couple Tony and Elita Georgiadis.

Tony Georgiadis and his brother are the owners of a shipping company operating out of London called Alandis.

During the sanction years against South Africa, Tony Georgiadis went out of his way to deliver oil to South Africa. He bankrolled the National Party and defied international sanctions to deliver oil to our country.

However, Tony Georgiades name appeared again when Independent Democrats leader Patricia de Lille released her "arms deal dossier" in 1999, identifying him as a lobbyist for German arms companies.

In 2008 the M&G revealed that Georgiadis received at least \$22-million from ship-builder Thyssen for lobbying fees and paid more than three amounts of R500 000 to the ANC and two charities linked to Nelson Mandela and his wife, Graça.

Tony Georgiades and his former father in law George Lanaras, the father of Elita are business partners and were the targets of German investigations into the arms deal.

Elita married Tony Georgiadis in 1971, but divorced him in 1998 to marry former South African president FW de Klerk. Georgiadis had in the meantime begun transferring his circle of contacts to the new Mandela government.

Marike and F.W. de Klerk became good friends with the Giorgiadis couple. They became frequent visitors to Greece where they were the guests of the Giorgiadises on Tony's luxury motor yacht.

Elita was a spoiled woman. She grew up rich and had a privileged life and was bored of all the luxury. She started to have an affair with the very religious and conservative F.W. de Klerk. Apparently God turned a blind eye at the time, because De Klerk was still the chosen one...

By 1994, Georgiadis suspected his wife of having feelings for De Klerk and confronted the outgoing president about it. De Klerk agreed to sever contact with Elita, but he did not. Maybe if he prayed and asked the Lord to show him the way, he would have had another Damascus moment. Nevertheless during the entire time of the Codesa negotiations, also known as the "Roelf and Cyril show", De Klerk was disinterested. All he had on his mind when our country was handed over to Marxist terrorists gangsters was his Greek mistress.

De Klerk was totally obsessed with Elita. He followed her around like a lost puppy. He was so besotted that he was not thinking rationally. His entire country was slipping into the hands of criminal Marxist scum, his people about to be slaughtered, yet De Klerk could not care less. De Klerk was betraying his friend Tony, he was betraying his wife Marike, he was betraying God and it was only natural that he would eventually betray his people too.

To understand what type of person De Klerk is, one has to remember that he left his wife Marike on Valentine's Day 1998 to live with his mistress. Six days after the death of Marike he married Elita.

In her emotional biography, *Marike: A Journey Through Summer and Winter*, ghost-written by Maretha Maartens, the former first lady described the closing chapter of the couple's marriage....

Where was Dominee Pieter Bingle to intervene and chastise his friend F.W. de Klerk? Instead of preaching to him about skanks such as Jezebel or Delilah he searched for a fig leaf to cover F.W. de Klerk's sins. He told the people not to judge De Klerk and that those without sin should throw the first stone.

The "M" for Money

Was F.W. paid to hand over South Africa? How did he gain financially?

Well, he obtained half of the Nobel Prize which is about \$1,4 million dollars. It means F.W. got about \$700,000 officially for handing the country over. He wrote a biography and got royalties from other books about him. He travels the world and delivers speeches as the chairman of the F.W. de Klerk Foundation and

the chairman of the Global Leadership Foundation and obviously makes a bit of money like that. This is all legal. The question we need to ask is was he paid a specific sum? How much was he paid and most importantly who paid the piper and called the tune?

In a report in the Citizen, Steven Motale reported that former president P.W. Botha in an interview with a Dutch Newspaper a few days before his death alleged that De Klerk received “Millions of dollars” to hand over the country to the ANC.

P.W. Botha made the same allegations to author Jan [Lamprecht](#) when Lamprecht visited him at his home “Die Anker” in George. The amount was not even that big. \$3 million or something to that effect.

Apparently P.W. Botha said he knew about the offer, because the same offer was made to him. He did not accept. He also did not say how big the offer was or who the donor/s were.

The leader of the HNP Willie Marais wrote a letter to De Klerk asking for his explanation and why the money was not declared. De Klerk threatened with lawyers in the light of libelous accusations, yet he never went through with it. The National prosecuting Authority and the Scorpions simply ignored these allegations and it was never investigated.

What we do know is that in 2008 De Klerk owned a prestigious wine farm in the Cape called “Wildepaaardejacht” which was his residence for ten years. It had 14 hectares of vineyards and 7 hectares of olives and fruit orchards. It went on the market for R35 million.

After this De Klerk bought himself a R20 million mansion in Fresnaye in Cape Town where he is still living today with his Greek wife.

Have no doubts. F.W. de Klerk is not a poor man today. Whether he took the money that was offered to him and P.W. Botha, is hard to say. Whether the NPA will ever investigate it fully is another question. What concerns me more is who could have been the possible sponsors?

A glimpse of this comes from two books. The first one I already touched on, namely, “Tomorrow is another

Country” by Allister Sparks, formerly a journalist from the Anti Apartheid newspaper the Rand Daily Mail and the man who exposed the Muldergate, Eschel Rhoodie so called “Information Scandal”.

Sparks tells us that the secret negotiations between prominent Afrikaners including F.W. de Klerk’s brother Wimpie were sponsored by Consolidated Gold Fields, a British Mining Company established in 1887, 12 years before the British went after the gold in the two former Boer Republics of the ZAR and the Orange Free State.

On page 82, Spark says that there were twelve of these secret meetings, between November 1987 and May 1990. Eleven of them took place at Mells Park House, in the village of Mells, near Bath, Somersetshire, a luxury estate belonging to Consolidated Gold Fields.

Sparks mentions that the man behind it all was the director of public affairs at Consolidated Goldfields, Michael Young. He was the mediator or facilitator in these secret meetings. It was his job to find the role-players for the secret meetings. It was his job to get Professor Willie Esterhuyse and Thabo Mbeki amongst others drunk on Glenfiddich, telling jokes and yarn swapping so they could see that in their drunken state they were all the same.

All the air fares, food and liquor were sponsored by Michael Young and Consolidated Gold Fields. A small price to pay for all the gold in South Africa.

Today it is hardly a secret anymore. In 2009 they produced a movie for BBC Chanel 4 called “Endgame” telling us everything about the secret meetings facilitated by Michael Young. At the time the meetings were ultra secret, illegal and participants talking to a terrorist organization such as the ANC would not only lose their jobs, they would be imprisoned. The ANC was on the CIA’s list of the ten worst terrorist organizations in the world...not that it actually mattered, because the CIA was funding them.

The French have a saying, that if you want to hide something, all you have to do is put it in the centre of the picture and nobody will notice it.

This model or method of getting role players secretly together to betray their countries worked so well in the case of South Africa that Michael Young wants to export it to capture other nations.

Who needs war nowadays? As Prof. Willie Esterhuysen told his students afterwards, these things nowadays get decided over a bottle of single malt whisky. The end result is the so-called “Peace” we have in South Africa at the moment.

The other players in this game are exposed in the book, “Really Inside Boss” by P.C. Swanepoel, a retired senior National Intelligence Services agent (Director of Research) who discovered the role of the CIA in funding the ANC and other terrorist organizations in South Africa through various front companies and conduits in the UK and South Africa as well as through student organizations in South Africa.

When Swanepoel went to his boss, “Lang Hendrik” van den Bergh to tell him what he had discovered, General van den Bergh, also known as “The Tall Man” turned a blind eye. He refused to even read the reports.

William Rourke “Big Bill” Jordan, who ran a company called IMCO in the centre of Sandton City Centre, Johannesburg, was the head of the CIA’s Special Operations in South Africa at the time.

Big Bill was a personal friend of General Van den Bergh. He used to spend his Sundays on General Van den Bergh’s farm driving his tractor around to get some fresh air. (p99).

Today one shudders to believe the naiveté of our former National Intelligence masters. In those days we believed that the West was our friend. We were always Pro-Western and even fought on the side of the West in two World Wars. It was incomprehensible that these people would one day betray us.

It is wrong of us to say today that “The Americans betrayed us” or “The English were at it again like in the Boer war.”

The average American or Englishman today has no idea of what their hidden governments; the Council on Foreign Relations and the Royal Institute of International Affairs were up to. They are as much victims of the same organizations as we are in South Africa.

It appears as if these people, The Anglo American Establishment of the CFR and the RIIA through their agents, the CIA and MI6, in co-operation with big business, were the ones who made the offers to P.W. Botha and F.W. De Klerk. If F.W. de Klerk indeed took any of the money it would be interesting to find out if it was declared and whether he paid taxes on it.

The “C” for Coercion

So we have covered the M, the I and the E of M.I.C.E. However, what did the C in M.I.C.E stand for again? It stood for “Coercion”...meaning what did they blackmail him on?

The State Security Council

During the time of P.W. Botha, he formed what was called the State Security Council. It was a group of about 100 civil servants from various departments. Its function was to advise the government on formulating and executing national security policy. Botha himself chaired the SSC. F.W. De Klerk was a member of the SSC from 1985-1989.

These were the people who decided how the enemies of Apartheid should be “removed”. They were the ones who gave the orders to hit squads such as the Civil Cooperation Bureau (military) and Vlakplaas’ unit C10, later called C1 (Police) and later denied having any knowledge of atrocities and human rights abuses.

Today the head of Vlakplaas Eugene de Kock is serving a 212 year prison sentence for doing the jobs nobody else wanted to do and which he was instructed to do by the SSC.

Minutes of the meetings of the State Security Council show that F.W. de Klerk was present when the decision was taken to “Remove” Mathew Goniwe.

Goniwe and the so called “Cradock four” were abducted, beaten and murdered by three Black Security Branch policemen, a Sergeant Faku, Sergeant Mgoduka, and one Sakati . They burnt the bodies in the car that Goniwe was travelling in.

The three policemen themselves who participated in the killing of the activists were later killed in a car bomb blast at Motherwell in 1989.

The usage of semantics such as “Remove” would later emerge to be simply meaning offering the person a job in the Transkei or something to that effect...it never meant “Kill”. These were the word games De Klerk was playing when he personally ordered the killing of five sleeping teenage boys in 1993 when the Codesa negotiations were coming to a close.

Funnily enough, when political opponents of the NP turned up dead one after the other, after the SSC ordered them to be “Removed”, no enquiry was ever made. No investigations, no arrests...nothing.

De Klerk had many skeletons in his closet, not just his love affair with his Greek mistress at the time (that nobody knew of).

A few years later his former wife Marike wrote two books. Her second book, “A place where the sun still shines” was an attempt to help women who are going through the same as she went through with F. W. de Klerk.

She wrote an entire chapter on F.W. de Klerk. She was bitter and suffering from depression. The editor of Marike de Klerk’s two books, Maretha Maartens of publishers Carpe Diem, sent a copy of the chapter to F.W. de Klerk. The chapter was called, Grotgesprek (Cave Conversation).

F.W. De Klerk was livid. Maartens confirmed to

Afrikaans newspaper Rapport that the chapter was deleted at FW’s request adding that a compromise was reached whereby some portions were published while others, the more bitter elements, were withdrawn.

Both F.W. de Klerk and Rapport has a copy of the original chapter. It is being kept from the public. What was it that Marike de Klerk wanted to reveal in her book? An anonymous source provided Rapport with the chapter, where Marike warns Elita that she too will die alone.

Marike was brutally murdered under mysterious circumstances at her Bloubergstrand sea view apartment at the Dolphin Beach complex on the fourth of December 2001.

I have heard from a person who was close to her that Marike was working on a third book in which she would “Reveal all” about F.W. de Klerk’s treachery.

Marike was growing more and more despondent with the crime situation in South Africa and she knew that F.W. de Klerk had a big part in betraying South Africa and its entire people. She was married to him for 39 years after all. She would know exactly how much money he received and by whom it was paid.

To use F.W.’s semantics...for this she was “Removed”.

Summary

of their lives. [The Daily Telegraph](#) states:


"The new type of sham marriage involves couples – including a European Union national with 'free movement' rights to be in Britain – marrying in overseas ceremonies which they do not even have to attend.

1. Jews use pornography “to destroy gentile morals”

Who are the richest and most successful entrepreneurs

of the \$100 billion year porn industry? The peddlers of pornography belong to all races, but one race above all stands out as preeminent in this field. Selling sex, like slave trafficking and money-lending, has always been a Jewish speciality.

Jewish academic historian **Dr Nathan Abrams** (above), perhaps the world’s most renowned authority on the Jewish role in pornography, let the cat out of the bag a few years ago in his controversial essay, *Triple-Exthnics*. Published in the prestigious *Jewish*

Quarterly in 2004, this essay spelled out in detail how the world's multibillion dollar porn industry was dominated by Jews.

Dr Abrams not only admits that Jews are the world's most successful pornographers, he celebrates the fact. Jews, he tells us, have a grudge against Christianity, an "atavistic hatred of Christian authority" rooted in centuries of humiliation, and pornography is one of the ways in which they get their revenge on their Christian persecutors — the hateful oppressors who expelled them from 109 countries since the year 250 AD, always without justification. So it's now payback time.

Jewish involvement in pornography [Dr Abrams notes candidly] has a long history in the United States. Though Jews make up only two per cent of the American population, they have been prominent in pornography. According to one anonymous industry insider quoted by E. Michael Jones in the magazine *Culture Wars* (May 2003), "the leading male performers through the 1980s came from secular Jewish upbringings and the females from Roman Catholic day schools". The standard porn scenario became as a result a Jewish fantasy of schtupping the Catholic *shiksa* [non-Jewish female].

Jewish involvement in the X-rated industry can be seen as a proverbial two fingers to the entire WASP establishment in America. Jewish involvement in porn, Dr Abrams believes, "is the result of an atavistic hatred of Christian authority: they are trying to weaken the dominant culture in America by moral subversion."

Al Goldstein, the publisher of *Screw* magazine, had once said — and Dr Abrams is happy to quote him: "The only reason that Jews are in pornography is that we think that CHRIST SUCKS."

Dr Abrams' indulgent attitude to porn is a little surprising. Here is a man who actually believes that Jewish domination of the porn industry is a stunning achievement. Jews get gold stars for masturbation promotion.

ADL National Director, Abraham H. Foxman, agrees with the "liberal" idea that pornography is a good

thing — if not for the countless victims of porn addiction, at least for Jews who grow rich on exploiting those addicts. "Those Jews who enter the pornography industry," Foxman notes with approval, "have done so as individuals pursuing the American dream."

Dr Abrams, the sober Jewish academic, now ups the ante by adding a sinister touch to the controversy. "Jews are the driving force behind the modern pornographic industry," he tells us smugly, "and their motivation is, in part, to destroy gentile morals."

To destroy gentile morals

Note that phrase well. It amounts to an open declaration of war. For why should Jews wish to "destroy gentile morals" unless they hated the gentiles — in this case, Christians — and wanted to destroy our most cherished values?

There is no law to prevent this Jewish comedienne (pictured opposite) from uttering blasphemous obscenities against Jesus Christ and giving offense to 2.1 billion Christians by her infamous comment, "*I hope the Jews did kill Christ! I'd fucking do it again — in a second!*" Just imagine an equally well-known Christian comedian coming out with a similar insult against the victims of the Holocaust: "*I hope the Nazis DID kill 6 million Jews! I'd fucking do it again — in a second!*"



Such a grossly offensive comment would be unthinkable. The comic who made it would be ostracized at once and never allowed to work again in the entertainment business. And yet the Jew today, in the person of Sarah Silverman, is perfectly free to spit in the Christian's face and is even applauded for this hate speech. The Christian can do nothing about it.

He has become a slave in his own country — an object of ridicule and contempt.

2. How Jews Dominate the American Porn Industry. It comes as no surprise that Jews dominate the production and distribution of pornography. If you want to learn more about these luminaries of lust and see what they look like jewishfaces.com/porn.htm is an excellent starting point.

In a now defunct article entitled *Jews in Porn*, parts of which have been published on Henry Makow's site, Luke Ford notes: Used to hatred from society, Jews will do its dirty work – such as money-lending in the Middle Ages or porn today – for the opportunity to make money.

Persecuted for millennia in the various societies they've lived in, many Jews developed an allegiance to their own survival as their highest value and care little about the survival of the persecuting society. Even when Jews live in a society that welcomes them instead of harassing them, many Jews hate the majority culture. Neither rooted in their own tradition or in that of the majority Christian tradition, they live in a community of rebels. Because of Judaism's emphasis on education and verbal dexterity, Jews dominate academia, entertainment and media generally. Porn flows out of this culture over which Jews exert an influence disproportionate to their 2% proportion of the American population.



SAN FERNANDO VALLEY Known also as “Porn Valley”, this bastion of Jewish sleaze is thought to produce 90 percent of America’s pornography.

Robert J. Stoller, M.D. in his 1991 book, *Porn: Myths for the Twentieth Century*, sought to understand the mentality of the people involved in the hard core pornography business. While interviewing some of the actors and actresses in California, he was told, “If you’re welcomed into the porn scene, it’s unbelievable. It’s an extended family.... *So many Jewish people involved with it.*” Today, most porn movies and porn videos in America are produced by Jews in the **San Fernando Valley** (pictured) in Southern California. This is located just north of Los Angeles in a sprawl of seedy suburbs known to locals as “Porn Valley” or “the Other Hollywood”.

Here Jews are the kingpins of the sex industry and own every single major studio. Chief among these is **Vivid Entertainment**, reportedly the largest porn production company in the world. This is owned by Jewish multi-billionaire Steven Hirsch, sometimes known as the “Porn King”. Vivid generates an estimated \$100 million a year in revenue, cranking out 60 films per year and selling them in video stores, hotel rooms, on cable systems and on the Internet.

“**Sex is a powerful thing,**” Hirsch notes complacently. “This is the right time for us!” Another billionaire Jewish porn mogul, Paul Fishbein, founder of Adult Video News (*AVN*), is also headquartered in Porn Valley, California. Fishbein’s business associates, Irving Slifkin, Barry Rosenblatt, and Eli Cross are all fabulously rich Jews. So make no mistake: Porn Valley, California, is a Jewish enclave, as Jewish as Tel Aviv or Brooklyn.

3. The Jewish Role in Child Pornography

According to the British charity, National Children’s Homes, 55 percent of the world’s child porn in made in America. It would be astonishing to learn that Jews were not in the forefront of this sordid enterprise also, given that they dominate the porn industry as a whole.

Pedophilia is a worldwide phenomenon, but it is an undeniable fact that the large number of Jews who practice it appear to do so with a certain impunity. Roman Polanski, after he had drugged and raped an unconscious nymphette, got off the hook lightly. All he had to do was buy a one-way ticket to Paris, France. Nothing was done to bring him to justice.



In July 2000, Brazilian police tried to arrest the Israeli vice-consul in Rio de Janeiro, Arie Scher. He was wanted on suspicion of running a child porn ring from the Israeli embassy. Vast quantities of pornographic material had been found on his computer. What happened to Scher? Nothing. Claiming diplomatic immunity, he hopped on a plane to Tel Aviv and that was the last that was heard of him. Another Jewish pedophile too important to receive serious punishment for his crimes was the son of the famous science fiction writer Isaac Asimov. Found in possession of the hugest cache of child pornography in California, a federal crime normally carrying a 20-year sentence, David Asimov was to receive a slap on the wrist: six months home detention.

How is it he got off so lightly? “A look at the players yields the answer,” a sensational news report reads. “Asimov’s child porn stash was so big that many child victims and perpetrators would have taken a fall had Asimov been zealously prosecuted at trial.” There is one law for the Jews, it seems, and another for us lesser mortals.

4. Jewish Gang involved in Child Murder and Snuff Pornography

If 55 percent of the world’s child pornography is produced in the US — according to the British charity National Children’s Homes — 23 percent of the world’s child porn is produced in Russia. Whether or not Russian child porn is dominated by Russian Jews remains a nebulous issue. There is a high probability that it is, given that there is more than enough solid evidence of Russian Jewish involvement in sex

trafficking, kidnapping, pedophilia, and even child murder in the production of snuff porn movies.

Here is a news report first published in October 2000. It will give the reader some idea of the depths of depravity to which some pornographers are willing to sink:

Jewish Gangsters raped & killed children as young as two on film

Rome, Italy — Italian and Russian police, working together, broke up a ring of Jewish gangsters who had been involved in the manufacture of child rape and snuff pornography.

Three Russian Jews and eight Italian Jews were arrested after police discovered they had been kidnapping non-Jewish children between the ages of two and five years old from Russian orphanages, raping the children, and then murdering them on film. Mostly non-Jewish customers, including 1700 nationwide, 600 in Italy, and an unknown number in the United States, paid as much as \$20,000 per film to watch little children being raped and murdered. Jewish officials in a major Italian news agency tried to cover the story up, but were circumvented by Italian news reporters, who broadcast scenes from the films live at prime time on Italian television to more than 11 million Italian viewers. Jewish officials then fired the executives responsible, claiming they were spreading “blood libel.”

Though AP and Reuters both ran stories on the episode, US media conglomerates refused to carry the story on television news, saying that it would prejudice Americans against Jews.

According to the *Talmud*, 3-year-old girls like this are fair game for sex with adults (Sanhedrin 54b). Killing them is permissible too. “The best of the gentiles deserves to be killed,” the revered Rabbi ben Yohai states authoritatively in the *Talmud*.

5. Mass Enslavement through Sex

It is a tragedy that the Jews should have been allowed to deploy pornography to such good effect that they have succeeded in enslaving entire nations, as Circe with a touch of her magic wand enslaved the Greeks, turning men into swine: an apt metaphor for what lies ahead for the masses under their new masters.

“A really efficient totalitarian state,” Aldous Huxley once noted, “would be one in which the all-powerful executive of political bosses and their army of managers control a population of slaves who do not have to be coerced, because they love their servitude.”

Organized Jewry seems to have no moral scruples about profiting from the sale of pornography. They show no concern about the proven fact that highly addictive and dangerous erototoxins are released into the brain after contact with pornography and can cause progressive brain damage.

Nor do these pornocentric Jews have any qualms of conscience in regard to the wholesale corruption of families, whether Jewish or non-Jewish, or show the slightest concern about the tragic descent of children into the hell of compulsive masturbation and porn addiction — a subject I have covered in detail in a soon-to-be-published article.

These are not the worldchangers and wizards of the future of whom Nietzsche said, “Behold, I show you the Superman!” Because of their degeneracies, their weaknesses, they are destined for the dustbin of history.

Here is what Nathanael Kapner has to say on this subject. It is a neat summation. The fact that Kapner is Jewish makes his words even more compelling:

“The degradation of Western Christian social life did not merely happen, it was planned, deliberately fostered and spread, as outlined by *The Protocols of the Learned Elders of Zion*. This systematic undermining of the culture of the West continues today. The instruments of this assault on Christian culture and consciousness are the weapons of propaganda: the press, television, cinema, and education. The chief fount of the propaganda is the cinema.

From his capital in Hollywood, the Jew spews out an endless series of perverted films to debase and degenerate the youth of America and the Western world. Divorce replaces marriage, abortion replaces birth, and the family becomes the battleground of individual strife. The Jew has attained his goal in destroying Western culture.”

I am afraid I cannot agree with Kapner’s sweeping conclusion that the Jews are entirely to blame for the decline and fall of Western culture. 6. Conclusion

Holohoax Memorial Berlin, Crumbling

The so-called Memorial to the Murdered Jews of Europe which the Jews have imposed upon the city of Berlin is a revoltingly ugly field of 2,711 large concrete slabs. This grotesque waste of resources occupies nearly 5 acres in the heart of the city a short distance from the Brandenburg Gate. Each of the slabs are 2.38 meters long and .95 meters wide, however they purposely vary in height.

If we had to guess, we would imagine the varying heights of the slabs to represent the disparity between the many Jewish tall tales upon which the artificial “holocaust” narrative is constructed. Now, although it is now only 9 years old, approximately 80 percent of the large rectangularly shaped slabs are crumbling. We find this to be quite fitting, since the Holocaust stories which the stones represent have long ago crumbled, and should have been relegated to the dustbin as well.

The “memorial” was designed by an “American” Jewish architect, Peter Eisenman, and the British engineering firm Buro Happold. It includes the 4.7 acre field of now-crumbling concrete slabs and an underground “information” center. At a cost of \$36.7 million it was completed in 2005.

Cracks have been discovered in thousands of the concrete slabs that make up the supposed memorial. Approximately 2,200 out of the 2,711 slabs are said to be damaged. Now the people who have been connected to its oversight, maintenance and construction have been scrambling to answer questions about the cause and, ultimately, about who will have to pay for the repairs.

Already the foundation which operates the “memorial” has said that it has reinforced 44 of the more damaged slabs with steel bands, and had ordered an additional 380 such

bands are planned for others. Two of the slabs to Aachen Institute for Building Research to be examined. The cause of the damage is still under investigation, but some speculate the concrete used was not designed to withstand extreme weather fluctuations in Berlin. When the “memorial” was opened, the architect Eisenman reportedly boasted that the concrete used in the slabs was the “best concrete Berlin has ever seen.” According to a related website, they were manufactured by Firma Geithner and were erected on site after receiving final approval from Eisenman and his team.

Now Eisenman is singing a new song. In a recent [interview with Stern.de](#), the 81-year-old architect blamed the damage on the board of trustees of the “memorial”. “Things have been changed in order to save money,” he told the news bureau. “This is a huge problem.” He added that he would “certainly not pay for the damages.”

The “Foundation Memorial to the Murdered Jews of Europe” is actually more cautious, and an official told the same newspaper that it was too early to blame anyone, including the board of trustees. Uwe Neumärker, director of the foundation said officials had yet to determine the cause, remediation method and cost before laying blame. Then will the responsible party be determined, he said, likely by the courts, he said.

The courts. How typical of the Jews. We are amused, but not surprised, by these developments. We look forward to the day when the whole world sees that the holocaust itself has indeed crumbled. *We found a short video at Youtube, [Five years Holocaust Memorial in Berlin](#), where Eisenman and Neumärker were interviewed by German television. Perhaps the tenth anniversary will be celebrated with a different attitude.*



Judas Goat

Silence of the Goats

If Hollywood were to make a movie called 'Silence of the Goats,' it would be about jews being gassed in concentration camps by evil White Christians. There would be “weeping and gnashing of teeth,” (Mt. 13:52), “bemoaning... and lamenting... when they see the smoke of her burning” (Rev. 18:9) and “clothed with terror... trembling” Ezek. 26:16 NIV. What? You say they've already made that movie? Yes, hundreds, if not thousands of fictional dramas depicting the perpetual horrors of jewish persecution... they just have different titles: Schindler's List, Sophies Choice, The Pianist ad nauseam. Try as they may to depict the audible sounds of genocide, there has never been anything substantial to prove actual gas chambers or crematoria designed for mass executions. Instead, we have been inundated with hysterical propaganda and neurotic jewish actors pretending to have escaped the so called Holocaust. They preceded the contemporary batch of crisis actors that mold public opinion in the controlled media from 9-11 to Sandy Hook.

The prostituted pulpits of America likewise butcher the Bible so that hardly anybody knows who the real sheep and the real goats are... or why Jesus is going to divide the sheep on His right hand and the goats on the left. Those of you who are familiar with my work, know that on occasion I have said 'we owe the jews a Holocaust.' Today, I'm going to show you, biblically, how that will come to pass; how the goats will be silenced forever. For it is we, White Christians, who have been “accounted as sheep for the slaughter” (Romans 8:36) as it is written in the talmud. We contemplate the near impossibility of communicating the Christian Identity message to our countrymen and

it's all due to the jewish lies that have permeated most of our defeated and demoralized people, who are more lost now than ever before. They put on the facade that they are concerned about our nation and a future for their children, but their souls are putrefying in a puddle of multicultural lies. You see, the talmudists don't want you to get too knowledgeable about their contempt for you and how they regard you as cattle or chattel (enslaved people seen as property). You've heard it before, I'll say it again: “*My people are destroyed for a lack of Knowledge*” Hosea 4:6. What knowledge?

Christian Zionists (those who are under the spell of the jewish hypnotist) will tell you that Matthew 25:33 is only talking about good people and bad people. Really? Even though the verse just before that, puts it into context saying it's “*nations*” that will be separated? In fact, there is not one nation that will escape the omnipotence of Almighty God. We know that sheep are the exclusive identity of Israelites; there is no spiritual Israel or honorable mentions. The sheepfold only pertains to Israelites, whom Paul identifies in Romans 9:4. Therefore, the goats must be, by the power of logical deduction, non-Israelite nations. Any variation of this truth is a goat trying to squeeze itself into our divine destiny.

The Second Coming of Jesus Christ is not about your apathetic soul being Raptured to Heaven, it's about the final destruction of Esau-Edom and all the goats that fall under their umbrella. It's also about the sheep who worship the ground that goats walk on, as if they were the lost goats of the house of Israel. It is the

great culmination of the ages between light and dark, righteousness and unrighteousness, the unbridgeable gulf between our race and all others, in which divine justice reconciles those who have put asunder, those whom God has joined together with Himself. The God of Israel is not an integrationist and the Bible is not a blueprint for racial diversity; the Lord is the God of segregation, the Word of God says, *“This is the book of the generations of Adam”* Gen. 5:1. Otherwise, He would not be separating two very distinct groups of people. The theme is recorded throughout Scripture.

In Mt. 13:47-50 we read about the great dragnet that was cast into the sea (which represents the world), in which every kind of person is identified as being a citizen of the Kingdom or not. The Greek word for *“kind”* is 'genos' (#1085) and means kin, nations, offspring or race. Races of people were being gathered in and *“gathered the good into vessels, but cast away the bad.”* And it says they discriminated between the wicked and the just. The wicked were cast into a furnace of fire. It was the same story in the parable of the wheat and the tares earlier in the same chapter, whereby an enemy planted weeds in a field of wheat (Mt.13:28). God will send forth His angels (which means messengers), but it doesn't say whether they are terrestrial or celestial; they are the reapers who will gather the tares first, binding them in bundles to burn them; but gather the wheat into the Lord's barn. *“The field is the world; the good seed [race] are the children of the Kingdom; but the tares are the children of the wicked... the enemy that sowed them is the devil.”* Let's hold the devils feet to the fire, those that are responsible for the race mixing, *“and shall cast them into a furnace of fire”* (v.42). Collectively, the purveyors of mongrelization are identified in the NT as “devils,” which means false accuser or slanderer. If you see a Jew moving his lips, he's lying. *“For this purpose the Son of God was manifested, that He might destroy the works of the false accuser”* I John 3:8. Race mixing is only approved of in Baal worship.

From Easton's Bible Dictionary we can glean the various Hebrew words for goat. The word 'ez,' (aze, #5795) is a she goat or a he goat or a kid (young goat). Hence it may be regarded as the generic name of the animal as domesticated. It literally means 'strength' and points to the superior strength of the goat as compared with the sheep. The word 'attud,'

(at-tood, #6260) used metaphorically for princes or chiefs as in Isaiah 14:9, where we read about the king of Babylon or Lucifer, the chief goat/ram who thought he was God [Dodge trucks are 'ram tough']. The word 'sa'ir' (saw-er, #8163) is a shaggy, hairy goat and by analogy a devil as Lev. 17:7 reports, *“And they shall no more offer their sacrifices unto devils [goats], after whom they have gone a whoring”*; it is the goat of the sin-offering in Lev. 9:3,15; so we see that sa'ir was not only the goat of Levitical ordinance, but also heathen animal worship, which the KJV calls “devils” as in devil worship; why did Israel go into Assyrian captivity? They were *“whoring after strange gods”* Deut. 31:16. The word 'azazel' (az-aw-zale, #5799) a goat of departure, the scapegoat, as found in the Levitical Law. Goats in the NT, for our purposes today, are a symbol of oppressors and wicked men, and the wicked can be shown in many Scriptures as non-Israelites.



This idea of separating the races can also be found in Ezek 37:21-25, *“Behold, I will take the children of Israel from among the heathen, whither they be gone, and will gather them on every side, and bring them into their own land; And I will make them one nation in the land upon the mountains of Israel; and one king shall be king to them all... Neither shall they defile themselves any more with their idols, nor with their detestable things, nor with any of their transgressions: but I will save them out of all their dwellingplaces, wherein they have sinned, and will cleanse them: so shall they be My people, and I will be their God... and they all shall have one shepherd: they shall also walk in My judgments, and observe My statutes, and do*

them. And they shall dwell in the land that I have given unto Jacob My servant... and their children, and their children's children for ever."

Why left and right? Well, we get a little help from Eccl. 10:2, "*The heart of the wise inclines to the right, but the heart of the fool to the left.*" Politically, we see the leftists as dangerously anti-White and antithetical to Christianity. Republicans aren't much better than Democrats. Both are owned by jews, sucking on the AIPAC teet. Matt Bevin, who is a recent loser in the primary elections in Kentucky against incumbent Sen. Mitch McConnell, was lamenting his loss on the Glenn Beck program. Both of these turkeys are the epitome of "lukewarm" and for fear of the jews are too afraid or dumb to address the the race problem in America, which is not mildly percolating, it's boiling! The melting pot is killing us. The inmates are running the asylum in this worker's paradise of cultural Marxism. Mitch flaunted his race mixing on a campaign advertisement with his squat monster wife. Jesus is going to put her on the left. Christ will then state to those on the left, as confirmed in Mt. 25:41, "*Begone from Me, with the curse resting upon you, into the Fire of the Ages, which has been prepared for the devil and his messengers.*" The sheep are symbolic of those who follow and obey Jesus, while the goats represent those who do not follow Jesus and His witness. Remember, the unrepentant thief was hanging on the left side of the Cross at Calvary. The Son of Man, Jesus Himself, has the sole authority to divide the humanity of mongrelized societies from Adamic mankind; it is as racial as the two seedlines of 'us and them' in Gen. 3:15. There are no more than two categories: sheep and goats, right and left... period.

This particular judgment of the nations is distinct from the 'great white throne' judgment of individuals in Rev. 20:11-15. One overlooked fact concerning this judging is that Jesus considers one set of animals His i.e. "*as a shepherd divides His sheep*" Mt. 25:32, but the others He does not! He doesn't say, "His goats." He owns us: "*For ye are bought with a price; therefore glorify God in your body, and in your spirit, which are God's*" I Cor. 6:20. He is the true shepherd over those willing to follow Him and do what He says. He does not, however, claim ownership or responsibility over the goats! The goats are those who are rebellious and stubbornly refuse to follow anyone anywhere. Their ultimate fate is to be destroyed. We

might say they are freaks of nature, because God never created them.

The real point of the message, as you have likely guessed, is not only race, but the difference in behavior between the two groups. One group is merciful, kind, generous, loving and willing to do whatever it takes (even at their own expense) to help out other sheep in true need. Jesus told Peter, "*Feed My sheep.*" There was never an admonition to 'feed My goats.' Jesus regarded actions of the sheep as personally pleasing to Him. Because of their unselfishness and giving behavior they inherit God's Kingdom. The other group is selfish, self-centered, self-absorbed and self-seeking. They are rejected in the judgment. It's a division of racial types and every tribal nation in the world has their own moral barometer that is predestined. Some have a propensity for crime and warring, while others exhibit virtue and peace. In the countryside sheep and goats mingled during the day. At night they were often separated: sheep tolerate the cool air, but goats have to be herded together for warmth. The sheep are only judged on how they benevolently interact with each other. The sheep are not predestinated to interface with goats. "*They shall not dwell in thy land*" Ex.23:33. There is a judgment to come after the judgment of the goats, in which every Adamic man will receive his reward, meaning the cause and effect of his life.

Christ must come to undo the mess of man, for the wicked and the godly dwell together in the same cities, churches, schools and families. Jesus the Christ will distinguish between those that are His, and those that are not. The punishment of the wicked will be a permanent punishment; their state of affairs cannot be altered. Thus life and death, good and evil, the blessing and the curse, are set before us, that we may choose our way and as our way, so shall be our judgment. "*Thy kingdom come, thy will be done on earth, as it is in heaven.*" In other words, if Jesus is the Way, it's our way also.

His sheep are on His right side, which is a place of favor, respect and honor, a token of His affection for them; being that they are the elect of God and true believers, to whom is bestowed the grace of God, whom He, as the Good Shepherd, laid down His life for; and who hear His voice and follow Him in the righteous ways of His Law. We are comparable to sheep for their docile meekness and innocence, their simplicity and usefulness, their harmless and

inoffensive lives, and their conversations. White people say the darnedest things.

Goats convey the impression of worthlessness, a type of unruly, proud, slothful wickedness, who, because of the impurity of their blood, the filthiness of their hearts, and their offensiveness to Christ, He will place at His left hand, as a token of His disaffection for them, as a brand of disgrace, an intimation of dishonor and the state of heat they will soon find themselves in. These different situations plainly predestine how things will go with each; that one will be acquitted and made happy with eternal life, whereas the other will be condemned to the finality of death. So the saints of God, who are like sheep for their whiteness, gentleness, innocence, and feed in this world together with stinking and lascivious goats, the wicked of the world, compared to goats for their filthy habits by which they resemble them; yet on the day of judgment Christ shall separate them. The Bible is a far different world from that which the jews dream of, or the negroes "I have a dream' messiah.

Faith requires obedience, and in each age, the requirement is a little different. In Moses' day, the Israelites were required to enter Canaan. Their lack of faith was manifested by their lack of obedience. In David's day, the requirement was to remain loyal to David and not join Absalom's army or his support group. In Jesus' day, the people were required to be "good figs" and submit to the authority of the iron beast, following the example of the true Messiah. Once again, most refused to do so and usurped His throne instead. In our time, the requirement is to support Jesus Christ in His claim to the Birthright. This is the primary form of true obedience that is required at the present time, along with the issue of character. Likewise, in the Old Testament context, Israel was chosen to rule the nations. They were disqualified and failed, of course, because the nation as a whole did not manifest the lamb-like character of Christ. So in the New Testament we see Christ leveling the playing field, giving all White men the opportunity to be either lambs or goats, according to their character.

In yet another parable of frogs in my repertoire... a group of frogs were traveling through the woods and two of them fell into a deep pit. All of the frogs gathered around the pit peering down. When they saw how deep the pit was, they told the two frogs down there that they were as good as dead. The two frogs

ignored the comments and tried to jump out of the pit with all of their might. The other frogs kept telling them to stop, that they were as good as dead, they weren't going to make it. Finally, one of the frogs took heed to what the other frogs were saying and gave up. He fell down and died. The other frog, however, continued to jump as hard as he could. Once again, the crowd of frogs yelled at him to stop the pain an just die with dignity. He jumped even harder and finally made it out. When he got out, the other frogs said, "Didn't you hear us?" The frog explained to them that he was deaf. He thought they were encouraging him on for the duration of his quest for freedom. Do you think the other frogs looking down at their fellow frog had ulterior motives? We should keep in mind that Jesus Himself prophesied of His death at the hands of the priests, "*But when the vine-growers saw the Son, they said among themselves, This is the heir; come, let us kill him and seize His inheritance*" Mt. 21:38.

Sometimes it's a blessing to be deaf, not listening to those who would have you throw in the towel. The moral of this story is when the churches only hear themselves, they're not listening to the voice they belong to. Jesus said, "*My sheep hear My voice.*" We need to be deaf to anything that smacks of goat.

Christian character reflects the character of Christ, having the power of life and death in what we say. An encouraging word to someone who is down can lift him up and help him make it through the day. A destructive word to someone



who is down can be what it takes to kill them. Be careful what you say. Speak life to those who cross your path. The power of words are sometimes hard to understand, that an encouraging word can go such a long way. Anyone can speak words that tend to rob another of the spirit to continue in difficult times, or to even overcome adversity. You can do it my brethren. You can see what this message is saying even if it's the first time you've ever heard it. It's the truth that will make you free from the lies. Special is the person who will take the time to share revelation. Be special to one another, look for the God given character of our race, because we are lost sheep that need to be found and reintroduced to the Word of God. Don't cast your


pearls before goats or swine. *“For thou art an holy people unto the Lord thy God; The Lord thy God hath chosen thee to be a special people unto Himself, above all people that are upon the face of the earth”* Deut. 7:6. If we're above, that creates two levels.

I know there are some people in Christian Identity who are disappointed and are getting impatient with things not happening faster; with the vengeance of the Lord dispatching His and our enemies. But, what does tribulation worketh? *“Because of our faith, Christ has brought us into this place of undeserved privilege where we now stand, and we confidently and joyfully look forward to sharing God's glory. And not only this, but we glory [boast] in tribulations [afflictions] also: knowing that tribulation worketh patience; and patience produces proven character; and character produces hope”* Romans 5:2-4. This is a message of hope that the wicked will not escape God's wrath. There will be a Rapture... of the antichrists. And leading the charge against our Lord and Savior are the Christ-killer jews.

Here's the key to understand modern jewry: Jacob-Israel's brother Esau-Edom race mixed with the Canaanites, becoming a mongrel people known as Edomites; but during the warlike rule of the Maccabees (Hasmonean dynasty of the jews) they (Edom) were completely subdued and even forced to conform to jewish laws and rites and submit to their government.

The Edomites were then incorporated into the Judean society and known generically as jews (thanks to jews inventing this obfuscating word in the 1750's), and the whole province was often termed by Greek and Roman writers as 'Idumea'... from this time, the Edomites as a separate people, disappear from the pages of history; at the time of Christ, Herod the Great was of Edomite blood; but the Bible is not finished with them, to identify a future adversary of the White race, we have the book of Obadiah. The rabbinical authorities admit “Edom is in modern Jewry,” Jewish Encyclopedia, 1925 edition, Vol. 5, p. 41. Mt. Seir was the area in which Edomites lived prior to their conversion to judaism. Seir means “goat” and is therefore linked to the worship of “devils” that we read about in Lev. 17:7. The mongrel infusion into the sect of the Pharisees, which were predominantly 'bad fig' Judahites (also mongrelized from Babylon) was the perfect storm to kill Christ on the Cross and that His blood would be on their children to this very day;

leaving a history of satanic bloodlust and jewish ritual murder.



Baphomet (the deity of half man, half goat), the Goat of Mendes (Egyptian), the god of the witches, the mutation of the biblical scapegoat was the jewish way of mocking Christ as the “Lamb” who dies for the sins of Adamkind. Jesus Christ is the Lamb of God and performed the only pure and sin-free sacrifice for the redemption of Israel's sins; past, present and future. The goathead is the dark mockery of Jesus' role as the Lamb. It is the satanic jew's way of flipping the bird at the Cross. Freemasons readily admit that Baphomet is a pagan fertility god and confess that Masonry is a fertility cult religion. The association of the goat with Satan probably originated with a corruption of the Levitical traditions of the scapegoat. In ancient Israel the sins of the tribes were ceremonially loaded onto the head of a goat; this 'scapegoat' became the god Azazel, messenger of the lord, who took these sins away each Day of the Atonement. Seventh Day Adventist understand this symbolism, as the Azazel goat was traditionally understood by jews of antiquity and Christians of the Reformation, in the personified form of Satan. Since the second goat was sent away to perish, the word 'scapegoat' has evolved to mean a person who is blamed and punished for the sins of others. The horned god Azazel was considered a divine redeemer who took human sins upon itself and atoned for them by exile and/or death. This is in complete contradistinction to our Kinsman Redeemer, who gives us reconciliation through His unconditional sacrifice given to us free and exclusively. *“Herein is love, not that we loved God, but that He loved us, and sent His Son to be the propitiation for our sins”* I John 4:10. Here's the big question that will never be

allowed in churchianity: who was Christ sent to, in order to reconcile their sins? Mt. 15:24 gives us the answer from Jesus, *"I have not been sent except to the lost sheep of the house of Israel."* Are you beginning to see why the goats must not be joined together with the sheep on the right hand of Jesus, because their genetics will never be compatible with the will of God? We most certainly are accountable for the manner in which we live our lives.

But wait, there's more! Goats are capricious. They are impulsive and unpredictable, devious and contrary. Paul, speaking of the Jews in I Thes. 2:15, who killed both the Lord Jesus and the prophets, said, *"they please not God and are contrary to all men."* When goats are grazing, it is not unusual to see several with their heads through a fence, straining to reach the grass that is always greener on the other side! Folklore says that goats have slit eyes to enable them to see around corners where the grazing is better.



If they are not poking their heads through fences, they may be standing on their hind legs, stretching for those tender leaves just out of reach. Goats are never content with what they have. They are experts in opening gates and squeezing through small gaps because they hate to be confined. Fences that will handle sheep, cattle, and horses will not hold goats. They will work tirelessly to spring themselves from any situation they deem inhibiting. Consequently, goats are not very good followers.

"Gregarious behavior" is a term that refers to the

flocking or herding instinct which is found strongly in sheep, cattle, and horses. Again, this quality is rather weak in goats; they prefer leading or going off on their own. Meat packers use this instinct in sheep and goats to their advantage. They will train an old goat, appropriately called a "Judas," to lead sheep to the pens for slaughter. A well-trained Judas will lead group after group of sheep to the slaughter all day long. Consider that! Goats in a congregation tend to divide it, leading the sheep astray. By now, a goat's characteristics should be clear. This animal is not evil per se (they are intelligent, sensitive, playful, quick to respond to individual attention and affection), but some of their traits could be deadly, spiritually speaking, if found in a Christian. What would we call a Christian who is unpredictable? A goat! Or one who thinks he is above it all? A goat! Or one who independently does his own thing? A goat! What would we call a Christian who wants to take over, has trouble functioning in a group, and does not want to be led? A goat! A goat follows only its own lead, creating disunity when he comes in contact with others in the flock. Because of his independent nature, he often finds himself in contention with the Shepherd for leadership of the flock, leading some astray. A goat often eats things sheep would avoid because they have no value and cause sickness. These are serious spiritual characteristics and the malevolent impact it's had on the Christian character of the church is immeasurable. The analogy between sheep and goats is the perfect indicator to separate believers from unbelievers and Israel from non-Israel. The difference between the two is that sheep listen to the shepherd's voice and follow him everywhere he goes; the goats are more independent thus the illustration as to those who would be God's followers (sheep) and those who refuse to listen (goats).

By the time of Christ, the Temple ordinances of animal sacrifices had lost all meaning and were simply the traditions of man, which would become Judaism, which would become modern secular humanism, which Christ denounced in principle wherever it appeared. Jesus told these self-righteous Jews, *"Making the word of God of none effect through your tradition, which ye have delivered; and many such like things do ye"* Mark 7:13. The Book of Hebrews was written to present to us the better form of the Word of God. Changes were made, because creation outgrew the old forms and structures that had been suitable for an earlier time. But none of this nullified

the Word in any way, nor did these changes alter reality. In the first century, judaism had become hardened through the worship of structure and form, and thus, they denied the inalienable right of White men to change their viewpoints. If God had not taken the drastic step of hiring the Romans to destroy Jerusalem (Mt. 22:7), judaism might still be sacrificing lambs and goats and bulls today. In fact, many jews and even Christians today believe that God intends to revert to those old structures that He destroyed, in favor of the new way. Such is the strong delusion of ritual worship.

There is a strange doctrine being taught today by those who apparently do not believe that the book of Hebrews is the inspired Word of God. They teach that the order of Levi is going to be raised up in the Millennium (supplanting the order of Melchizedek) to minister as priests of God and of Christ. It is further taught that they will revert to the old sacrificial system of bulls, goats, and lambs, as if the Lamb of God, the sacrifice of Jesus was only temporary. It's a very big presumption that they are descended from the Levitical priests of the Old Testament. Bible teachers often take these passages too literally, thinking that God is going to set up another temple in Jerusalem on the temple mount, complete with jewish Levites and animal sacrifices. They say that the Age of Grace is soon completed, and then we are all going back under animal sacrifices once again. This is nothing short of utter blasphemy. It is as if they never read the book of Hebrews. The blood of bulls and goats can never remove sin. "*We are not of those who shrink back to destruction*" Heb. 10:39.

The core message of the Sheep and Goats is that God's people will love other races, whom they should hate or be in opposition to. The Law of God has not changed: "*They shall not dwell in thy land*" Ex. 23:33. Good works will only result in our relationship with the Shepherd. Followers of the jewish Jesus will treat the non-White strangers, the "illegal aliens" with kindness coupled with obeisance, serving them as if they were serving Christ Himself. But the unregenerate live in a degenerate lifestyle. We have no communion with them. While goats can indeed perform acts of charity, random acts of kindness are not endemic to their race; their hearts are not right with God and their actions are not for the right purpose, to honor and glorify God. Their big shot philanthropists funnel their exorbitant wealth into the vaults of tax-free foundations, never

having to pay taxes like the middle class. Isn't Bill Gates such a wonderful guy spending millions of dollars for negro education, putting computers in inner city classrooms, so they can play video games? Or vaccinating the continent of Africa?

The goats on Jesus' left are cursed, and the reason given is that they had the opportunity to minister unto the Lord, but they did nothing. "*For I was hungry and you gave Me nothing to eat; I was thirsty and you gave Me nothing to drink; I was a visitor and you didn't take Me in; I was naked and you didn't clothe Me, sick and in prison and you didn't visit Me*" Mt. 25:42-43. We find the same theme of today's message in Psalms 118:10-11, "*All the nations surrounded Me, but in the name [authority] of the Lord I will destroy them. Yes, they surrounded and attacked me, but I destroyed them all with the authority of the Lord.*" The repetition here implies that they are like mad bees (v.12) swarming in fervent frequency, having an arrogance of succeeding. We must understand that, "*The kingdom of heaven suffers violence, and violent men take it by force*" Mt. 11:12. That has been the sordid history of the RCC and jewish penetration of seminaries for the last 2000 years. God does not change in His prophetic promises, "*My dear friends, do not avenge yourselves, but leave room for God's wrath, for it is written, Vengeance is mine; I will repay, saith the Lord*" Romans 12:19. Prophecy is a guarantee that God's predictive capacity never fails. "*Their day of disaster will arrive, and their destiny will overtake them*" Deut 32:35.

Obadiah is a book dedicated to the White race when Israel is in her final downtrodden defeat, in captivity and poverty, and being delivered from the last beast empire, Mystery Babylon, a religious-economic crime syndicate of jews, catholics and universalists. Verse 15 specifically bears the most profound event in the history of mankind, 'the Day of the Lord' i.e. 'the Second Coming' of Jesus Christ. It precedes the outwardly hopeless condition of spiritual slavery to the world as we witness it today. The field is ready for harvest. The hope for that better day rests on the prophet's belief that there is no escape from judgment for the perpetrators, Edom and all who fall under it's umbrella... in one word, goats. Obadiah is a firm advocate of the idea of the vindication of the Lord and of His promises to his people as the principle of justice is applied in the society of nations. And justice does not conflict with love; it is love's vindication on a

national and social level. You can read the whole book for yourself; it's one of the shortest books in the Bible comprising only 21 verses. But, what I want to emphasize today is the confirmation of Mt. 25:33 and 41, that all nations, not just Edom, will be identified and set apart for the fires of destruction.



Thus we begin reading verse 15, *“For the day of the Lord is near upon the heathen [godless nations], as you have done to Israel, it shall be done to you; you will get exactly what your deeds deserve. Just as you swallowed up My people on My holy mountain, so you and the surrounding nations will swallow the punishment I pour out on you. Yes, all you nations will drink and stagger and become as if they had never existed. But there will be a deliverance on Mount Zion, and there shall be holiness [racial purity]; the house of Jacob will dispossess those who dispossessed them. And the house of Jacob shall be a fire, and the house of Joseph a flame, and the house of Esau for stubble, And they will set them on fire and consume them, So that there will be no survivor of the house of Esau,“ For the Lord has spoken it”* Obadiah 1:15-18.

There will be no Jewish survivors or any other non-White nationalities if you believe this prophecy, which dovetails with a myriad of other supporting Scriptures. It also confirms the identity of the pyro-technicians, which Mt. 13 calls “angels” and “reapers,” as Jacob (Judah) and Joseph (Ephraim and Manasseh), the two houses of Israel reunited in restoration on the right side of Christ.

It's the bread and butter of Ken Ham and the not so good 'Answers In Genesis' corporation. Don't let them look down on you with a free pass to hell. Come out of that deep pit that traps the souls of men; arise and thresh ye men of Israel; shake off thy sorrow and fear and despair.” Israel shall crush all the nations that rise up against her. Thus, the spiritual men of Israel, purified by suffering, and redeemed, shall consecrate to the Lord the power of the world; and all the wealth and might of the earth shall be subservient to the glory of the Kingdom of God.

The Nasty Side of Organ Transplantation

Body Parts and Business *Chapter 12*

Norm Barber

Organ transplant interests complain that vital organ donations haven't risen for the past ten years. This is true. Prospective customers aren't shooting or knifing each other as frequently as in the good old days. Car seat belts and breath testing have dented the flow of brain-injured candidates. Better neurosurgery for stroke victims is reducing another source of donors.

The Hidden Industry

But there is a hidden industry for which statistics aren't publicly presented and to which donation agencies feign ignorance. The reader might test their local organ donation centre on this issue. There is a huge worldwide market for completely dead donors whose hearts and everything else has stopped. They are really dead. Their vital organs are rarely used due to decomposition and damage during the dying process. Yet these cold bodies still provide raw material for surgical activities ranging from heart valve replacements to cosmetic surgery.

The American dead body processing industry is far more advanced than the Australian but demand for our cosmetic and surgical techniques is on par with the Americans. Our industry is fed with imported body products salvaged from American bodies. Our demand for cadaver products encourages Americans to aggressively harvest their own citizens. Australians are indirectly responsible for this strange American activity.

Compulsory Harvest Requests

In 1998 Clinton Administration legislation forced United States hospitals that receive Medicare payments to pressure relatives of the deceased to sign voluntary donation consent forms. This increased cardiac dead harvesting in the United States 172% over five years to 20,000 bodies annually or three and a half times the number of vital organ donors.

Worth More Dead than Alive

This isn't a joke. A single donor body can provide the raw material to generate products selling for US\$220,000 wholesale. When adding surgical fitting costs it can reach one million dollars. If the donor also supplied vital organs the amount generated by one body is two million dollars. Most of us are worth more dead than alive. More than a herd of cattle or fifty-thousand chickens. Our dead bodies are a market commodity and a factor motivating transplant coordinators to pressure relatives to release their next of kin for harvesting. A hungry market raises prices so the body parts industry aggressively lobbies governments, manipulates public opinion and funds donor promotion registries.

Shortage of Cadaver Skin for Burns but Plenty for Cosmetic Surgery

When a person is burnt from exploding fuel in a car smash, or a pan of oil slips off the stove onto their leg then the skin is destroyed leaving exposed flesh vulnerable to infection. Cadaver skin placed over the wound protects the body and facilitates the replacement of the patient's own skin. Harvested skin

is also used to cover holes left by tumours and make internal slings to support bladders of those with urinary incontinence thus alleviating the need for adult nappies. More skin comes from the obese and less from midgets and thin people though on average skin from one donor fetches \$3600 when used to treat burns victims. Twenty thousand cardiac dead donors annually in the United States would provide more than adequate quantities of skin for medical purposes, but there is a continuous shortage because of corruption. Non-profit body donation Foundations receive the bodies for free then pass them on at a token price to cosmetic companies who set up the Foundations in the first instance. The processed skin from one body, worth \$3600 when used for burns victims, is instead transformed into cosmetic surgery products which sell for \$36,000 wholesale. This business practice means that burns victims don't get the cadaver skin. Instead, surgeons strip skin from the burns patients' living relatives who, despite full anaesthetic, say it is the most painful experience they've had.

Thick Penis Treatment

LifeCell Corporation uses donated cadaver skin to produce Alloderm, a plastic surgery product used to reconstruct eyelids for older women who want to look younger and sexier. Other uses include reducing or enlarging breast size and thickening penises. Have you ever wondered how movie stars or aging TV newsreaders have so few wrinkles or the women display such big pouting lips? Collagenesis, Incorporated of Massachusetts, uses cadaver skin to make an injectable gel called Dermalogen. Cosmetic surgeons will, for \$1000 a shot, inject Dermalogen to fatten lips or reduce wrinkles and laugh lines by puffing up the skin. The benefit of Dermalogen is that the body doesn't break it down so repair jobs are less frequently needed. The drawback with this injected cadaver skin is its permanent nature. Ghastly mistakes are hard to fix as evidenced by a number of freaky-looking TV personalities whose faces look like clown masks.

Alloderm and Dermalogen compete with similar products cultured from the bugs living in the fluid of arthritis sufferers' swollen joints. The —stuff is injected into the face puffing it up like arthritic fingers thus taking away the wrinkles. The body absorbs the —stuff and the expensive injections must be repeated every six to twelve months. Similarly, cowhides are

made into a collagen and pumped into wrinkly faces. Allergen makes Botox, another wrinkle reducer, from botulinum toxin A, which is related to botulism. It paralyzes facial muscles to stop those natural facial movements that cause wrinkles.

Have you ever admired the thighs of scantily clad movie stars? Fascia Biosystems of Beverly Hills, California sell a trademark thigh tissue to cosmetic surgeons. Fascia lata is the connective tissue holding thigh muscles together. Fascia is transplanted from the corpse to movie stars, which may explain those incredibly firm and tight bodies.

Football and sports heroes don't miss out on the cannibal trade. Ten of a corpse's tendons bring \$20,000 (the Achilles and patella come with bone still attached). Knee cartilage is worth \$14,000. When an Australian Football League player breaks a tendon or wrecks a knee he is off to the morgue for spare parts. A humerus fetches \$28,000. Need a varicose vein job? Saphenous and Femoral veins are used for varicose vein and blood vessel reconstruction and sell for \$14,000. Corneas, the clear part of the eye that covers the coloured part, fetch \$2400 a pair. Heart valves are \$7000 each from a heart costing Cryolife or other valve collectors less than \$1000 from the non-profit Foundation, which they have usually set up as a front to obtain cheap or free corpses.

Bones and the Ladies Powder Room

We may think the blood and bone people dealing in human body parts are from a Jeffrey Dahmer style murder trial, but it is technology and market demand that has created the impetus for this industry. The market is hungry for body pieces so the industry relentlessly pressures governments for increased access to corpses. They'll hire slick advertising people to portray this form of cannibalism in the most heart-warming manner making people feel greedy if they don't give the sometimes still warm bodies of their deceased next of kin to the harvesters.

The human body has 206 separate bones most of which will fetch a reasonable price, but it is the processing and transplanting stage where the biggest profits are made. Bones are deep-frozen or freeze dried at 92 degrees below zero Fahrenheit (<71C), which ensures a five-year Use-By period. The first stages of bone processing are so simple that some

American doctors have taken cadavers home and removed the bones in their garages. Bones are later irradiated to minimise rejection and increase storage times. They're often stored for six-months to allow time to perform disease checks. Living donors via amputations and hip replacement surgery are observed for this period to see they fall ill from certain infectious diseases. If they're still okay after six months the bones are used. When you consider the diseases that may be transmitted by the natural procreative sexual act then incorporating another person's body part inside oneself permanently is like opening a floodgate to new infection possibilities. Donors may have been unaware they carried the Hepatitis virus; Creutzfeldt- Jakob prions, (similar to Mad Cow Disease); the Epstein-Barr virus that causes glandular fever; HIV-AIDS; cancer; you name it. Young donors with strong vibrant bones fetch high prices while the porous bones of older woman are ground up for dental dust, which gives a new twist to the term "ladies powder room". Harvesters want every human bone, which indicates the challenge to morticians at open casket funerals and the delight of plastic medical pipe suppliers.

Dental Dust and Bone Putty

Carpentry shops cut and grind human bones into specially manufactured parts for hospital and dental surgeries. These include bone chips (looking like grated parmesan cheese), screws made from bones, wedges, spears, blocks and a large range of custom made parts used to reconstruct, patch or replace the effects of injuries and illness suffered by living humans. Bones are also made into bone putty. Osteotech, Inc makes a bone putty costing US\$853 for two teaspoons that is used to patch up bone cracks in living humans. Larger cracks are mended using a chip and putty blend. Crushed bones help fuse together ceramic and bone during hip replacement surgery.

Regeneration Technologies, Inc (RTI) in Florida also manufactures a bone putty called Regenafil. It's also made from human bones mixed with a gelatin-carrier base sourced from pigs. And they do a roaring business processing up to 4000 bodies a year using

similar cutting machines that Boeing and Lockheed Martin use to cut aluminum. RTI doesn't offer factory tours for school classes.

Demineralised human bone is ground into "dental dust" and used to improve healing after tooth extractions, spinal fusions and minor surgery. Like bone putty this "dust" is made by removing the 70% mineral content from bone leaving the 12 morphogenic collagen and non-collagenous proteins. Dentists spray this "dust" onto healthy exposed bone after grinding out rotting teeth and jawbone. This speeds up healing. It also helps fuse bones together when transplanting bone material from a corpse to a living patient. It also fuses worn vertebrae and other joint bones to stop movement and associated pain. Dental dust's popularity hasn't suffered despite a problem with the transferal of HIV-AIDS, a problem reportedly solved.



Business Links to Non-profit Foundations and Government Enterprises

One might wonder where business, donation agencies and hospitals merge in this creeping neo-cannibalism. Government hospitals are often reluctant players. Most doctors and nurses are dedicated to the Hippocratic ideal not to harm patients yet the act of cutting out a healthy (and it must be healthy) beating heart from an injured patient isn't exactly First Aid. Some wish organ harvesting hadn't been developed. Hospital staff usually avoid the skin and bone

harvesting that is done by a less skilled team from a euphemistically entitled Tissue Bank. Compared to vital organ harvesting their work resembles a butchering job and is usually performed at the Tissue Bank.

American Tissue Banks operate like the non-profit Musculoskeletal Transplant Foundation. It's the largest body procurer in the U.S.A., theoretically operating as a benevolent society but actually a front organisation specifically set-up in 1987 by Osteotech, Incorporated. The Foundation obtains bodies free of charge then transfers them to Osteotech for tiny prices that then process each body into hundreds of thousands of

dollars worth of products. The Musculoskeletal Transplant Foundation produces a catalogue listing 650 body parts products for sale. They aren't alone because virtually every American body procuring benevolent foundation is a secret agent for a private company.

Australians use more subterfuge and hide their body parts businesses within government science and educational institutions. The Donor Tissue Bank of Victoria discreetly operates as a business within Monash University and the New South Wales Bone Bank hides out at St George Hospital in Kogarah. An Australian characteristic is using the guise of medical post-mortems to remove body parts unlike the American model where relatives are directly approached to donate the body.

Australian harvesting for non-vital body components is bureaucratically cumbersome. There are strict disease controls that slow down the procurement of body parts and these are used by dissidents within the medical profession and government.

The South Australian Tissue Bank operates under cover of the Institute of Medical and Veterinary Science in Adelaide. It's amongst a cluster of buildings that includes the Royal Adelaide Hospital. One employee told me that harvesting was limited because bureaucrat impediments slow down the bodies passing through each level of hospital bureaucracy on their way to the harvest room. A single delay may push the body beyond the 24-hour harvest window after death.

Disease fears are another factor and one freezer contains bones rejected due to respiratory flora contamination: someone breathed on them. "In the fridge behind the wall," my informant advised me. These impediments insured that just four bodies were harvested for bones in the first eight months of 2006 and just one in 2005. This is from a population of 1.5 million people with almost half registered as organ donors and from which two dozen "brain dead" donors are harvested annually. Consequently, there are "more requests [for bones] than donations" so bones are obtained via amputations and hip replacement surgery. The New South Wales State government in Australia had this same problem so they adopted the American model. Special legislation allows non-doctors from the government-owned New South Wales Bone Bank to

harvest bones from bodies supplied by the Glebe Institute of Forensic Medicine, also known as the Sydney City Morgue.

The Bone Bank sends these bones in cooler boxes to the commercial outfit, Australian BioTechnologies, which operates out of the northern Sydney suburb of Frenchs Forest. They grind these bones into shapes for transplanting and process the shavings into bone putty then sell these products back to the New South Wales Bone Bank. This bypasses the medical establishment, which can no longer obstruct "progress".

Our predicament is that we have a medical industry on which over 500 surgical procedures depend on human body products. National governments fund this medical industry and while this continues our wellbeing will remain dependent on a form of cannibalism that we euphemistically call — body parts recycling or the — gift of life. It isn't pretty and some say it isn't a particularly efficient system of maintaining health.

Aaron Vowles was twelve-years old in 1994 when he and his brother were emptying a compressed gas cylinder one evening in their Adelaide backyard. A gentle wind pushed the gas cloud into the pilot light of an outdoor water heater. The fireball melted Aaron's nylon tracksuit burning sixty-four percent of his skin which turned black and fell off. Doctors put Aaron into an induced coma but he still suffered a cardiac arrest.

Aaron needed cadaver skin to cover his burnt body and protect him against infection until his own body rebuilt skin cover. There wasn't any skin available despite South Australia's aggressive harvesting program of "brain-dead" organ donors. Aaron's brother, Damon, and their father entered hospital to have skin stripped from their bodies. Damon told me it was the most painful experience he'd ever had and all the anaesthetic and other painkillers didn't work.

Dear Mr Finck,

I have read your essay *Classical Records of the Dorian & Danaan Israelite-Greeks*. I happened to read a book of Greek history on the subject of Greek festivals in Ancient Sparta. One was called Karneia (Karnia) it is said that it came from the word Karno which meant in the Doric dialect *ram*. I've checked the word carno (karno) and found one city in Wales and one city in the Biblical area that is called Carnaim and which is called Carno by Ptolemy and Strabo. It is probably related to Genesis 14:5 to a city called Ashteroth Karnaim.

I would appreciate your take on this.

Hello, Peter,
Of course I had not heard this before, so far as I can remember, and thank you for your observation. Being certain of the origins of much of Greek culture, it certainly does not surprise me that there would be a connection.

Karnaim (in the King James Version) is a dual form (plural of two, and some early Greek nouns also had such a form), and it comes from a Hebrew word which means *horn*. So I can see where that may well be related to the idea of a *ram*, having *two horns*. Karnaim appears in the Scriptures only in Genesis 14:5, and it is Strong's Hebrew lexicon # 6255.

The Karneia festival was held in honor of Apollo, and Apollo was seen as the patron/protector of shepherds and herds. According to the 9th edition of Liddell & Scott *karnos* is ram, and *karnon* is a horn, so I would be confident to say that the word is definitely a cognate with the aforementioned Hebrew word.

As for the Welsh, connection, Liddell & Scott also cite a Celtic word, *karnux*, which appeared in certain Greek writings and which they say is equivalent to *karnon*! That is truly interesting.

These examples of natural pain relievers are meant to affect acute inflammation. Chronic inflammation should be explored further to discover the cause rather than simply treating the symptoms

Herbs and Homeopathic Remedies

Turmeric (Curcumin)

Turmeric is a spice and the active anti-inflammatory ingredient in turmeric is curcumin. Turmeric is a yellow/ orange spice and used a lot in Asian cooking. Curcumin is shown in many research studies to help with pain of osteoarthritis as well as by affecting many different inflammatory modulators. It can be used after a fall, sprained joint, or any other area of pain. Curcumin relieves inflammation, pain and heat. It can actually inhibit the COX-2 enzyme. That's the same thing that an NSAID does, but without any specificity to the type of COX enzyme and type of inflammation. Turmeric is specific to being a COX-2 inhibitor and can be used safely for pain reduction.

Turmeric can be taken internally for pain relief. My favorite uses are to grind fresh turmeric and add it to green tea or a green juice. You can also mix equal parts turmeric (made into a paste) and coconut oil and take it on a spoonful as a supplement. Do not rub the turmeric paste on the skin simply because turmeric will stain anything it touches. You can also juice turmeric or add it to one of your green smoothies. Once again, watch out for the staining yellow/ orange color. You can also purchase curcumin or turmeric in capsule form and take it easily in that form too.

Arnica

Arnica is a flowering plant that looks similar to a small sunflower and has yellow petals. The roots and flowers are used to make arnica products. If you know anything about arnica you know that it comes in many forms. The most common use of arnica is in a homeopathic remedy. Arnica comes in homeopathic gels, creams, pellets and tinctures. I have know many people who use arnica cream or take the pellets and have more significant pain relief than from taking an NSAID. Arnica can also be found as an oil and can be used in homemade pain relieving creams.

Arnica can be used for muscle pain, cramps, joint pain and has also been shown to be successful in relieving pain from osteoarthritis. For kids, arnica can work well to relieve growing pains. Arnica is very powerful and can have side effects if not used properly. If taking internally only use the homeopathic versions. The arnica oil is for external use only and can be put on the skin safely in a cream or salve.

Traumeel

Traumeel is a homeopathic blend of 12 different ingredients and is best used in joint pain and muscle pain. Traumeel comes in many forms. Traumeel ointment is great for massaging purposes. We use the ointment at our chiropractic office if we are going to do muscle work. We also use essential oils with the

Traumeel. Traumeel gel is great for athletes and individuals who are physically active, as also Traumeel oral drops. Traumeel tablets offer quick pain relief.

Magnesium

Magnesium is a mineral that is involved in a multitude of our cellular functions. One thing it does is modulate the inflammatory response. It is said that much of us are magnesium deficient. Magnesium deficiencies can actually feed the fire of inflammation and pain and without enough magnesium you can't put that fire out as easily. Magnesium helps in calming down the inflammatory response...

My favorite way to absorb magnesium is through an Epsom Salt Bath. Also known as a detox bath or magnesium bath. Fill the tub up with hot water, or as hot as you can handle it. If the bath is for a child, the temperature will be warm. For children use 1 cup of Epsom salts per bath and for adults use 2 cups of Epsom salts per bath. Stay in the bath for 20 minutes to fully absorb the magnesium.

You can also obtain sufficient magnesium from magnesium oil. It is called an "oil" because when you spray it on your skin it will feel oily, but the oil actually only contains magnesium chloride and water. For children, spray each arm and leg with 3 sprays (12 sprays total). For adults, double the children's dose using 6 sprays on each arm and leg (24 sprays total). Allow the magnesium oil sit on your skin until it starts to look white and feel almost like salt on your skin. You may wash it off with a washcloth, apply lotion or just leave it. If the magnesium oil starts to tingle, rub a little lotion or coconut oil on your skin and that should take care of the tingling.

Essential Oils

When using essential oils I recommend using an essential oil brand that is therapeutic and 100% pure. Oils that are not 100% pure CANNOT be taken internally and are known to have questionable fillers in them. Purchase the higher quality essential oil. I personally use/distribute [Young Living Essential Oils](#).

Copaiba

Copaiba is one of my favorite anti-inflammatory oils and happens to be one of the best oils for inflammation. It comes from the oleoresin of the

copaiba tree, which is a similar process to tapping a tree for maple syrup. It contains a lot of beta-caryophyllene which will decrease the inflammatory process.

I use copaiba for mouth and gum pain. For a teething child put one or two drops on your finger and rub in their gums. Also mix one drop of copaiba and one drop of clove or cinnamon Bark and do the same. It both numbs the area and relieves the inflammation. For muscle and joint pain use 1-3 drops of copaiba and rub over the painful or inflamed area. Often times I mix copaiba with some of the oils below for more relief.



Other Essential Oils for pain relief

Some of my other favorite essential oils for pain are Peppermint, Lavender, Balsam Fir, Wintergreen, Cinnamon Oil, Clove Oil. There's no magic blend of oils for pain relief because each oil works differently for each injury and for each person. Experiment trying different types of oils and blending them together. When you find the oils that work best for you, you will feel it. Or maybe I should say you will feel relief. I recommend applying the oils 2-5x per day over the area of pain. I personally love the combination of peppermint, lavender and cinnamon when I experience aches and pains or menstrual cramps. If the oil burns when you apply it to the skin you will need a carrier oil. A carrier oil dilutes the essential oil and my

personal favorite carrier oil is coconut oil. If putting an essential oil on a child, make sure to read the label on how to use it and always use a carrier oil. I recommend rubbing one drop of oil mixed into coconut oil into the bottoms of their feet 2-3x per day. The bottoms of the feet have large pores and the oils will be taken into their body and cells within seconds of applying the oil.

Foods Reducing (or Eliminating) Sugars and Grains


We have a saying at our chiropractic office: “Sugar and grain cause pain”. I have seen it time and time again. We always have the most people in pain around the holidays (can you say sugar rush!!). Another thing I commonly see in today’s high grain/sugar consumption is people who are so inflamed they are not responding well to their chiropractic adjustment. Those people need an anti-inflammatory diet to see changes. Our food choices are very powerful for building health or building symptoms! This applies to both adults and children. So many people think just because their child doesn’t have pain or are not overweight means they don’t have to watch their diet. Reducing inflammation is crucial in little bodies too!

Listen to your body! Each person has a different inflammatory response and sensitivity to sugars and grains

Increasing healthy fats and Omega-3 fatty acids

Another way to counteract inflammation via diet is to increase your intake of healthy fats. The macronutrient that should be the highest in our diet is fats. Our brains are 60% fat, our nerves and nervous system is coated in fat and our cell membranes (all 10 trillion of them) have two layers of fat. One property in body that is healing at the highest level is a healthy level of dietary fat. But there is a difference between a good-fat and a bad-fat.

Good Fats to Increase are: Coconut Oil, Butter, Olive Oil, Grapeseed Oil, Animal fats, Nuts/ Seeds, Nut and seed butter, Free-range eggs, Grass-fed beef, Free-range chicken and turkey and Avocados, whole-milk grass-fed raw dairy products, Coconut products (coconut milk, shredded coconut, coconut butter,



Chiropractic Care

I am a chiropractor. Misalignments of the spine, called subluxations, create pain by inflaming the area around the nerve, causing heat. Coconut oil is unique in that it is about 50% lauric acid, a medium chained triglyceride that is otherwise very hard to find in our diets (palm kernel oil is also about 50% lauric acid).

Interestingly, lauric acid makes up about 2% of the fat in cow's milk but 6% of the fat in human milk, implying that humans may have a naturally higher need for this fatty acid.

These studies don't necessarily mean coconut is the panacea of cancer what it means is that nature has provided many natural ways to combat disease and the more research we can do and the more information we can share with others gives us opportunities to possibly find cures and preventive measures using Mother Nature instead of simply putting our faith in the medical communities singular approach to disease.
