Christian Socialism

The word *socialism* is a dirty word in many Christian Nationalist and other so-called conservative or right-wing circles today. There are two reasons for that. First, for over a hundred years and until this very day the word has been used as a euphemism for Marxism and for Bolshevik Communism – if the two may be distinguished because the practice was even much more sinister than the theory. This use of *socialism* as a euphemism for Marxism and Communism seems to have been preponderated by the Jewish media, in order to conceal the true nature of these Jewish ideologies. However the word *socialism* and the original ideas that it once represented are much older than Marxism, and bear little real resemblance to it. Secondly, many Christian Nationalists are still locked into the Jewish *Capitalist-vs-Communist* dichotomy and have trouble thinking on any other terms. So long as they stay there, they will never be a threat to the intentions of the Jew since both modern Capitalism and modern Communism are inventions of the Jew. The Capitalist system has enabled World Jewry to slowly feed off of the labor and resources of the nations which admit it, while the Communist system has enabled World Jewry to rapidly subsume the resources and the lifeblood of those nations which become its victims. The Capitalist system is designed to infiltrate, corrupt and control nations with pliant rulers or other malleable systems such as parliamentary democracies, and the Communist system has seized power violently wherever firm rulers do not allow the Capitalist system to gain control. It is Capitalists, the international Jewish bankers, who have financed Communism wherever it has appeared, as retribution against nations wherever the rule of those bankers is rejected. When either system fails to seize a nation, then the international Jew wages war against it from the outside through those nations which he does control. Such was the case in Europe in the Second World War.

From the ashes of the old feudal system which the French Revolution destroyed for good arose many theories of political and economic organization among thinking men, most of whom were schooled in the philosophers of the Enlightenment. One such theory was national socialism, which was actually postulated by French philosophers a century before Adolf Hitler put such a theory into practice in Germany. Marx did not create socialism. Rather, he pilfered it, and used the label as a euphemism for his Talmudic perversion. Other systems, such as syndicalism and fascism, were based upon this original socialism in one degree or another. Yet Christian Nationalists, primarily because of the way in which the Jewish theorists and their media have poisoned the term, and also because of their own entrapment in the Jewish *Capitalist-vs-Communist* dichotomy, have also failed to notice that as it was originally conceived socialism had Christian foundations. Furthermore, National Socialism as it was implemented by Adolf Hitler's Germany was based entirely upon Christian principles, and it is absolutely contrary to Marxism. So long as Christians remain inside the box which the Jewish political theorists have constructed for them, they will forever remain blind and obedient slaves to the world's foremost usurers and pillagers.

The following passages from the Book of Acts demonstrate Christian *community*, from the King James Version:

Acts 2:42-47: “42 And they continued stedfastly in the apostles' doctrine and fellowship, and in breaking of

bread, and in prayers. 43 And fear came upon every soul: and many wonders and signs were done by the apostles. 44 And all that believed were together, and had all things common; 45 And sold their possessions and goods, and parted them to all men, as every man had need. 46 And they, continuing daily with one accord in the temple, and breaking bread from house to house, did eat their meat with gladness and singleness of heart, 47 Praising God, and having favour with all the people. And the Lord added to the church daily such as should be saved.”

Acts 4:32-37: “32 And the multitude of them that believed were of one heart and of one soul: neither said any of them that ought of the things which he possessed was his own; but they had all things common. 33 And with great power gave the apostles witness of the resurrection of the Lord Jesus: and great grace was upon them all. 34 Neither was there any among them that lacked: for as many as were possessors of lands or houses sold them, and brought the prices of the things that were sold, 35 And laid them down at the apostles' feet: and distribution was made unto every man according as he had need. 36 And Joses, who by the apostles was surnamed Barnabas, (which is, being interpreted, The son of consolation,) a Levite, and of the country of Cyprus, 37 Having land, sold it, and brought the money, and laid it at the apostles' feet.”

Here the example of true Christian communion is given, to which must be compared Josephus' account of nearly identical practices among the Essenes, found in his *Wars of the Judaeans*, 2.8.2-3 (2:119-122).

Josephus, *Wars of the Judaeans*, 2:122: “These men [the Essenes] are despisers of riches, and so very communicative as raises our admiration. Nor is there anyone to be found among them who has more than another; for it is a law among them, that those who come to them must let what they have be common to the whole order,--insomuch that among them all there is no appearance of poverty or excess of riches, but everyone's possessions are intermingled with everyone's possessions; and so there is, as it were, one patrimony among all the brethren.”

Aside from being socialist, Christianity is also nationalist - as we discussed here in the [June, 2012 Saxon Messenger editorial](#) of a similar title. That it is indeed nationalist can be demonstrated where fornication, of which race-mixing is one form, is forbidden Christians in Acts Chapter 15. That race-mixing is a form of fornication is readily demonstrated from Jude 7 and from 1 Corinthians chapter 10 where Paul explicitly warns against it and references a race-mixing event from the Old Testament in order to substantiate his warning. Christianity must be nationalist, since Christ professed coming “but unto the lost sheep of the house of Israel” (Matthew 15:24) and since, as Paul explains in Romans chapter 4, the nations of the promise are only those nations which sprang from the seed of Abraham, which he identifies throughout his epistles. If Christianity is nationalist, then Christian community must also be nationalist. The Essenes, as Josephus attests elsewhere, were also nationalists. While the sects of the Pharisees and Sadducees sought proselytes, the Essenes were the only Judaeen sect which required its members to be Judaeen *by birth*, where the Greek word *genos* means ethnic birth and not geographical birth. The translator, William Whiston, would have done better to write “Judaeans by race”.

Christians are told to reject those who have rejected Christ, and therefore neither should Christian community nor Christian fellowship be extended to non-Christians. From the epistles of John, where the apostle was speaking in the context of the Roman world of his time:

2 John 9-11: “ 9 Whosoever transgresseth, and abideth not in the doctrine of Christ, hath not God. He that abideth in the doctrine of Christ, he hath both the Father and the Son. 10 If there come any unto you, and bring not this doctrine, receive him not into your house, neither bid him God speed: 11 For he that biddeth him God speed is partaker of his evil deeds.”

The word *common* as it appears above in Acts 2:44, and at 4:32, is from the Greek word *koinos*, which is “*common, shared in common*, opposed to *idios ...common to or with another...common to all the people, public, general...*” (Liddell & Scott). This word *koinos* is related to the word which was translated as *fellowship* at Acts 2:42, which is *koinonia*, “*communion, association, partnership, fellowship*” (ibid). The Roman church has distorted the meaning of the word *communion* in the minds of many people by using it to denote their

mystery ritual. The word does not describe any ritual in the New Testament, but rather intends, as its primary dictionary definition states, "The act or an instance of sharing...", according to *The American Heritage College Dictionary, communion*, 1. The word *koinonia* is found 19 times in the New Testament, and in the King James Version it is translated as *communion* four of those times. The true mystery of communion is not possessed by the Roman church nor any other: the true mystery is why so few realize that the body and blood of Christ are actually those Israelites sitting around the table! See, for instance, I Corinthians 10:16-17 and 12:12. The word *communion* is related to the words *common*, *community*, and *communism*. From this basic idea of Christian communion sprang those states which are designated by the term *commonwealth*.

1 Corinthians 10:16-17: "16 The cup of eulogy which we bless, is it not fellowship of the blood of Christ? The wheat-bread which we break, is it not fellowship of the body of Christ? 17 Because one loaf, one body, we the many are, for we all partake from the one loaf."

1 Corinthians 12:12: "12 For just as the body is one and has many members, and all the members of the body, being many, are one body, so also the Anointed."

The Old Testament example of the commonwealth is found in the story of the Exodus at the collection of the manna in the wilderness. From the King James Version:

Exodus 16:16-18: "16 This is the thing which the LORD hath commanded, Gather of it every man according to his eating, an omer for every man, according to the number of your persons; take ye every man for them which are in his tents. 17 And the children of Israel did so, and gathered, some more, some less. 18 And when they did mete it with an omer, he that gathered much had nothing over, and he that gathered little had no lack; they gathered every man according to his eating."

Christianity is nationalism, and Christianity is socialism. However when it is properly defined, socialism is a care for and a tending to the needs of one's own national community. As it was in the Exodus, although some clearly had the ability to gather more than others, yet everyone was assured enough to eat. The needs of the Christian community outweigh the needs of the individual member. Thus is the Christian Commonwealth. Yet the wealth of the Christian community is not for aliens. Rather, it was considered a curse if an alien ate of those blessings bestowed by God upon the children of Israel. Thus we read in Ecclesiastes chapter 6: "A man to whom God hath given riches, wealth, and honour, so that he wanteth nothing for his soul of all that he desireth, yet God giveth him not power to eat thereof, but a stranger eateth it: this is vanity, and it is an evil disease." It was also considered evil to accommodate the sinful. From the Wisdom of Sirach, chapter 12: "6 For the most High hateth sinners, and will repay vengeance unto the ungodly, and keepeth them against the mighty day of their punishment. 7 Give unto the good, and help not the sinner." For that same reason the apostle Paul wrote in Romans chapter 10 (from the Christogenea New Testament): "8 You owe to no one anything, except to love one another: for he who loves another has fulfilled the law. 9 Indeed you shall not commit adultery, you shall not murder, you shall not steal, you shall not lust, and any other commandment is summarized in this saying, to wit: 'You shall love him near to you as yourself.' 10 Love for him near to you who does not practice evil: therefore fulfilling of the law is love."

Marxist Socialism and Communism - if they can be distinguished at all - are ungodly. These products of Jewish thinking have all the West - all of Christendom - enslaved today. They are enforced by the State, they force blindness to nationality, and they have a general disregard for moral character. Christian communion is not enforced by the State. For Paul, quoting the very passage in Exodus concerning the distribution of the manna, asks that the assembly at Corinth give to the needs of persecuted Christians in Judaea *voluntarily*, and did not compel them (2 Corinthians chapter 8). Christianity is not ethnically blind, but rather it is wholly racist, to use a Marxist term. That Christianity is racist is evident from passages such as Matthew 15:24 where Christ is recorded as having said "I am not sent but unto the lost sheep of the house of Israel" or Matthew 25:32-33 where the sheep and goats are divided by sight, and the judgement of the sheep nations is entirely positive where the judgement of the goat nations is entirely negative. Neither is Christianity morally neutral, and those who are of reprehensible moral character and who are unrepentant should be ejected from

the Christian community (I Corinthians chapter 5), so that they may suffer without its beneficence.

Neither does Christian community endorse the idea of a hand-out. In a Christian community the slothful is penalized (II Thessalonians 3:10), but the workman is to be rewarded (Matthew 10:10, 25:28-29). If one does not work, one does not eat: 2 Thessalonians 3:10: "Also when we were with you, this we instructed you, that if anyone wishes not to work, neither must he eat." This idea was expressed in the political philosophy of Adolf Hitler, and was later implemented in National Socialist Germany's welfare policies. From the pages of Mein Kampf, Book 1, Chapter 2:

Page 24 (in the Murphy edition): "I do not know which is the more nefarious: to ignore social distress, as do the majority of those who have been favoured by fortune and those who have risen in the social scale through their own routine labour, or the equally supercilious and often tactless but always genteel condescension displayed by people who make a fad of being charitable and who plume themselves on 'sympathising with the people.'"

Page 27 (in the Murphy edition): "During my struggle for existence in Vienna I perceived very clearly that the aim of all social activity must never be merely charitable relief, which is ridiculous and useless, but it must rather be a means to find a way of eliminating the fundamental deficiencies in our economic and cultural life--deficiencies which necessarily bring about the degradation of the individual or at least lead him towards such degradation."

Part of the foundation of good Christian doctrine is the idea that one should devote his life to serving his brethren, which are his kinsmen. Individual sacrifice for the benefit of the race is often merely inferred in the Gospels, but just as often it is presented as an explicit requirement of Christians. The idea of giving one's life for one's people does not necessarily mean dying prematurely for them, however that too may often be a necessity. But what it means much more practically is the *devoting of one's life to their well-being, to the common weal or to what is of benefit to all*. Hitler's own thought in this area is a perfect product of the gospel, and he often stressed the need for individual sacrifice on behalf of the race. Here are a few New Testament scriptures that elucidate this philosophy:

John 10:11-17: "11 I am the good shepherd: the good shepherd giveth his life for the sheep ... 14 I am the good shepherd, and know my sheep, and am known of mine. 15 As the Father knoweth me, even so know I the Father: and I lay down my life for the sheep. 17 Therefore doth my Father love me, because I lay down my life, that I might take it again."

Matthew 10:38-39: "38 And he that taketh not his cross, and followeth after me, is not worthy of me. 39 He that findeth his life shall lose it: and he that loseth his life for my sake shall find it."

Matthew 23:10-12: "10 Neither be ye called masters: for one is your Master, even Christ. 11 But he that is greatest among you shall be your servant. 12 And whosoever shall exalt himself shall be abased; and he that shall humble himself shall be exalted."

John 15:13: "Greater love hath no man than this, that a man lay down his life for his friends."

It is evident from these scriptures and others, that we are to follow Yahshua Christ's example by giving up, or at least by devoting, our lives to the betterment of our communities. If Christians devoted their lives to their nation, rather than to their own self-enrichment, how much better off the nation would be as a whole! And Yahweh God would surely reward the individual who did these things. What follows are some quotes from Mein Kampf which demonstrate that Hitler had fully incorporated this Christian philosophy into his own philosophy.

From Book 1, Chapter 10 (page 146 of the Murphy edition): "The right to personal freedom comes second in importance to the duty of maintaining the race."

From Book 1, Chapter 4 (page 94 of the Murphy edition): "The sacrifice of the individual existence is necessary in order to assure the conservation of the race. Hence it is that the most essential condition for the establishment and maintenance of a State is a certain feeling of solidarity, wound in an identity of character

and race and in a resolute readiness to defend these at all costs."

From Book 1, Chapter 11 (page 168 of the Murphy edition): "The readiness to sacrifice one's personal work and, if necessary, even one's life for others shows its most highly developed form in the Aryan race. The greatness of the Aryan is not based on his intellectual powers, but rather on his willingness to devote all his faculties to the service of the community. Here the instinct for self-preservation has reached its noblest form; for the Aryan willingly subordinates his own ego to the common weal and when necessity calls he will even sacrifice his own life for the community."

From Book 1, Chapter 11 (page 169 of the Murphy edition): "In the German language we have a word which admirably expresses this underlying spirit of all work: It is *Pflichterfüllung*, which means the service of the common weal before the consideration of one's own interests. The fundamental spirit out of which this kind of activity springs is the contradistinction of 'Egotism' and we call it 'Idealism'. By this we mean to signify the willingness of the individual to make sacrifices for the community and his fellow-men ... To this kind of mentality the Aryan owes his position in the world. And the world is indebted to the Aryan mind for having developed the concept of 'mankind'; for it is out of this spirit alone that the creative force has come which in a unique way combined robust muscular power with a first-class intellect and thus created the monuments of human civilization."

From Book 2, Chapter 2 (page 239 of the Murphy edition): "The man who loves his nation can prove the sincerity of this sentiment only by being ready to make sacrifices for the nation's welfare. There is no such thing as a national sentiment which is directed towards personal interests. And there is no such thing as a nationalism that embraces only certain classes."

In early America, some of our own most Christian states were founded on this same principle of "service of the common weal", which is what the word *commonwealth* means. Materialism, the consuming individual hording for his own gain and the prospect of his own future security, is anathema to the Christian community. The concept of the egotistical individual, the concept of stardom, is antithetical to Christianity. Both of these concepts are deceptions of the Jewish mind, and divide the members of the body of Christ into units which are then in competition with one another. To the Jew, a nation unified in Christian community is anathema. So one tendency of the jew is to divide society by creating the *star* or the *personality*. This fragments the nation into a collection of individuals, each seeking after their own interests, and not caring for the interests of the nation. Such materialism and egotism are vain idolatry. It is not a coincidence that the Jewish media calls their stars and heroes *idols*.

That Nationalist Socialist Germany put these sound principles of Christian Community into practice is documented. The following passages are from the booklet *Social Welfare in Germany* by Werner Reher, 1938, published by the Terramare Office, in Berlin, pages 3 through 7 (some notes from the editor are in brackets):

"In all civilized countries there are organizations for social assistance which owe their origin and maintenance to private initiative. Some of these operate under the aegis of religious denominations and others are carried on by lay associations which have been established to meet some definite social need. The idea which inspires all these springs from the Christian principle of love for the neighbour, the idea of doing good to others. Then there are social welfare activities which are subsidized and directed by the State and these also are inspired by the Christian principle. The desire and purpose of all such undertakings is to foster a social policy whereby the economic distress of the individual will be made at least bearable. Thus the underlying presumption is that economic distress is a permanent condition in which a certain class of the community must live. Should temporary distress arise temporary measures are generally adopted to meet it. But the uniform postulate on which social welfare activities are generally based is the belief that the poor will be always with us. The preaching and practice of this principle weakens the moral resistance of those who find themselves in need of assistance. [Simply because Christ stated it as a matter of fact doesn't mean that we should give people an excuse to despair. - *WRF*]

“Germany is now endeavouring to establish a new social concept of the State and its functions. This idea is based on the traditional union between the people and their native land [Blut und Boden, or Blood and Soil] and on the hope that, by uniting the people in one folk community where class distinctions play no part [but certainly existed and were expected to continue], it may be possible to find a solution for the social problem in a synthesis between people and State. Unless this attempt first wins the acceptance and sanction of the people it will be doomed to failure. The State must secure the willing cooperation of the people.

“This free collaboration on the part of the people, which is now an established fact and force in Germany, is a proof that the people have been approached and won in the right way. And this achievement must be placed to the credit of the National Socialist People's Welfare Organization (N. S. V. = Nationalsozialistische Volkswohlfahrt). This organization has now more than seven million members. These seven millions are the sponsors of that work which shows itself most strikingly in the German People's Winter Help and in the "Mother and Child" institution. In this social service there are nearly 1,500,000 voluntary workers. These workers are engaged in teaching the public in a practical way **to understand that the need of the individual is an affair that concerns the community as a whole. Whatever help is given to the individual must not be given as an alms.** It is the duty of the community to render assistance in cases of need, not as a work of supererogation [the performance of more than is asked for, the action of doing more than duty requires] but as a work that is necessary to maintain the existence of the community itself. Such is the principle which inspires all the activities of the N. S. V. and that principle is constantly kept before the public mind.


In the Marxist and liberalistic systems the individual and his needs formed the point of central interest. That is not so with the National Socialist welfare system. Here the community of the people is the primary and essential object of care. The wellbeing of the community is a necessary precondition for the wellbeing of the individual. Hitler once declared: "We do not say to the rich man: 'Give to the poor', but we say: 'People of Germany help yourselves'."

However the people of Germany had the means with which to help both themselves and their communities. The removal of the usury-based currency and the prohibition of speculation in land and raw materials, among other measures, ensured that the individuals in a community had access to the means of production and the tools necessary to develop both healthy communities and healthy individuals. All of which is anathema to the Jewish capitalists, and which was why Hitler's Germany had to be destroyed.

National Socialist Germany was only putting into practice the concepts of socialism as it was originally conceived, that the producers would control the means of production rather than the Jewish capitalists and speculators. Contrarily, in the Marxist system as it was implemented in Russia, the State owned the means of production - and the State was wholly controlled by Jews. Under the National Socialist system, freed from the world's parasites all of the members of the body could be healthy once again. Therefore Germany blossomed while the rest of the West was in depression. Today's Christians must remove themselves from the Jewish-controlled shackles which captivate their political thoughts, and reassess both Scripture and history if they are ever going to free themselves of Satan.

When will All of Israel be Awakened to their Identity?

This is a very important question which I was asked by an astute lady, whom I will not name. Of course, when we make mention of this subject, we are talking about how the twelve tribes of Israel were “blinded” to who they were because they had been unfaithful to their Husband, Yahweh.

Because Israel had been disloyal on many occasions, and repeatedly chastened for that disloyalty, eventually it became evident to Yahweh, her Husband, that He had no other alternative but to give her a writ of divorce. Upon that divorce, Yahweh “put away and punished” the twelve tribes of Israel for “seven times” (*i.e.*, 2,520 years). Lev. 26:18 states:

“And if ye will not yet for all this hearken unto me, then I will punish you seven times more for your sins.”

This punishment didn’t start all at the same time, but was spread over a period of 160 years. To get a Biblical, historical and archaeological perspective view of the deportations of the house of Israel and the house of Judah, I will quote from *An Outline History of the Seventy Weeks Nation* by The Rev. Alban Heath, pp. 11-13:

“The first of these deportations was in the time of Tiglath-Pileser, who reigned over Assyria 745-727 B.C. **‘In the days of Pekah king of Israel came Tiglath- Pileser king of Assyria, and took Ijon, and Abelbeth-maachah, and Janoah, and Kedesh, and Hazor, and Gilead, and Galilee, all the land of Naphtali, and carried them captive to Assyria’** (2 Ki. 15:29). **‘And the God of Israel stirred up the spirit of Pul king of Assyria and the spirit of Tiglath-Pileser king of Assyria, and he carried them away, even the Reubenites, and the Gadites, and the half tribe of Manasseh, and brought them into Halah, and Habor, and Hara, and to the river Gozan, until this day’** (1 Chron. 5:26). These

captives were of Ten-Tribed Israel, as distinct from the House of Judah, and they were taken to the country we now know as Mesopotamia. The British Museum authorities identify Pul with Tiglath-Pileser.

“The next deportation was in the time of Shalmaneser V, who was king of Assyria, 727-722 B.C. **‘... Shalmaneser king of Assyria came up against Samaria, and besieged it ... And the king of Assyria did carry away Israel unto Assyria, and put them in Halah and in Habor by the river Gozan, and in the cities of the Medes’** (2 Ki. 18:9, 11). Samaria was [in] the country of Israel. Again the captives were deported to Mesopotamia, and again the captives were of the House of Israel as distinct from the House of Judah.

“Sargon II, 722-705 B.C., does not appear in Old Testament history. Isaiah [20:1] makes one passing reference to him but his dealings with Israel find no mention in the sacred writings. But Sargon himself has left the following inscription: ‘(In the beginning of my reign) the city of Samaria I besieged, I captured ... 27,280 of its inhabitants I carried away; fifty chariots in the midst of them I collected (and the rest of their goods I seized); I set my governor over them and laid upon them tribute and taxes like those of the Assyrians.’

“Later, the Southern kingdom fell a victim to the ravages of heathen rulers. **‘... Sennacherib king of Assyria (705-681 B.C.) did come up against all the fenced cities of Judah, and took them’** (2 Ki. 18:13). While the Scriptures are silent on the subject of deportations at this time, Sennacherib himself has left the following record: ‘And Hezekiah king of Judah, who had not bowed down at my feet forty-six of his strong cities, his castles, and the smaller towns in their neighbourhood beyond number with warlike engines. ... I attacked and captured 200,150 people small and great, male and female, horses, mares, asses, camels, oxen and sheep beyond number, from the midst of them I carried off and distributed them as a spoil. He himself, like a bird in a cage, inside Jerusalem his royal city I shut him up.

“When neo-Babylon overthrew the ascendancy of Assyria and became itself the supreme power, Nebuchadnezzar, 604-561 B.C., imposed his heavy

yoke upon the king and the kingdom of Judah. The vassalage began in the first year of Nebuchadnezzar. In the days of Jehoiakim “Nebuchadnezzar king of Babylon came up, and Jehoiakim became his servant.”

This testimonial from *An Outline History of the Seventy Weeks Nation*, by The Rev. Alban Heath, is only a brief recap of the evidence of a much longer and complicated story! Up to this point, Yahweh had married the twelve tribes of Israel, and because His wife on many occasions proved to be habitually unfaithful, He finally divorced her and put her away in punishment for 2,520 years, which would last approximately until the early 1800’s A.D. We should also take into account the fact that the twelve tribes were not all taken captive at the same time, so also, their 2,520 years of punishment would not end at the same time.

Therefore, we should not be surprised that a man by the name of John Wilson, who was born at Kilmarnock, Scotland in 1779 A.D., began an inquiry into the Israelitish origin of the Anglo-Saxons in the year 1837 A.D. The reason that the twelve tribes forgot their origins is explained at Isaiah 29:10-12, which states:

“¹⁰ For Yahweh hath poured out upon you the spirit of deep sleep, and hath closed your eyes: the prophets and your rulers, the seers hath he covered. ¹¹ And the vision of all is become unto you as the words of a book that is sealed, which men deliver to one that is learned, saying, Read this, I pray thee: and he saith, I cannot; for it is sealed: ¹² And the book is delivered to him that is not learned, saying, Read this, I pray thee: and he saith, I am not learned.” Here, the moral to the story is: Don’t ask your pastor or priest, no matter how educated he might be, or your less educated relatives or friends, but check it out for yourself. Likewise, don’t take my word for it, as Scripture makes each individual Israelite responsible for the truthfulness and accuracy of this account. Additionally, if you are a descendant of one of the twelve tribes of Israel, and if Yahweh doesn’t lift His “spirit of sleep” from off of you, you’ll not understand it until He does! And **NO**, this “spirit of sleep” was not placed on the converso Edomite-jews! To confirm the mass conversion of Edomites to Israelite-ism, (which they Talmud-ized into “Judaism”), read Josephus’ *Antiquities*, book 13, chapter 9, paragraph 1, which states in part:

“... Hyrcanus took also Dora and Marissa, cities of Idumea, and subdued all the Idumeans; and permitted them to stay in that country, if they would circumcise their genitals, and make use of the laws of the Jews; and they were so desirous of living in the country of their forefathers, that they submitted to the use of circumcision, and the rest

of the Jewish ways of living; at which time therefore this befell them, that they were hereafter no other than Jews.” [*underlining mine*]

A footnote on the same page makes the following comment on this passage:

“This account of the Idumeans admitting circumcision, and the entire Jewish law, from this time, or from the days of Hyrcanus, is confirmed by their entire history afterwards. This, in the opinion of Josephus, made them proselytes of justice, or entire Jews. However, Antigonus, the enemy of Herod, though Herod were derived from such a proselyte of justice for several generations, will allow him to be no more than a half Jew. Ammonius, a grammarian, says:— ‘the Jews are such by nature, and from the beginning, whilst the Idumeans are not Jews from the beginning ... but being afterwards subdued by the Jews and compelled to be circumcised, and to unite into one nation, and be subject to the same laws, they were called Jews.’ Dio also says:— ‘That country is also called Judea, and the people Jews; and this name is given also to as many as embrace their religion, though of other nations’.”

What most Christians overlook is the prophecy at Jeremiah 16:16, which declares:

“¹⁶ Behold, I will send for many fishers, saith Yahweh, and they shall fish them; and after will I send for many hunters, and they shall hunt them from every mountain, and from every hill, and out of the holes of the rocks. ¹⁷ For mine eyes are upon all their [Israel’s] ways: they are not hid from my face, neither is their iniquity hid from mine eyes.” Nearly all of us Israelites understand that, when Christ called His disciples, He told them He would make them “**fishers of men**”, but what our people have yet to learn, He was also to call for “**hunters of men**”! The hunters have pretty well completed their task, so let’s take note of the most important discoveries the hunters unearthed. ?

WHAT DID THESE HUNTERS FIND ?

While all of these archaeologists found many things verifying Biblical places, times and events, far and away the most important of these were the cuneiform clay tablets found in the excavations of the Assyrian royal library at Nineveh. It might appear today, after a lapse of 2500 years, all hope of tracing the Israelites has been lost in the midst of antiquity. Archaeologists have, though, during the last 100 years, unearthed and published the original contemporary records of the Assyrians who took the Israelites captive. From these records, in recent years, vital clues have come to light. These records consist of cuneiform clay tablets which can be found today in the British Museum.

These tablets serve today as archaeological evidence of Israel's migrations. These clay tablets were frontier post reports of Assyrian spies, to the Assyrian king, keeping watch over the captive peoples. Among these tablets were over 1,400 different texts, including reports of how the captive peoples (Israelites) were breaking away in small groups and heading northwest in the general direction of Europe. The texts of these Assyrian clay tablets were not deciphered until about 1930. These Assyrian reports were saying, in effect: "The last time we saw those sons of Omri (as the Israelites were called by the Assyrians), they were breaking away and heading in a northwesterly direction toward Europe." Not to inquire about this evidence found by the prophesied "hunters" would therefore be foolhardy, for there is nothing heedlessly implied in Scripture! It should be very carefully noted that the prophet placed the importance of the "hunters" on the same level with the "fishers"! Yet, we hear next to nothing concerning the importance of the "hunters" from nominal churchianity.

While the "hunters" were doing their job, during approximately the same time period, the descendants of Cain were busy concocting a dogma they called "Zionism". To get a handle on this, I will quote from *The Story of the Jew*, by Rabbi Lee J. Levinger, and his wife Elma ©1928, 9th printing, 1936 (used as a textbook for Jewish children), pp. 217-217:

"... Now it became the movement of modern Jewish thinkers in Russia; they called it the Haskalah or 'enlightenment,' and called themselves the Maskilim, or 'enlighteners.' Their writings were partly about the Jews and Jewish problems, partly about all other subjects that interested people in the nineteenth century. Some of them wrote also in Yiddish, the language of the people, which they gradually developed into a literary language; some of them even wrote in Russian, the language of their oppressors.

"The first of them all was Isaac Baer Levinsohn [in 1828; (lived 1788-1860)], the Mendelssohn of Russia; about forty years after Mendelssohn, he followed that great leader in trying to combine Jewish interest and general education. He and his followers published magazines in the Hebrew language, wrote poetry and novels as well as histories and serious articles. Abraham Mapu wrote a romantic novel of the days of Isaiah, entitled 'Ahabath Zion,' the Love of Zion, which introduced hundreds of young [Jewish] students of the Bible to modern literature. Of course, they had read it in secret, as the Haskalah movement was not approved by the old type of Hebrew educators.


"We have already mentioned the greatest Hebrew poets, Chaim Nachman Bialik, and you will hear in chapter XVII of *Ahad Ha'am*, the greatest of Hebrew

essayists and the founder of cultural Zionism. For Haskalah in Russia led toward Zionism; Smolenskin and Pinsker were forerunners of Theodore Herzl as they worked out a theory of the Jewish nation."

No doubt, this divergent information may seem extraneous to some readers, but it is essential to our investigation. Not only did the Jews hatch up their theory of Zionism, but they infiltrated and financed this false Zionism into the denominations of nominal churchianity. Here's the story, as I stated in my essay, *Old Jerusalem Shall Never Rise Again*:

"As a young con-artist in Kansas after the Civil War, Cyrus I. Scofield met up with John J. Ingalls, an aging Jewish lawyer who had been sent to Atchison by the 'Secret Six' some thirty years before to work the Abolitionist cause. Pulling strings both in Kansas and with his compatriots back east, Ingalls assisted Scofield in gaining admission to the Bar, and procured his appointment as Federal Attorney for Kansas. Ingalls and Scofield became partners in a railroad scam which led to Cyrus serving time for criminal forgery.

"While he was in prison, Scofield began studying the philosophy of John Darby, pioneer of the Plymouth



Brethren movement and the ‘any moment now’ rapture doctrine. Upon his release from prison, Scofield deserted his first wife, Leontine Carry Scofield, and his two daughters Abigail and Helen, and he took as his mistress a young girl from the St. Louis Flower Mission. He later abandoned her for Helen van Ward, whom he eventually married. Following his Illuminati connections to New York, he settled in at the Lotus Club, which he listed as his residence for the next twenty years. It was here that he presented his ideas for a new Christian Bible concordance, and was taken under the wing of Samuel Untermeyer, who later became chairman of the American Jewish Committee, president of the American League of Jewish Patriots, and chairman of the Non-sectarian Anti-Nazi League. [“nazi” is a Hebrew word for “prince”!]

“Untermeyer introduced Scofield to numerous Zionist and socialist leaders, including Samuel Gompers, Fiorello LaGuardia, Abraham Straus, Bernard Baruch and Jacob Schiff. These were the people who financed Scofield’s research trips to Oxford and arranged the publication and distribution of his concordance.”

Thus, the Jesuit priest Riberia’s writings influenced the Jesuit priest Lacunza; Lacunza influenced Irving; Irving influenced Darby; Darby influenced Scofield; Scofield and Darby influenced D.L. Moody, and Moody influenced the Pentecostal Movement; and the Pentecostal Movement influenced the Charismatic Movement. Scofield also was the head of Southwestern School of the Bible in Dallas, the forerunner of the present Dallas Theological Seminary. This school is now a major center for spreading Scofield’s views, and I don’t want to have the slightest part in this satanic plot dreamed-up, supported and perpetuated by Canaanite-Edomite-jews.


We can see very clearly here that the converso Edomite-jews knew quite well that if they could convince nominal churchianity that they were “God’s chosen people”, then they could gain Christian support for their Satanic agenda! Considering all of this evidence, we are now in a better position to answer the question, “When will all of Israel be awakened to their Identity?” Yes, the Bible does answer our question, but it is found in a most unlikely place: Ezekiel 39:22-25:

So the house of Israel shall know that I am Yahweh their Elohim from that day and forward. ²³
And the heathen¹⁴⁷¹ **shall know**³⁰⁴⁵ **that the house of Israel went into captivity for their iniquity: because they trespassed against me, therefore hid I my face from them, and gave them into the hand of their enemies: so fell they all by the sword.** ²⁴ **According**

to their uncleanness and according to their transgressions have I done unto them, and hid my face from them. ²⁵ **Therefore thus saith Yahweh Elohim; Now will I bring again the captivity of Jacob, and have mercy upon the whole house of Israel, and will be jealous for my holy name”**

Matthew Poole, in his 3-volume *Commentary*, vol. 2, p. 783, states on verse 22:

“The sottish [*i.e.*, *stupefied*] heathen thought meanly of the God of Israel, and reckoned they came into captivity because the people of some greater god had by the power of their god prevailed against Israel’s God and his people; but by this overthrow given to Gog, they shall see it was not impotence in Israel’s God, but iniquity in Israel’s people, that brought them into captivity. *Trespassed*; committed sin perversely, continually, and with a high hand. *Hid my face*; withdrew my favour, would no more regard them, and then it was soon a night of trouble to them. *Into the hand*, into the power, *of their enemies*, which could not have hurt Israel if Israel had not first forsaken his God, but then God forsook them. When God withdrew his defence, as fenceless, they fell under the sword of the enemy; for it is he that subdueth enemies and giveth victory.”



Adam Clarke, in his 6-volume *Commentary*, vol. 4, p. 530, remarks reasonably well on verse 25:

“... *Now will I bring again the captivity of Jacob*] Both *they* and the *heathen* shall know that it was for their [*Isra-el’s*] iniquity that I gave them into the hands of their enemies: and now I will redeem them from those hands in such a way as to prove that I am a *merciful God*, as well as a *just God*.”

From this it should be evident that we are dealing with two different entities, (1) all of the twelve tribes of Israel, and (2) a people who are enemies of Israel. We

are presently mindful of such illegal “heathen” pouring across our borders and entering our Israelite lands on a daily basis.

Barnes’ Notes, Eze 39:25-26, p. 371, reads:

“... The contrast of the future of Israel with that of the surrounding nations. This prophecy reaches far beyond a mere temporal restoration. It points to times of more permanent security, when from all nations and kingdoms the Church [*sic ekklesia*] of Christ, the Israel of God, shall be gathered in, when the power of the world shall be for ever broken, and the kingdom of Christ shall be established for ever.”

Matthew Henry, in his 6-volume *Commentary*, vol. 4, p. 979, states on verses 23-25:

“... God will let the heathen know the meaning of his people’s troubles, and rectify the mistake of those concerning them who took occasion from the troubles of Israel to reproach the God of Israel, as unable to protect them and untrue to his covenant with them. When God, upon their reformation and return to him, turned again their captivity, and brought them back to their own land, and, upon their perseverance in their reformation, wrought such great salvations for them as

that from the attempts of Gog upon them, then it would be made to appear, even to the heathen that would but consider and compare things, that there was no ground at all for their reflection, that Israel went into captivity, not because God could not protect them, but because they had by sin forfeited his favour and thrown themselves out of his protection (vv. 23-24): *The heathen shall know that the house of Israel went into captivity for their iniquity, that iniquity which they learned from the heathen their neighbours, because they trespassed against God. That was the true reason why God hid his face from them and gave them into the hand of their enemies*”

At Deut. 32:26-28 we are told: “**26 I said, I would scatter them into corners, I would make the remembrance of them to cease from among men: 27 Were it not that I feared the wrath of the enemy, lest their adversaries should behave themselves strangely, and lest they should say, Our hand is high, and Yahweh hath not done all this.**” Have you noticed how “strangely” our enemies have been acting lately? Like, for instance, the nonentity in the empty chair?

Solzhenitsyn once remarked that the very essence of Communism/Zionism was quite beyond the scope of human understanding and that for so many average, normal, moral, decent people living in the West it was just too much of a stretch of their imagination to picture the real and dreadful, vile and disgusting actions committed by these ideologically and spiritually crippled people who have plundered and pillaged and raped and destroyed untold millions of souls in their quest to gain total control of the world.

I could go on with quote after quote from Solzhenitsyn warning those in the West of the subtle dangers that are working ceaselessly everywhere to drag down unsuspecting nations into the mire of atheistic perversions and immoral mental and spiritual torpor and confusion thus making them incapable of realizing that their rights and freedoms are being terminated until it is too late. He says it becomes incumbent upon the individual to reject the Zionist ideology.. In his words, “Such a rejection is more than a political act. It is a protest of our souls against those who would have us forget the concepts of good and evil.

XVII ¹ And ^{one} from among the seven messengers having the seven bowls came and spoke with me, saying: “Come, I shall show you the judgment of the great whore who sits upon many waters, ² with whom the kings of the earth have fornicated, and those inhabiting the earth have been intoxicated from the wine of her fornication!” ³ And in the Spirit he brought me to a desert.



Speaking allegorically, there is really only one woman in the life of Yahweh, and that is the nation of the children of Israel. The children of Israel are the woman of Revelation chapter 12, and they are also the woman of Revelation chapter 17. Whenever, in the Old Testament, the Children of Israel followed the ways of the aliens, and followed after strangers, they were described as a woman, a wife – specifically the wife of Yahweh, who had gone off into whoredom. Hee it is no different. In the centuries following the Reformation, when practically everyone had a family Bible – the Little Book opened to all Israel – most of our race has instead chosen to worship the beast system and pursue the things of this world. Therefore, Israel is the whore sitting upon many waters - the Saxon empires who had subjugated all of the world's aliens by the beginning of this very period, in dawn of the 19th century. While the British empire was of course foremost, other Saxon nations also had their colonies abroad. These are the many waters which the whore sits upon. Those inhabiting the earth – all of the

peoples of the world whether sheep or goats, are intoxicated with the wine of her fornication – without the Saxon peoples and their inventions, there is no durable world trade.

And I saw a woman sitting upon a scarlet beast filled with names of blasphemy, having seven heads and ten horns. ⁴ And the woman was clothed in purple and scarlet and gilt in gold and precious stones and

pearls, having a gold cup in her hand full of abominations and the unclean things of her fornication, ⁵ and upon her forehead a name is inscribed: “Mystery Babylon the Great, Mother of the Whores and the Abominations of the Earth”.

It is the beast who is filled with the names of blasphemy, not the woman. The seven heads and ten horns again represent the governments and powers which have ruled over the woman, and by this we see that our subject has not changed from those earlier visions and prophecies concerning world empires which were to rule “wheresoever the children of men dwell”, meaning the sons of Adam, which is stated at Daniel 2:38 of the first beast.

In order to understand the beast referred to as Mystery Babylon, we must go back to the original Babylon, the Tower of Babel account of Genesis chapter 11, and begin there: “¹ And the whole earth was of one language, and of one speech. ² And it came to pass, as they journeyed from the east, that they found a plain in the land of Shinar; and they dwelt there. ³ And they said one to another, Go to, let us make brick, and burn them thoroughly. And they had brick for stone, and slime had they for mortar. ⁴ And they

said, Go to, let us build us a city and a tower, whose top may reach unto heaven; and let us make us a name, lest we be scattered abroad upon the face of the whole earth. 5 And the LORD came down to see the city and the tower, which the children of men builded. 6 And the LORD said, Behold, the people is one, and they have all one language; and this they begin to do: and now nothing will be restrained from them, which they have imagined to do. 7 Go to, let us go down, and there confound their language, that they may not understand one another's speech. 8 So the LORD scattered them abroad from thence upon the face of all the earth: and they left off to build the city. 9 Therefore is the name of it called Babel; because the LORD did there confound the language of all the earth [*Babel* means *confusion*]: and from thence did the LORD scatter them abroad upon the face of all the earth." Of course, Genesis 11 is only describing the White Adamic sons of Noah, who had been listed in Genesis chapter 10. While there may have been thousands, even tens of thousands, of Adamic people descended from Noah in the world by this time, here then in the balance of Genesis chapter 11 is the genealogy carried down to Abraham, and the rest of the Bible the story shall focus upon him and his descendants. From henceforth, the other Adamic nations – and any non-Adamic peoples - are referred to only when they come into contact with or when it is pertinent to the children of Israel.

The Genesis 11 event is referred to in later Scripture, both at Deuteronomy 32:8 and at Acts 17:26. Here are those passages:

Deuteronomy 32:8-9: “ 8 When the most High divided to the nations their inheritance, when he separated the sons of Adam, he set the bounds of the people according to the number of the children of Israel. 9 For the LORD'S portion is his people; Jacob is the lot of his inheritance.”

Acts 17:26: “And He made from one every nation of men to dwell upon all the face of the earth, appointing the times ordained and the boundaries of their settlements”.

Yahweh God created the borders between the Adamic nations, and ordained the periods of their duration. It has always been the purpose of the dragon, and as it states in Revelation chapter 13 it is the dragon which


gives its authority to the beast, to destroy those borders. For this reason, in the Old Testament we see the word *Canaanite* used to refer to a *merchant*, for the terms became synonymous (i.e. Job 41:6, Proverbs 31:24, Isaiah 23:11, Hosea 12:7 and Zephaniah 1:11) although there are other Hebrew words for *merchant*. The Edomites were also Canaanites, except for Esau himself, and it is manifest in Revelation chapter 12 that the Edomite Herod was one representative of the dragon, by which we understand the nature of satan as those people forever opposed to the God of creation: they are the seed of the Genesis 3:15 serpent. In this age it is the intended and often-published goal of the international merchants, most whom happen to be Edomites jews, to break down borders and bring all local and regional laws into conformity, so that “the world may be as one”, exactly the situation which Yahweh God despises, as it is manifest in Genesis chapter 11.

Stronger correlations between Mystery Babylon and international commercialism shall be made later in chapter 18. First several other things must be considered and discussed. It can be shown that many aspects of the world system which we have today, things which are especially promoted by the internationalist jews, had their origins – at least among the Adamic race – in ancient Babylon. Among these are the ideas of democracy and the current laws extant throughout the Christian world governing commercial transactions. The first pagan pantheons were also found in ancient Sumer.

Many scholars think that democracy, which is *rule by the people*, was new to the ancient Greeks and developed by them. Yet there are much older Mesopotamian inscriptions which reveal a democratic system in operation many centuries before the Greek experiment. This is remarked upon with references to several journal articles, in *Ancient Near Eastern Texts Relating to the Old Testament*, J. B. Pritchard, Editor, 1969, Princeton University Press. There are several scholarly articles in other publications also referring to this form of so-called “primitive democracy”. Where the people were said in Genesis 11 to have “said one to another” and “let us make a name”, they were certainly acting democratically, and therefore we find that democracy is rooted in ancient Babylon. A rather recent article ran in the January 2001 issue of a periodical called *Archeology Odyssey*, entitled “The

Birth of Kingship – From Democracy to Monarchy in Ancient Sumer” by one Jacob Klein.

However an observation concerning more recent and perhaps more pertinent circumstances is this: that the Torah – the Hebrew law – advocates theocracy as the only viable system of government for the Adamic race, while the Talmud – the real religious book of the jews – is actually a book advocating democracy, where the decisions of a preponderance of rabbis outweigh the Word of God. The following quote is from page 173 of the book *Maimonides: The Life and World of One of Civilization's Greatest Minds* (and I would dispute the truth of even the title). It states “Maimonides' discourse on majority and minority (even individual) views exemplifies how rabbinic democracy worked. Having established that the law follows majority opinion, or consensus, not prophetic inspiration, Maimonides noted the value of individual opinion.” So we see the idea that man can rule himself in a majority of opinions, which can then outweigh the Word of God, is rooted in the Babylonian Talmud. This is one facet of “mystery Babylon”. Reading the writings of Madison, Jefferson, Franklin, Adams, and others of the founding fathers of this nation, they founded a Republic based upon Christian principles guided by the Word of God. America was never, ever supposed to be a democracy. In the early 20th century, the jewish media sold that idea to a slothful and ignorant people.



In the early Middle Ages, the jews had rabbinical schools at Babylon, and from there were supplied rabbis and teachers to the rest of the jewish world. While there are two different Talmuds, the Babylonian and the Jerusalem, the Babylonian Talmud is

regarded as the authoritative version. "The authority of the Babylonian Talmud is also greater than that of the Jerusalem Talmud. In cases of doubt the former is decisive." (R.C. Musaph-Andriese, *From Torah to Kabbalah: A Basic Introduction to the Writings of Judaism*, p. 40). Mystery Babylon has been disseminated through, and is inseparable from, world jewry. The vile anti-Christ ideas emanating from this book, and spread throughout the Christian world through the synagogues of the jews, have affected the lives of each and every Christian throughout the past several centuries. Everywhere we find jews and democracy, we find the principles of the Babylonian Talmud in action, which leads inevitably to Pharisaism and to tyranny.

Not only has our system of government become overtaken by Mystery Babylon, more so our system of commerce. In a thoroughly researched 1983 Georgetown Law Journal article, written by a jewess named Judith Shapiro and entitled “The Shetar's Effect on English Law — A Law of the Jews Becomes the Law of the Land”, it is fully evident that English and American commercial laws – the laws which govern contracts and debt and credit transactions - were also taken from the Talmud because there was no need for Saxons to even have such laws, until after the admission of jews and usury into England. One major change to English law which was made due to jewish influence, was that a landholder could be separated from his land as a result of default on debt, something which was not permitted beforetime. The mortgage is an invention of this period. The introduction to Talmudic principles made in England and on the Continent because of the acceptance of jewish money-lending is absolutely contrary to the laws of Yahweh God which Christians should seek to live after (i.e. Romans 3:31).

Mystery Babylon also has a religious aspect to it, and while there is no direct connection between the papacy and the ancient high priesthood of Babylon, as some infer, there is still a connection nonetheless. The Roman Catholic church adopted all of the pagan ways of Rome and painted a Christian facade on them. The rituals, the statues, the edifices dedicated to a so-called saint, are no different than the ancient Babylonian pagan temples, dedicated to so-called gods, and the rituals which took place in them. Verse 5 of Revelation chapter 17 announces “**Mystery Babylon**

the Great, Mother of the Whores and the Abominations of the Earth” and this is certainly true when it is considered that these whores are the individual assemblies of Israelites still worshipping idols in the pagan manner the way their ancestors did thousands of years ago.

6 And I saw the woman intoxicated from the blood of the saints and from the blood of those bearing the testimony of Yahshua. And I marveled seeing this great wonder.



Nearly all of the White Adamic peoples killed in our wars or persecutions were killed by their own fellow White Adamites! Yet whether it be the 30 Years' War, the extermination of the French Huguenots, the American War Between the States, or the two World Wars of the 20th century, the aggressors were always convinced that they were doing good – even doing the will of God Himself. The instigators were always jews and those whom the jews convinced and financed to do their bidding. An example is the extermination of the French Huguenots, which occurred when France was under the thumb of Catherine de Medici, of that same family of jewish bankers which brought usury to the Romish church. The woman, believing that she has done well by exterminating her own people, surely is “intoxicated from the blood of the saints”.

7 And the messenger said to me: “For what reason do you marvel? I shall tell you the mystery of the woman and of the beast carrying her, having the seven heads and ten horns! 8 The beast which you saw was and is not and is going to ascend from out of the bottomless pit and go into destruction, and those dwelling upon the earth, whose name is not written in the book of life from the foundation of

Society, shall marvel seeing the beast that was and is not and shall be present.

The seven heads and ten horns identify this beast as that same beast that was seen in Revelation chapter 13. It was, and yet John foresaw its demise, which long ago transpired. Yet it “is going to ascend from out of the bottomless pit”. The casting of the beast into the pit in the first place, and its ascent from out of the pit, are a topic for Revelation chapter 20, which is another vision of this very thing from a different perspective. There it shall also be established that this beast is indeed world jewry. The jews of today, actually having descended from the Edomites and other Canaanites of the Old Testament, are the descendants of the seed of the serpent through Cain, Canaan and Esau. That Satan is also the dragon and the serpent – that these are all epithets for the same entity, is fully evident in Revelation chapter 12, where it is also evident that Herod the great stood as a historical representative of the dragon, fitting perfectly with Scripture since Herod was an Edomite, and not an Israelite.

When the jews were driven out from Christian society after Christianity became the official religion of the empire and edicts were made against them by the Byzantine emperors, they were forced to remain in the background – either outside of the empire or, at various times and in various degrees, they were able to exert influence discreetly from positions as moneylenders to unscrupulous noblemen, as court physicians to kings, or in other ways. During this period, however, the jew had comparatively little influence over everyday Christian life, and for a thousand years could not even dwell near Christians, but had to live in ghettos – jewish neighborhoods set aside for them to dwell in. However after the French Revolution and the emancipation of the jew, the jew once again attained equal rights of citizenship – something he had not had in Europe since the passing of pagan Rome. Jewish emancipation was actually a process which began towards the end of the 15th century, when wealthy jewish “converts” to Romish Catholicism were able to secure the papacy with regularity. Among these were the de Medici popes. With Giovanni de Medici, who was not even a priest, posing as Pope Leo X during the Fifth Lateran Council, usury became acceptable to Catholics by decree and whether bishops liked it or not. During the

Reformation, while the German Reformers rejected usury, Calvin accepted the practice. In New England, Cotton Mather also defended the practice, and advocated it as necessary for commerce. The acceptance of usury by Christendom secured the path by which Satan emerged from the pit in which he had been bound for a thousand years.

The beast which emerged from the pit would “go into destruction”. The French Revolution was launched from the Masonic lodges of France. These, in turn, and especially the Grand Orient lodge, had been infiltrated by the jews in the decades which preceded, and particularly by the Illuminati, a group founded by Jesuit priest Adam Weishaupt, who was a jew by race. The Jesuit order was also a jewish vehicle, by which jews were able to infiltrate and influence the Romish church and the governments of Europe before they could do so openly as jews. Once the French Revolution was completed, Christendom as it had been known for centuries was practically destroyed in France along with much of the French nobility, and many of the ideals of the Revolution were then exported to the rest of the European continent via Napoleon Bonaparte, who officially emancipated the jews. The French Revolution also enriched the jewish House of Rothschild in Britain to the point where it could take a commanding control of the British economy, which until now holds a tremendous influence over the policies of that nation. From the time of their emancipation, the jews have launched one revolution and war after another unto this very day, whether they be revolutions of arms, such as the Bolshevik revolution, or merely social revolutions such as those seen in America in the 1950's through the 1970's, which have turned American society into a cesspool of immorality. All of the jewish-instigated social revolutions have had the common goal of destroying the basic fabric of Christian society, not merely stopping at the so-called churches and governments but even destroying the basic family unit itself. All of those not written into the Book of Life are to marvel after this beast, which has brought us sexual liberation, Communism, woman's liberation, the Civil Rights movement, racial so-called equality, diversity, multiculturalism, unlimited so-called third world immigration and every other wicked and unclean spirit that our society has been beset with these past two hundred years. All while they cry incessantly for “Liberté, Egalité [and] Fraternité”.

9 Thus is the mind having wisdom: The seven heads are seven mountains, where the woman sits upon them. And there are seven kings: 10 five have fallen, one is, another has not yet come, and when he should come it is necessary that he remains a short time. 11 And the beast which was and is not even he is the eighth and is from of the seven, and goes into destruction.

The seven mountains are the world empires which have ruled over the woman throughout history. In Daniel chapters 2 and 7, we only saw four world empires described, but Daniel's vision was not as full a panorama of history as the one here revealed to John. The five empires which are fallen are the empires of Egypt, Assyria, Babylon, Persia and Greece. The one which is, in John's time, is Rome. The short-lived seventh empire must be that of Napoleon, who only lasted for a brief time. The papacy is not counted here, being a merely revival of one of the heads of the first beast, of Rome, and the Holy Roman Empire was a mere extension of the papacy. The eighth beast must be jewish international finance – world jewry itself, since not only does it control all world governments today, but both the British and American empires have been fueled by the jews of London, and then of New York. They are mere tools of the eighth beast, which is in its sum greater than either of them, although they are major components of it. The United Nations is not considered here, since that too is only a front for world jewry.

12 And the ten horns which you saw are ten kings, who have never received a kingdom, but they shall receive authority as kings for one hour with the beast. 13 These have one mind and power and they give their authority to the beast. 14 These shall make war with the Lamb and the Lamb shall overcome them, because He is Prince of Princes and King of Kings and those with Him called and chosen and faithful!”

There is much speculation over which kings these ten are. At one time it was imagined that they could be the ten European Commonwealth nations, which is certainly not likely. Or perhaps there will be ten United Nations Secretaries, as if they actually ever had any real power. The horns hate the whore – the people of Israel – so they must represent some power opposed to the people of Israel, whether bankers or

despots. Since they give their authority to the beast, they must be of the dragon, for which compare Revelation 13:4. However until the Lamb overcomes this last beast, it cannot be known with any certainty exactly what these ten kings represent. It would be easy to name ten international jewish billionaires, but it may also be vain to create such a list before the end of these things. Verse 13 here, which states that “these have one mind and power and they give their authority to the beast” may be compared with verse 17 below, which shall be discussed momentarily.

15 And he says to me: “The waters which you saw where the whore sits are people and multitudes and nations and tongues. 16 And the ten horns which you saw and the beast, these shall hate the whore and they shall make her desolate and naked and they shall eat her flesh and they shall burn her down with fire.

These statements verify the interpretation given here, and today the children of Israel are spread over the entire globe. Yet the horns of the beast have long been stripping the whore and making her desolate.

17 For Yahweh has bestowed it into their hearts to do His will and to have one purpose, and to give their kingdom to the beast until the words of Yahweh shall be accomplished. 18 And the woman which you saw is the great city which has dominion over the kings of the earth.”

The children of Israel, in whatever nations they dwell, have through a so-called democratic process voluntarily enslaved themselves to the beast. This has been exactly as Peter has warned, that “proclaiming for themselves freedom they become slaves of corruption”. While the jew has pronounced liberty, the White Christian world has been placed under the burdens of ever-burgeoning bureaucracies and higher and higher taxes, to support and enforce these jewish ideals of freedom, which really only elevate the scum of the world to assume the position of the children of God, and liberate the White Christian from the fruits of his labors. The White Christian, once having been truly free in the bondage of Christ, has now enslaved himself to the jew because he chose to worship the idols set up by the jew, turning away from the worship of Yahweh his God. After the French Revolution, the jew was free to disseminate not only countless false

religions and false philosophies, but also all of the fleshly distractions of which he is history's most famous propagator: pornography in pulp novels, pornography in the theater, gambling houses, prostitution, the corruption of children, and every other vice imaginable has become commonplace in modern White – formerly Christian – society. [The Communist Manifesto](#) calls for “Centralisation of credit in the hands of the State, by means of a national bank with State capital and an exclusive monopoly.” The Federal Reserve is precisely that. Once they achieved control of the American economy, it mattered not who sits in the presumed offices of power in Washington. Nathan Rothschild, the scion of the banking family in the days of Napoleon, is attributed as once having said “I care not what puppet is placed on the throne of England to rule the Empire. The man who controls Britain's money supply controls the British Empire and I control the British money supply.” While earlier British colonization was often financed for profit by the bankers of London, the

Rothschilds were behind the colonization and occupations of India, the opening up of China and Japan for trade by the British, the Opium Wars, and all of the other imperialist British wars of the 19th and 20th centuries. Through its New York and Boston banking agents, they also engineered the War Between the States and all of the American wars of imperialism. Nathaniel Meyer Rothschild, speaking to a group of international bankers in 1912, is attributed as having said: “The few who could understand the system [of cheque, money, and credits] will either be so interested in its profits, or so dependent on its favours, that there will be no opposition from that class, while on the other hand, the great body of people, mentally incapable of comprehending the

tremendous advantage that capital derives from the system, will bear its burdens without complaint, and perhaps without even suspecting that the system is inimical to their interests.” The wars against the German people in the 20th century, and the Bolshevik so-called Revolution in Russia, were orchestrated by the Rothschilds so that those nations may also be enslaved by this same beast.

The woman, the great city – representative of a seat of government – did have dominion over the kings of the earth, and the Saxon people still do in pretense, however their own kingdom is handed over to the beast, so it is the work of the beast which is done in the world.



South African Tells of Genocide in Communist-dominated South Africa

On October 2, 2012, the Fox Valley Conservative Forum, in Appleton, Wisconsin, hosted a talk by South African Sonia Hruska who now lives in the United States. She discussed the ongoing genocide against white people in her country

under the largely communist-controlled ANC government of Jacob Zuma.

Born in Victoria, South Africa, to a non-traditional Afrikaner family, with a right-wing father and a left-wing mother, Hruska would go on to work in politics as a consultant in the presidential administration of Nelson Mandela from 1994 to 2001. "I was the coordinator between the different spheres of government, civil society and state organizations, to actually implement the new government policies," Hruska said.

As an early supporter of Mandela and the dream of a rainbow South Africa, Hruska truly believed in establishing a country where, regardless of the color of one's skin or ethnicity, one could live in harmony and equality. Unfortunately, as she described, the

opposite came true.

"After about six years," Hruska said, "I realized something serious is wrong; the communist elements are taking over, it's not what we were promised."

Whites were getting excluded through affirmative action and black economic empowerment. And at the same time, the Chinese got black status; so the whites were excluded and the Chinese were included under affirmative action as black. We now find that a white is not allowed to enter, for instance, into management, but a Chinese person may buy a mine or buy shares in a mine, and the same [is true] with banks.

As a business owner, I can get 25 years in jail time if I employ a white person, for instance. It is totally ridiculous; you cannot have imagined that affirmative action could have gone so far.

What began as a quest to end the white discriminatory policy of apartheid has transformed into a kind of "reverse racism," where "whites are now totally excluded from the economic sector," according to Hruska.

The newly empowered African National Congress (ANC) government has slowly curtailed the rights of whites, and now some black South Africans have gone as far as committing atrocious killings of whites to the point where the situation has been classified as

“genocide” by Genocide Watch. Over the last decade, more than 3,000 white farmers have been murdered in South Africa. [*S.A Government has stopped counting*]

A favorite song among the ruling ANC is “Dubula iBhunu,” which means, “kill the farmers.” Former ANC Youth League chief Julius Malema was caught singing, “Kill the Boers! The Racists!” Even South African President Jacob Zuma sings this song to kill the farmers at ANC party functions, despite the song being labeled “hate speech” by a South African court.

“‘Kill the Boer’ is a hate song. ‘Kill the Boer, kill the farmer,’ it’s actually instigating armed groups to carry out these attacks,” Hruska explained. “[The] ANC is actually communist — we never realized it,” Hruska said.

Even now, President Zuma remains a strong supporter of the SACP and the international communist movement. At the 12th International Meeting of Communist and Workers Parties was held in Tshwane, South Africa. President Zuma attended and delivered a speech. The Times of South Africa quoted Zuma urging a call for unity among the various official Communist parties in attendance: “A majority of communists part ways because once they believe in something they have a culture to believe in it seriously. Unity is crucial.”

Zuma’s call for Communist Party unity was well received and resonated amongst the many foreign party delegates present. Following the conference, Zuma left for a visit to Cuba, where he met with Fidel and Raul Castro, the leaders of the Communist Party of Cuba.

The widespread violence and killings in South Africa have led many victims to lose everything and go into hiding, with some living in makeshift shanty dwellings or in the fields by rivers. Out of the nearly four million whites living in South Africa, nearly one million live in economic destitution.

Hruska described how in some cases, young white individuals, especially white females, because of their popularity, have been kidnapped and prostituted as sex slaves. Human trafficking is not illegal in South Africa and many young white teenage girls are drugged and sold for sex across the country.

The police do nothing about this; in fact, in some cases they are involved in the prostitution of those

women. “Those who do escape,” Hruska explained, “go into hiding seeing as there is no government assistance for them and because they are too embarrassed to tell their family or friends.”

Although a majority of those murdered, nearly 80 percent, Hruska said, are seniors (over the age of 60), the killers do not discriminate against age. “It’s heinous torture,” Hruska explained. “Even children as young as two months old get burned with hot water, are wrapped in newspaper and burned.”

She continued, “There is no easy way of saying exactly how these people are tortured. The standard would be a hot iron, electric iron, boiling water ... and these are carried out for hours.”

In the case of one family, Hruska detailed, the black mob broke into a home and waited for the white family to get home. When they arrived, they took them and raped the mother, in front of the father and son to see, and then once they killed her they killed the father, and finally the son by way of boiling water.

The government denies that such murders are occurring or that they are aimed at the white farmers. Instead they are reported as robberies despite nothing being stolen, Hruska explained. “The murders occur now at a rate of at least one per day,” she said.

After her talk, she stayed for an additional hour speaking to the people and answering questions. Her main message to the world, she told *The New American*, was, “Acknowledge it. Don’t deny it.” She realizes the difficulty in speaking about this unique situation, especially due to its racial dynamic and the politically-correct state of society.

“You cannot criticize Mandela or the ANC; they are sacred cows,” Hruska explained, but the truth needs to be told, regardless of how difficult it may be for some to hear or accept. Her main objective is not only to create greater awareness about the genocide but also to help find the victims of rape and economic destitution and provide them with the necessary post-traumatic support and assistance to help them cope with the trauma and either rejoin society, or leave the country if they so desire.


I have written this book for all the innocent victims of war, of all nations and creeds. Not the least the children for in this, the 2nd World War; they were the true innocents without vote of influence.

The Saar and the Rhineland were occupied by French troops; inflation soared out of control until there were 136,000,000 Deutsche Marks to the dollar. Decadence erupted in sleaze. Art was debased as were the German people. Child prostitutes of both sexes could be bought openly on the streets.

The world's debased were quick to take advantage of the German nation's descent into the economic chaos



The Versailles Treaty; the peace terms dictated by the victor nations and notorious for its monstrously unjust nature was heaped upon this volcanic social upheaval. "The greater part of our troubles is the result of World War 1 and the bad treaties which ended it." - Alfonso of Bourbon and Orleans. Great Grandson of Queen Victoria.

The unemployment figures rose to a third of the number usually employed in the nation, which means, however, that by counting the families of the unemployed as well there were 26 million people in Germany out of a population of 65 millions Who faced an absolutely hopeless future." - Adolf Hitler

In Russia, the Bolsheviks had seized power. The geographical giant on Germany's eastern borders was locked into civil war, the brutality of which knew no bounds. The tentacles of the emerging internationalism of Communism were spreading like wildfire throughout Europe.

If red terrorism was to have swept over Germany the western countries of Europe would probably also have realised that it is not a matter of indifference to them whether the outposts of a destructive Asian world power stand guard on the Rhine and on the North Sea, or whether the land is populated by peaceful German peasants and working men whose only wish is to make an honest living and to be on friendly terms with other nations. The National Socialist revolution has but one aim; To restore order in our own country, to provide work and bread for our starving masses and to lay down the ideas of honour, loyalty and decency as being the basis of our moral code, which, far from doing harm to other nations, can be for the benefit of all." - Adolf Hitler

In the front line against the Bolshevik explosion stood defeated Germany, out of which maelstrom emerged Adolf Hitler, a highly decorated soldier of the front lines. 

Cruel Britannia

In 2006, Cpl. Donald Payne was the first British soldier to be convicted of a war crime in this country under the International Criminal Court Act 2001. His crime was the inhuman and degrading treatment of prisoners held by British Forces in Southern Iraq in September 2003. He received a year in jail and was dismissed from the British Army for his crime. However, whereas a foot soldier who is complicit in torture is sent to jail – as the book reveals, for those higher up the social spectrum a CBE, knighthood or peerage await. Such is the hypocrisy in the British history of torture



If that sounds like an unlikely or extreme thing to say, I can only respond by saying read *Cruel Britannia* by Ian Cobain.

His book is a remarkable narrative and will come as something of a shock to most readers who are taken in by Britain's image of fair play and decency abroad. This is a myth, as Cobain explosively demonstrates. When the publishers sent me the manuscript I wrote to them that it was like a hand grenade rolled into the heart of the British Establishment. Here is why.

Firstly, the book is explosive because it reveals direct participation by the United Kingdom in torture since 1944. This probably will come as a great surprise to many readers but the official line that "the British do not participate in torture", is revealed as just part of a deliberate and well-practised line of deceit. The book charts the use of torture from "the Cage" in London used to interrogate leading Nazi's at the end of the Second World War, through the colonial campaigns of Kenya, Cyprus and Aden and then makes the link to Northern Ireland, Iraq and Afghanistan with the repeated and wilful use of "the five techniques". It exposes the exceptional brutality of the British in the treatment of the Mau Mau in Kenya - as is just beginning to emerge in the case of Nzili, Nyingi and

Mara, currently being heard in the High Court.

Evidence reveals that one British policeman at the time described the conditions in the camps as "far worse than anything I experienced in my four and a half years as a prisoner of the Japanese". To hear the British described as being more brutal than the Japanese will come as a great shock but, should there be any doubt as to the depravity of British Forces, the description in the book is unequivocal

"Men were whipped, clubbed, subjected to electric shocks, mauled by dogs and chained to vehicles before being dragged around. Some were castrated.

The same instruments used to crush testicles were used to remove fingers. It was far from uncommon for men to be beaten to death"

This savagery by the British continues throughout the colonial period and Cobain details the campaigns in Cyprus against EOKA and in the Aden Emergency where yet more torture was perpetrated on those we captured. The book then makes interesting references to the refinement of torture techniques which were developed in between 1950-1970 known as an "assault on the mind" whereby far subtler techniques capable of causing "irreparable psychological damage" were developed. The scientists found that a combination of five things: sensory deprivation through hooding, together with enforced stress positions, white noise, sleep prevention and very little food together produced "stress that was almost unbearable for most subjects".

This resulted in what became known as the "five techniques" which were subsequently employed against the IRA during interment in 1971 and later banned in the case of *Ireland v UK* in the European Court of Human Rights in 1978. Yet, despite the assurances of the British Government that such practises would never again be repeated in any

circumstances, Cobain makes the very alarming claim that the five techniques were in fact retained by the UK which is, perhaps, why they re-emerged in Iraq in 2003 and why the doctrine cited by the Intelligence Branch during the second Iraq War miraculously went missing when it came to the Baha Mousa trial in 2006 and the Inquiry two years later.

The second reason why the book is explosive is because it exposes the institutional cover up that has been perpetrated throughout the post war years. At the time of writing this article there is a sense of national outrage at what appears to be an institutional cover up... and connivance by numerous institutions in the Savile affair. Indeed, it seems to be a national trait that there are so many institutions and individuals who are prepared to participate, passively or actively, in a cover up of scandals for something as prosaic as enhancing their own career prospects or reward from the State.

The 'Establishment' is shown to be remarkably adept at not establishing the truth using methods every bit as subtle as those developed by the interrogators in the 1950's – 70. At the same time, the book reveals the courage of a few men and women who stand against torture. Men such as Colonel Arthur Young who repeatedly complained to Sir Evelyn Baring about the "unjustified or abhorrent crimes by British Forces" in Kenya but who resigned when he realised that Baring and others were not interested in his complaints. Or Lord Gardiner, who spelt out the legal position that the five techniques were a flagrant breach of International and domestic law but who was similarly ignored lest it get in the way of an interrogator's war. At the same time, the few good men who do speak out know what fate will befall them. Craig Murray was drummed out of the Foreign Office for revealing Foreign Office connivance with torture evidence and Ben Griffin, the former SAS Trooper who spoke out against the UK treatment of prisoners in Afghanistan, is now living under a Government injunction which prevents him from speaking any further. If he breaks the terms of the injunction he will go to jail. In *Cruel Britannia* you can lose your job or go to jail for revealing UK complicity in torture and rendition. Those who are complicit meanwhile remain untouched and untroubled. The only tap on the shoulder is the sword used to knight them.

Finally, the most explosive part of the book is the fact

that complicity in torture and rendition are potentially war crimes and are required to be outlawed in our domestic criminal law. The UN Convention against torture (UNCAT) states:

“each State Party shall ensure that all acts of torture are offences under its criminal law. The same shall apply to an attempt to commit torture and to an act by any person which constitutes complicity or participation in torture”.

If such acts are committed during armed conflict then they constitute a war crime or, in the case of rendition, a crime against humanity. However, to date despite increasingly weighty evidence no one has been prosecuted. As the Tory MP David Davis recently stated in the case of *R v Ahmed and others*,

“Although the combined circumstantial evidence of complicity in all these cases is overwhelming, it has not so far been possible — because of the government's improper use of state secrecy to cover up the evidence — to establish absolutely clear sequences of cause and effect.”

And here lies the rub. As the weight of evidence mounts up, so the State becomes increasingly desperate to cover up. Miliband (D) pirouettes in the High Court, Straw denies any involvement in rendition before his assurances are contradicted by the discovery of documents in Tripoli. Then up pops the so called “Justice and Security Bill” - currently making its way through Parliament - in a desperate, blanket attempt to cover up all UK complicity in torture and rendition. However, the more attempts there are to cover it up the more the issue is exposed and it must be the supreme irony that as details of torture are finally being exposed from Kenya, the Government is embarking on yet another cover up.

This is why Cobain's allegations in *Cruel Britannia* are like a hand grenade in the heart of the establishment. The truth has had the pin pulled out of it by this book and is likely to go off at any moment. When it does, it will not only be the foot soldiers who end up being caught in the explosive consequences.

4,250% Increase in Fetal Deaths Reported to VAERS After Flu Shot Given to Pregnant Women



Documentation received from the National Coalition of Organized Women (NCOW) states that between 2009 and 2010 the mercury-laden combined flu vaccinations have increased Vaccine Adverse Events Reporting Systems (VAERS) fetal death reports by 4,250 percent in pregnant women. Eileen Dannemann, NCOW's director, made abundantly clear that despite these figures being known to the Centers for Disease Control (CDC), the multiple-strain, inactivated flu vaccine containing mercury (Thimerosal) has once again been recommended to pregnant women as a safe vaccination this season.

Outraged by the CDC's total disregard for human life, Ms. Dannemann accused the CDC of 'willful misconduct,' saying that they are responsible for causing the deaths of thousands of unborn babies. She stated that the CDC deliberately misled the nation's obstetricians and gynecologists and colluded with the *American Journal of Obstetrics and Gynecology* (AJOG) to mislead the public by advertising the flu vaccine as a safe vaccine for pregnant women when they knew fully well that it was causing a massive spike in fetal deaths.

In a letter to Dr. Joseph Mercola, Ms. Dannemann wrote:

"Not only did the CDC fail to disclose the spiraling spike in fetal death reports in real time during the 2009 pandemic season as to cut the fetal losses, but also we have documented by transcript Dr. Marie McCormick, chairperson of the Vaccine Safety Risk



Assessment Working Group (VSRAWG) on September 3, 2010, denying any adverse events in the pregnant population during the 2009 Pandemic season.” [1]

HIDING LIFE OR DEATH EVIDENCE

Because the H1N1 pandemic vaccine had never been tested on the pregnant population, and to lessen the intensity of fears of the unknown risks, Dr. Marie McCormick of the CDC was employed to keep track of all adverse events during the 2009 pandemic season, including those adverse events in the pregnant population. Dr. McCormick was responsible for sending monthly reports to the

Secretary of the Health and Human Services (HHS), citing any suspicious adverse events.

According to Ms. Dannemann, NCOW has been unable to obtain access to these monthly reports. After sending a Freedom of Information Act request to the CDC, she was told that she may have to wait 36 months to access what should be published public reports. The Mercola letter continues:

"The Advisory Committee on Childhood Vaccines (ACCV) and CDC were confronted with the VAERS data from NCOW on September 3, 2010, in Washington, D.C., and then again by conference call on September 10, and then again in Atlanta, Georgia, on October 28, 2010. On both September 3 and September 10 Dr. Marie McCormick clearly denied that there were any adverse events for pregnant women from the 2009 flu vaccine."

THE DOCTOR'S VERSION OF CONCEAL AND CARRY

To emphasize their point, on October 28, 2010, NCOW requested that Dr. Rene Tocco present their data at the CDC headquarters in Atlanta, Georgia. The CDC's Dr. Shimabakuru gave a presentation on significant adverse reactions to the H1N1 vaccine, such as cases of Guillane-Barre Syndrome, which appeared to have risen three percent, claiming it as an insignificant signal. No mention at all was made of adverse events related to pregnant women. Unfortunately for Dr. Shimabakuru, his attempts to pull the wool over the eyes of the audience were foiled when he was challenged by a member of the audience asking if the vaccine caused adverse events in pregnancy. Feeling cornered, he reluctantly looked in his bag and sheepishly presented a slide that corroborated the NCOW data, confirming that the CDC knew of the spike in fetal deaths in the fall of 2010. [2]

So, why did Dr. Shimabkauru have a slide containing compromising evidence in his bag? Why did he decide to hide the slide? Surely, if he had prepared a slide outlining this crucial data, it would have made sense to include the slide in his presentation. After all, a 4,250 percent increase in fetal deaths is far more significant than a three percent increase in Guillane-Barre Syndrome.

Ms. Dannemann believes that the existence of this slide, along with the omission of it in his presentation, confirms that the CDC knew of the spike in fetal deaths by the fall of 2010 and was attempting by any means possible not to make it public.

Outlining a catalog of events, Ms. Dannemann believes the CDC's continual cover ups puts the lives of pregnant women and their unborn children in serious jeopardy. She maintained:

“Continuing the vaccine program without notifying the public or the healthcare practitioners of the VAERS miscarriage/stillbirth incoming data was clearly a purposeful decision. The CDC, aware of their own incoming stream of early vaccine adverse events reports, clearly decided to allow the obstetricians to continue, unwittingly, murdering and damaging the unborn so that the CDC's blunder of recommending the double-dose vaccination of pregnant women could be kept under the radar.”

COLLABORATION AND CORRUPTION

Despite evidence that the CDC knew of the 4,250 percent increase in fetal death reports in 2009/2010, in order to ensure the continuance of the vaccine program for pregnant women, the CDC published a study in AJOG authored by Dr. Pedro Moro of the CDC in the fall of 2010. The study articulated that there were only 23 miscarriages caused by the single flu vaccine in 19 years between 1990 – 2009, an average of 1.2 miscarriages per year. This study formed the basis of a CDC worldwide publicity campaign that the flu shot was safe for pregnant women by willfully and strategically excluding the 2009 pandemic data, which was available to them. Ms. Dannemann said:

“Both the CDC and AJOG were well aware of the fact that physicians and the public were awaiting the results of the 2009 H1N1 untested vaccine on pregnant women, amid solid assurances to the public at the beginning of the pandemic season that the CDC was on top of collecting any adverse reactions to the vaccine by establishing the Vaccine Safety Risk Assessment Working Group chaired by Dr. Marie McCormick (VSRWAG).”

Ms. Dannemann stated that by including the 2008/2009 flu season's data but excluding the available 2009 data from the 2009/2010 flu season in the study published in AJOG, Dr. Moro was able to give the impression that the 2009/2010 pandemic season was covered in the data, which of course it was not. Ms. Dannemann believes that this was a deliberate act on his part because he was aware of the fetal death spike in the 2009/2010 data at the time of preparing the study and purposely excluded the 2009 pandemic data from the study to hide this fact.

In the fall of 2010, just in time for the new flu season, media outlets all over the world publicized the AJOG, peer-reviewed CDC/Dr. Moro study as adamant proof that the flu shot is safe for pregnant women. The NCOW documents prove at the same time as widely publicizing advice that all pregnant women required the combined flu vaccination, the CDC was busy organizing ten non-profit organizations, to sign a joint letter to urge obstetricians and gynecologists to continue to vaccinate their pregnant patients.

One of the organizations to sign the letter was The March of Dimes [3] who urged health care providers

to recommend the flu vaccine to pregnant women and those who expect to become pregnant. They wrote the following recommendation to all medical professionals:

“Advice from a healthcare provider plays an important role in a pregnant and postpartum woman’s decision to get vaccinated against seasonal influenza. The American Academy of Family Physicians (AAFP), American Academy of Pediatrics (AAP), American College of Nurse-Midwives (ACNM), American College of Obstetricians and Gynecologists (The College), American Medical Association (AMA), American Nurses Association (ANA), American Pharmacists Association (APhA), Association of Women’s Health, Obstetric and Neonatal Nurses (AWHONN), March of Dimes, and Centers for Disease Control and Prevention (CDC) are asking for your help in urging your pregnant and postpartum patients to get vaccinated against seasonal influenza. The Advisory Committee on Immunization Practices (ACIP) recommends that pregnant and postpartum women receive the seasonal influenza vaccine this year, even if they received 2009 H1N1 or seasonal influenza vaccine last year. Lack of awareness of the benefits of vaccination and concerns about vaccine safety are common barriers to influenza vaccination of pregnant and postpartum women.”

WHAT THE CDC FAILED TO TELL PREGNANT MOMS

This year, on September 27, 2012, the *Human and Environmental Toxicology Journal*(HET) published Dr. Gary Goldman’s study that confirms NCOWs data, a 4,250 percent increase in the number of miscarriages and stillbirths reported to VAERS in the 2009/2010 flu season. [4] The study points out an astounding fact that no one saw until the publishing of the Goldman study in HET:*the CDC had recommended the double-dosing of the pregnant population with the seasonal flu vaccine with mercury and the untested H1N1 vaccine with mercury.*

In his abstract, Goldman said:

“The aim of this study was to compare the number of inactivated-influenza vaccine–related spontaneous

abortion and stillbirth (SB) reports in the Vaccine Adverse Event Reporting System (VAERS) database during three consecutive flu seasons beginning 2008/2009 and assess the relative fetal death reports associated with the two-vaccine 2009/2010 season.”



The facts that Goldman exposed are extremely disturbing. He highlights the fact that the safety and effectiveness of the A-H1N1 had never been established in pregnant women and that the combination of two different influenza vaccines had never been tested on pregnant women at all. Even more worrisome is the fact that the A-H1N1 vaccine inserts from the various manufacturers contained this warning: ***“It is also not known whether these vaccines can cause fetal harm when administered to pregnant women or can affect reproduction capacity.”*** (emphasis added)

Dr. Goldman also pointed out that the developing fetus is indirectly exposed to mercury when thimerosal-containing vaccines are administered to a pregnant woman. He outlined a study written by A.R. Gasset, M. Itoi, Y. Ischii and R.M. Ramer who examined what happened after rabbits were vaccinated with thimerosal–containing radioactive mercury. Goldman stated that from one hour post-injection to six hours post-injection, the level of radioactive mercury in the blood dropped over 75 percent. *Yet from two hours post-injection to six hours post-injection, there were significantly increased radioactivity levels in the fetal brain, liver, and kidney.*

Dr. Goldman concluded that because the rates of miscarriage reported to the Vaccine Adverse Events Reporting System (VAERS) for the single flu vaccine were relatively low, health care providers developed a false

sense of security that flu vaccines administered during pregnancy were safe. Goldman explained that just because a single vaccine has been tested and considered to be relatively safe, this does not mean that vaccinating pregnant women with two or more Thimerosal containing vaccines will be safe for them or their unborn babies. Overall, Goldman firmly believes that the VAERS grossly underestimates the true rates of miscarriage and other adverse events encountered in the US population. Remember, it is estimated that less than a tenth of true adverse reactions are reported to the VAERS with a one percent reporting rate for serious adverse events, including death, according to a study led by former FDA Commissioner Dr. David A. Kessler. [5]

As seen in the Goldman study, with the return to a single flu shot, the flu vaccine-related reports of fetal loss have returned to a significantly lower level compared to the high level of fetal loss reports in the two-dose 2009/2010 flu season. However, higher than background flu shot vaccine-related fetal losses continue to be reported to the VAERS.

Furthermore, the Goldman study recommends that the babies who survived the deadly double dose in utero be monitored:

*“In addition, because of the order of magnitude increase in fetal-loss report rates, from 6.8 fetal loss reports per million pregnant women vaccinated in the single-dose 2008/2009 season to 77.8 in the two-dose 2009/2010 season, **further long term studies are needed to assess adverse outcomes in the surviving children.** Additional research concerning potential synergistic risk factors associated with the*

administration of Thimerosal-containing vaccines is warranted, and the exposure-effect association should be verified in further toxicological and case-control studies.” (emphasis added)

Aside from fetal deaths, the CDC initiative to increase uptake of vaccines in pregnant women continues to fuel the increases in the levels of neuro-developmental, developmental, behavioral abnormalities, and chronic illness in the surviving children. Due to omitting reports of fetal deaths, the CDC enjoys success in increasing the uptake and number of vaccines in the pregnant population. The Advisory Committee on Immunization Practices (ACIP) is now recommending not only the flu shot (with mercury) but also the Tdap vaccine.

CONCLUSION

The work of NCOW and Dr. Goldman has **proven that potential lives are being destroyed before they are even old enough to draw their first breath.**

Developing fetuses who are fortunate enough to survive the onslaught of vaccinations now being recommended to pregnant women then need to play a form of Russian Roulette from the day they are born, because their caring parents followed the advice they were given by professionals who have been deliberately misguided.

Eileen Dannemann and her team have **proven with their remarkable work that both public and professionals alike are being lied to and deceived by organizations put in place by the government to sanction our vaccination programs. In my opinion, this is genocide** and the sooner people realize that all vaccines come with an element of risk and begin to research the dangers for themselves, the sooner these insane experiments will end.
